## CHAPTER E-2.1

### ELECTORAL BOUNDARIES ACT

#### PART I INTERPRETATION

- 1. In this Act** Definitions
- (a) “Chief Electoral Officer” means the Chief Electoral Officer appointed pursuant to section 2 of the *Election Act* R.S.P.E.I. 1988, Cap. E-1; Chief Electoral Officer
- (b) “Commission” means an Electoral Boundaries Commission established under section 8; Commission
- (c) “district” means an electoral district established pursuant to this Act. 1994, c.13, s.1. district

#### PART II ELECTORAL DISTRICTS

- 2. (1)** The province, for the purpose of the election of members to serve in the Legislative Assembly, is divided into twenty-seven districts, as set out in sections 3, 4 and 5. Electoral districts
- (2) Each of the districts and the boundaries thereof are more particularly described in the Schedule. 1994, c.13, s.2. *Idem*, described in Schedule
- 3.** Prince County is divided into nine districts, to be styled as Tignish-DeBlois, Alberton-Miminegash, West Point-Bloomfield, Evangeline-Miscouche, Cascumpec-Grand River, St. Eleanors-Summerside, Wilmot-Summerside, Kensington-Malpeque, and Borden-Kinkora. 1994, c.13, s.3. Prince County districts
- 4.** Queens County is divided into thirteen districts, to be styled as Park Corner-Oyster Bed, Crapaud-Hazel Grove, North River-Rice Point, Winsloe-West Royalty, Charlottetown-Rochford Square, Charlottetown-Kings Square, Parkdale-Belvedere, Sherwood-Hillsborough, Stanhope-East Royalty, Tracadie-Fort Augustus, Glen Stewart-Bellevue Cove, and Belfast-Pownal Bay. 1994, c.13, s.4. Queens County districts
- 5.** Kings County shall be divided into five districts, to be styled as Murray River-Gaspereaux, Montague-Kilmuir, Georgetown-Baldwin’s Road, Morell-Fortune Bay, and Souris-Elmira. 1994, c.13, s.5. Kings County districts

**6.** One member shall be returned to the Legislative Assembly for each district. 1994, c.13, s.6.

Municipalities

**7.** A reference by name to any municipality in the Schedule means that municipality as it exists with the area and boundaries that it has on the date this Act comes into force. 1994, c.13, s.7.

### PART III ELECTORAL BOUNDARIES COMMISSION

**8.** Within ninety days following ordinary polling day of the third general election after this Act comes into force and within ninety days following ordinary polling day of each third general election thereafter, the Lieutenant Governor in Council shall establish an Electoral Boundaries Commission, consisting of

(a) a chairperson appointed by the Lieutenant Governor in Council, who is a judge or retired judge of the Supreme Court of Prince Edward Island;

(b) a person who is not a member of the Legislative Assembly, or of the Parliament of Canada, or an employee of the Government of Prince Edward Island, appointed by the Speaker of the Legislative Assembly on the nomination of the Leader of the Opposition, after consultation with the leaders of any other political party registered under section 24 of the Election Act that is represented in the Legislative Assembly; and

(c) a person who is not a member of the Legislative Assembly, or of the Parliament of Canada, or an employee of the Government of Prince Edward Island, appointed by the Speaker of the Legislative Assembly on the nomination of the Premier. 1994, c.13, s.8.

Functions

**9.** A Commission shall, in accordance with this Part, review the districts of the province, and make a report to the Legislative Assembly setting out its recommendations as to the area, boundaries, and names of the districts of the province. 1994, c.13, s.9.

Remuneration

**10.** (1) Each member of a Commission, including the chairperson if he or she is a retired judge, shall be paid such remuneration as may be determined by the Lieutenant Governor in Council.

Expenses

(2) Each member of a Commission, including the chairperson, is entitled to be paid reasonable travelling and living expenses while away from the member's ordinary place of residence in the course of his or her duties as a member, at such rates as may be determined by the Lieutenant Governor in Council. 1994, c.13, s.10.

- 11.** There shall be made available to a Commission such advisers, clerks, and assistants, as may be required to enable it to discharge its functions. 1994, c.13, s.11. Administrative support
- 12.** If a vacancy in the membership occurs, through inability to act, resignation or otherwise, the vacancy may be filled in accordance with section 8. 1994, c.13, s.12. Vacancy
- 13.** A Commission may request the Chief Electoral Officer to provide any information possessed by his or her office, and any other assistance that a Commission considers necessary, and the Chief Electoral Officer shall comply with any reasonable request. 1994, c.13, s.13. Assistance of Chief Electoral Officer
- 14.** Each member of a Commission has the powers of a commissioner under the *Public Inquiries Act* R.S.P.E.I. 1988, Cap. P-31. 1994, c.13, s.14. Powers
- 15.** (1) A Commission shall hold public hearings throughout the province at such times and places as it considers appropriate to enable representations to be made by any person as to the area and boundaries of any district. Public hearings
- (2) A Commission shall give reasonable public notice of the time, place and purpose of any such public hearings. 1994, c.13, s.15. Notice
- 16.** A Commission may regulate its own proceedings and the conduct of its business. 1994, c.13, s.16. Procedure
- 17.** (1) Subject to subsection (2), in determining the area to be included in, and in fixing the boundaries of a district, a Commission shall take into consideration
- (a) the Canadian Charter of Rights and Freedoms;
  - (b) enumeration data from the most recent general election;
  - (c) polling divisions from the most recent general election;
  - (d) geographical features;
  - (e) population patterns;
  - (f) community of interest;
  - (g) municipal boundaries,
- and may consider such other factors as it regards as relevant. Criteria
- (2) The number of electors of a proposed district shall not be more than 25 per cent above, nor more than 25 per cent below the average number of electors of all the proposed districts. 1994, c.13, s.17. Number of electors
- 18.** (1) Within six months of its establishment, a Commission shall prepare and, subject to subsection (2), submit its report to the Speaker of Report

the Legislative Assembly, who shall lay a copy thereof before the Legislative Assembly forthwith, if it is then in session, and, if not then in session, within seven days of the opening of the next session.

Enlargement of

(2) The Lieutenant Governor in Council may, at the request of a Commission, extend the time for submission of the report for a period not to exceed three months.

(3) The report of a Commission is a public document. 1994, c.13, s.18.

**20.** The Chief Electoral Officer shall, for the general election next following the enactment of this section, divide each district into as many polling divisions as necessary, giving due consideration to the matters set out in section 16 of the *Election Act*, and shall, until the appointment of the returning officers for the districts, stand in the stead of those returning officers for the purpose of making all reasonable preparations for the transition from the districts that were established by this Act immediately before the date this section comes into force to the districts that are established by this Act on the date this section comes into force. 1994, c.13, s.20; 2006,c.44,s.8.

1. The electoral divisions are described and listed in numerical order.
2. Where the words highway, road, route, avenue, drive, street, terrace creek, river, stream, bay and harbour are used, they refer to the center line unless otherwise provided.

**Electoral District No. 1 Souris - Elmira**

The electoral district of Souris - Elmira is bounded as follows:

Commencing at East Point and bounded on the north by the Gulf of the St. Lawrence to a northwardly extension of the Bear River Road; Bounded on the west by an extension of the Bear River Road, then southwardly on the said extension and the Bear River Road and an extension to Rollo Bay; Bounded on the south and east by Northumberland Strait to the point of commencement:

**Electoral District No. 2 Morell - Fortune Bay**

The electoral district of Morell - Fortune Bay is bounded as follows:

Commencing at the northward extension of the Bear River Road and the Gulf of St. Lawrence and bounded on the north by the Gulf of St. Lawrence to Savage Harbour; Bounded on the west by Savage Harbour and the county line between Kings and Queens Counties to the south boundary line of Township lot 38, then east and north following the boundary line of Township lot 38 to the north boundary of Township lot 51, then eastwardly following the north boundaries of lot 51, 52, 53, 54 and an extension thereof to the east boundary of Township lot 55 then south along the east boundary of Township lot 55 to Route # 314, then following Route # 314 and Route # 332, crossing Route # 310 to the center branch of Little River to Howe Bay and an extension of the Bear River Road to Rollo Bay; Bounded on the east by the southward extension of the Bear River Road then northwardly along the said extension and the Bear River Road and a northwardly extension of the Bear River Road to the Gulf of St. Lawrence to the point of commencement.

**Electoral District No. 3 Georgetown – Baldwin’s Road**

The electoral district of Georgetown – Baldwin’s Road bounded as follows:

Commencing at Howe Bay and bounded on the north by a line commencing on Howe Bay at Little River, then following the center branch of Little River west to Route # 310, then crossing Route # 310 and then following Route # 332 and Route # 314 to the east boundary of Township lot 55, and following the east boundary line of Township lot 55 north to an eastwardly extension of the north boundary of Township lot 54,53,52 and 51, then westwardly following said extension and the north boundaries of Township lot 54, 53, 52 and 51, to the east boundary of Township lot 38, then south to the south boundary of Township lot 38, then west following the south boundary of Township lot 38 to the county line; Bounded on the west by the county line between Queens and Kings Counties to the north boundary of Township lot 59; Bounded on the south by the north boundary line of Township lot 59 east to an extension of the east boundary line of Township lot 51, then north to the Brudenell River to Cardigan Bay; Bounded on the east by Cardigan Bay, Boughton Bay to Rollo Bay and the point of commencement and includes Boughton Island.



**Electoral District No. 4 Montague - Kilmuir**

The electoral district of Montague - Kilmuir is bounded as follows:

Commencing at Cardigan Bay and bounded on the north by the Brudenell River to the east boundary of Township lot 51 then southward on said boundary line and an extension thereof to the north boundary line of Township lot 59, then west to the county line between Kings and Queens Counties; Bounded on the west by the county line between Kings and Queens Counties to the south boundary of Township lot 59; Bounded on the south by the Township lot line 59 to Sturgeon Bay; Bounded on the east by Sturgeon Bay and Cardigan Bay to the point of commencement.

**Electoral District No. 5 Murray River - Gaspereaux**

The electoral district of Murray River - Gaspereaux is bounded as follows:

Commencing at Cardigan Bay and bounded on the north by Cardigan Bay to Sturgeon Bay and following the north boundary line of Township lot 61 to the county line between Kings and Queens Counties; Bounded on the west by the county line between Kings and Queens Counties then south to Route # 202, then west on Route # 202 to the Murray Road then south on the Murray Road and an extension thereof to Northumberland Strait; Bounded on the south and east by Northumberland Strait to Cardigan Bay to the point of commencement and includes Panmure Island, Reynolds Island, Herring Island, Cherry Island, Thomas Island and Gordons Islands.

**Electoral District No. 6 Belfast - Pownal Bay**

The electoral district of Belfast - Pownal Bay is bounded as follows:

Commencing at the intersection of the county line between Kings and Queens Counties and the north boundary of Township lot 49 and bounded on the north by Township lot 49 to Route # 1A, then following Route # 1A to the road leading to Alexandra Point, then following said road to Alexandra point; Bounded on the west by Hillsborough Bay; Bounded on the south by Northumberland Strait to an extension of the Murray Road; Bounded on the east by an extension of the Murray Road, then north on said extension and the Murray Road to Route # 202, then east on Route # 202 to the county line, then north on the county line between Kings and Queens Counties to the point of commencement, and includes Governors and Cameron Islands.

**Electoral District No. 7 Glen Stewart - Bellevue Cove**

The electoral district of Glen Stewart - Bellevue Cove is bounded as follows:

Commencing on the Hillsborough River and bounded on the North by Hillsborough River; Bounded on the west by Charlottetown Harbour; Bounded on the south by Charlottetown Harbour and Alexandra Bay to Alexandra Point; Bounded on the east by the road leading from Alexandra Point to Route # 1A, then following Route #1A to Township lot 48, then east on the south boundary of Township lot 48 to the extension of Route # 21, then north on the said extension and Route # 21 to Fullertons Marsh then following Fullertons Marsh to the point of commencement.

**Electoral District No. 8 Tracadie - Fort Augustus**

The electoral district of Tracadie - Fort Augustus is bounded as follows:

Commencing on the Gulf of St. Lawrence and bounded on the north by the Gulf of St. Lawrence, Bounded on the west by an extension of the west boundary line of Township lot 35 then south along the boundary line of Township lot 35 to the Hillsborough River, then to Fullertons Marsh and Route # 21 and an extension of Route # 21 to the north boundary of Township lot 49; Bounded on the south by the north boundary of Township lot 49 to the county line; Bounded on the east by the county line between Queens and Kings Counties, Savage Harbour to the Gulf of St. Lawrence to the point of commencement.

**Electoral District No. 9 Stanhope - East Royalty**

The electoral district of Stanhope - East Royalty is bounded as follows:

Commencing on the Gulf of St. Lawrence and bounded on the north by the Gulf of St. Lawrence; Bounded on the west by Brackley Beach Sand Hills and the west boundary line of Township lot 34 and the extension thereof to an extension of Route # 220 (Horne Road), following the Horne Road westwardly to the eastern boundary of South Winsloe Community boundary, then following the community boundary south to the Royalty Junction road at the intersection of the C.N.R. tracks, then west following the Royalty Junction Road to Route # 223 (Winsloe Road), then south to Route # 2 (Malpeque Road), then south following Malpeque Road and University Avenue to the Towers Private Road. Bounded on the south by the Towers Private Road to Mount Edward Road, then south to Oak Drive , then east on Oak Drive to Brackley Point Road, then north to the south boundary of the Charlottetown Airport then east along the said airport property to the Norwood Road, then south to the St. Peters Road, then east on the St. Peters Road to Andrews Pond on Wrights Creek, then following Wrights Creek, Hillsborough River to the boundary line of Township lot 34; Bounded on the east by Township lot 34 to Savage Harbour, the Gulf of St. Lawrence to the point of commencement.

**Electoral District No. 10 Sherwood - Hillsborough**

The electoral district of Sherwood - Hillsborough is bounded as follows:

Commencing at the intersection of the Norwood Road and the Charlottetown Airport and bounded on the north by the south boundary of the Charlottetown Airport to the Brackley Point Road, Bounded on the west by Brackley Point Road, Bounded on the south by Falconwood Drive and the boundary line between the communities of Parkdale and Sherwood to the Hillsborough River and following the Hillsborough River to Wrights Creek; Bounded on the east by Wrights Creek to St. Peters Road, then southwest to Norwood Road, then north on Norwood Road to the south boundary of the Charlottetown Airport to the place of commencement.

**Electoral District No. 11 Parkdale - Belvedere**

The electoral district of Parkdale - Belvedere is bounded as follows:

Commencing at the intersection of the Brackley Point Road and Oak Avenue and bounded on the north by Oak Avenue to Mount Edward Road, then north to Towers Private Road, then west on Towers Private Road to University Avenue; Bounded on the west by University Avenue to Summer Street; Bounded on the south by Summer Street and an extension thereof to the community boundary between Parkdale and Charlottetown and following the said boundary to the Hillsborough River; Bounded on the east by the Hillsborough River and by the Community boundary between Parkdale and Sherwood along Falconwood Drive to Brackley Point Road and along Brackley Point Road to the place of commencement.



**Electoral District No. 12 Charlottetown - Kings Square**

The electoral district of Charlottetown - Kings Square is bounded as follows:

Commencing in the Hillsborough River and bounded on the north by the community boundary between Parkdale and Charlottetown to an extension of Summer Street and west along said extension and Summer Street to University Avenue; Bounded on the west by University Avenue and Great George Street to Charlottetown Harbour; Bounded on the south and east by Charlottetown Harbour to the point of commencement.

**Electoral District No. 13 Charlottetown - Rochford Square**

The electoral district of Charlottetown - Rochford Square is bounded as follows:

Commencing at the intersection of University Avenue and Kirkwood Drive, Bounded on the north by Kirkwood Drive, Upper Queen Street, Pond Street, Spring Park Road, Maple Street, McGill Terrace, McGill Avenue, North River Road, Sidmount Avenue, Goodwill Avenue, Viceroy Avenue and the extension thereof westwardly to the North (York) River; Bounded on the west by the North (York) River; Bounded on the south by the Charlottetown Harbour; Bounded on the east by Great George Street and University Avenue to the point of commencement.

**Electoral District No. 14 Charlottetown - Spring Park**

The electoral district of Charlottetown - Spring Park is bounded as follows:

Commencing at a point on University Avenue and Hermitage Creek and bounded on the north by Hermitage Creek, Douses Creek and Ellens Creek to North (York) River; Bounded on the west by the North (York) River; Bounded on the south at the extension of Viceroy Avenue at the North (York) River, then east on the said extension and Viceroy Avenue to Goodwill Avenue, Sidmount Avenue, North River Road, McGill Avenue, McGill Terrace, Maple Street, Spring Park Road, Pond Street, Upper Queen Street, and Kirkwood Drive; Bounded on the east by University Avenue to Hermitage Creek to the point of commencement.

**Electoral District No. 15 Winsloe - West Royalty**

The electoral district of Winsloe - West Royalty is bounded as follows:

Commencing at a point on the east boundary line of Township lot 33 and an extension of the Kilkenny Road Route # 250 and bounded on the north by the said extension and the Kilkenny Road, Kentyre Road Route # 250 and an extension westwardly to the west boundary line of Township lot 33; Bounded on the west by the west boundary line of Township lot 33 and extending southwardly to the North River, then following North River southwardly crossing the Rustico Road (Route #7), Crabbe Road (Route # 256), Malpeque Road (Route # 2) and the Milton Road (Route # 258) and then following the North (York) River to Ellens Creek, Douses Creek and Hermitage Creek; Bounded on the south by Hermitage Creek to Malpeque Road (University Avenue)(Route # 2); Bounded on the east by the Malpeque Road (Route # 2) extending to the Winsloe Road (Route # 223), north to the Royalty Junction Road, east on Royalty Junction Road to the C.N.R. tracks, then north following the C.N.R. track and the South Winsloe Community boundary to the Horne Road (Route # 220), then east along the Horne Road and extension thereof to an extension of the Township lot 33 and 34 line, then north on said extension and Township lot 33 and 34 to point of commencement and includes Poplar Island.

**Electoral District No. 16 North River - Rice Point**

The electoral district of North River - Rice Point is bounded as follows:

Commencing where the North River crosses the Malpeque Road (Route # 2) and bounded on the North by Malpeque Road (Route # 2) to the Colville Road (Route # 9), Bounded on the west by following the Colville Road (Route # 9), North Wiltshire Road (Route # 225), Bannockburn Road (Route # 247), Kingston Road (Route # 235) and an extension of Meadowbank Road (Route # 265) from Kingston Road to the Trans Canada Highway (Route # 1), then westwardly to the Clyde River, following the Clyde River southwardly crossing the West River and extending to the mouth of Long Creek, then following its courses back until it strikes the northwest boundary line of the late Malcolm MacNeill's farm, and following the same to the rear, then in a southeastwardly direction following the rear line of farms fronting on Long Creek and Canoe Cove Roads and along the eastern boundary of Hugh MacLean's farm to the shore of Northumberland Strait; Bounded on the south by the Northumberland Strait; Bounded on the east by the Charlottetown Harbour and the North (York) River to the point of commencement and includes St Peters Island.

**Electoral District No. 17 Crapaud - Hazel Grove**

The electoral district of Crapaud - Hazel Grove bounded as follows:

Commencing at the intersection of the Colville road (Route # 9) and the Malpeque Road (Route # 2) and bounded on the north by the Malpeque Road (Route # 2), Hazelgrove Road (Route # 228) and the extension thereof to the east boundaryline of Township lot line 21 , then north following the Township lot line to the McCourt Road, then west along the McCourt Road and extension thereof westwardly to the east boundary line of Township lot 67, then north following the Township lot line 67 to the north boundary line of Township lot 67, then west following the north boundary line of Township lot 67 to the intersection of Malpeque Road (Route # 2) and the County Line Road (Route # 233), Bounded on the west by the county line between Prince and Queens Counties, and at the South Shore Villa following the north, east and south property boundary to the county line, then to Northumberland Strait; Bounded on the south by the Northumberland Strait to Canoe Cove, Bounded on the east by following the shore of Northumberland Strait in Canoe Cove at the eastern boundary of Hugh MacLeans farm, then north along Hugh MacLeans east boundary to the rear boundary of the farms fronting on the Canoe Cove Road and the Long Creek Road, then in a northwestwardly direction to the rear of the late Malcolm MacNeill's farm, then following MacNeill's farm boundary to Long Creek and following Long Creek, crossing West River and north along Clyde River to the Trans Canada Highway (Route # 1), then following the Trans Canada Highway east to Meadowbank Road (Route # 265), then north following the extension of the Meadowbank Road to the Kingston Road (Route # 235), Bannockburn Road (Route # 247),North Wiltshire Road (Route # 225), Colville Road (Route # 9) to the point of commencement.

**Electoral District No. 18 Park Corner - Oyster Bed**

The electoral district of Park Corner - Oyster Bed is bounded as follows:

Commencing on the Gulf of St. Lawrence by the Brackley Beach Sand Hills, and bounded on the north by the Gulf of St. Lawrence; Bounded on the west by the county line between Prince and Queens County, Bounded on the south commencing at the intersection of Malpeque Road (Route # 2) and the County Line Road (Route # 233) also being the intersection of Township lot 20 and 67, then east along the south boundary line of Township lot 20 to the west boundary line of Township lot 21, then south along the west boundary line of Township lot 21 to the westwardly extension of the McCourt Road, then along the McCourt Road east to the east boundary line of Township lot 21, then south along the east boundary line of Township lot 21 to the Hazelgrove Road (Route # 228), then south along the Hazelgrove Road, the Malpeque Road (Route # 2) to where the North River crosses the Malpeque Road; Bounded on the east by following the North River north, crossing the Crabbe Road (Route # 256), Rustico Road (Route # 7) to the Township lot 33 and 34 line, then north along the Township lot 33 and 34 lot line to the Kilkenny Road (Route # 250), then following the Kilkenny Road east and the extension thereof to the west boundary line of Township lot 33 , then following the west boundary line of Township lot 33 north to Covehead Bay, then northeastwardly along the Bay to the Brackley Beach Sand Hills and Gulf of St. Lawrence to the point of commencement and includes the Rustico Island Sandhills.

**Electoral District No. 19 Borden - Kinkora**

The electoral district of Borden - Kinkora is bounded as follows:

Commencing at the intersection of the Blue Shank Road (Route # 107) and the county line between Prince and Queens Counties, and bounded on the north by the Blue Shank Road; Bounded on the west by Summerside Harbour, Sevenmile Bay and the Northumberland Strait; Bounded on the south by the Northumberland Strait; Bounded on the east commencing at Wrights Point, Victoria Harbour at the intersection with the county line, then north following the county line to the South Shore Villa Property, then following the South Shore Villa property east, north and west to the county line, then north to the point of commencement and includes Holmans Island.



**Electoral District No. 20 Kensington - Malpeque**

The electoral district of Kensington - Malpeque is bounded as follows:

Commencing on the Gulf of St. Lawrence at the county line between Prince and Queens Counties and bounded on the north by the Gulf of St. Lawrence and Malpeque Bay, Bounded on the west commencing at the intersection of the shore of Malpeque Bay and the north extension of the North St. Eleanors Road, then south following the North St. Eleanors Road, crossing the Western Road (Route # 2) to the intersection of West Drive and South Drive, then east along West Drive and the Western Road to the east boundary line of Township lot 17, then south following the east boundary line of Township lot 17 to the shore of Summerside Harbour at the mouth of Gillespie's Creek, Bounded on the south by the Summerside Harbour and the Blue Shank Road (Route # 107), then east following the Blue Shank Road (Route # 107) to the county line; Bounded on the east by the county line between Prince and Queens Counties to the point of commencement and includes Courtin Island, Ram Island and Little Courtin Island.

**Electoral District No. 21 Wilmot - Summerside**

The electoral district of Wilmot - Summerside is bounded as follows:

Commencing at the intersection of the Western Road (Route # 20) and Township lot 17 and 19 and bounded on the north by the Western Road (Route # 2) and West Drive to South Drive; Bounded on the west commencing at the intersection of the West Drive and South Drive, then south along South Drive to Pope Road, then east along Pope Road to Central Street, then south to Beaver Street, then east to Summer Street, then south to Pleasant Street, then east to Granville Street, then south on Granville Street and the extension thereof to Summerside Harbour, Bounded on the south by the Summerside Harbour to Gillespie's Creek, Bounded on the east commencing at the shore of Summerside Harbour at the mouth of Gillespie's Creek and the intersection of Gillespie's Creek and the Township lot 17 and lot 19 line then north following the east boundary line of Township lot 17 to the Western Road (Route # 2) to the point of commencement.

**Electoral District No. 22 St. Eleanors - Summerside**

The electoral district of St. Eleanors - Summerside is bounded as follows:

Commencing at the intersection of Central Street and Pope Road, then west to South Drive, then north to Western Highway (Route # 2), then west to the Kinsman Road; Bounded on the west by the Kinsman Road , the Lower Miscouche Road (Route # 11) and the extension of the Kinsman Road crossing Linkletter Creek and extending southwardly to the Linkletter Shore; Bounded on the south by the Summerside Harbour to the extension of Granville Street; Bounded on the east commencing at the extension of Granville Street at the shore of Summerside Harbour, then north on Granville Street to Pleasant Street, then west on Pleasant Street to Summer Street, then north on Summer Street to Beaver Street, then west on Beaver Street to Central Street, then north on Central Street to Pope Road to the point of commencement.

**Electoral District No. 23 Cascumpec - Grand River**

The electoral district of Cascumpec - Grand River is bounded as follows:

Commencing at Malpeque Harbour and the Gulf of St. Lawrence and bounded on the north by the Gulf of St. Lawrence, Cascumpec Bay and Mill River; Bounded on the west commencing at the intersection of the Mill River and the northwardly extension of the Fortune Cove Road (Route # 172), also being the eastern boundary of the Mill River Golf Course, then south to the south boundary line of Township lot 5, then west on the south boundary line of Township lot 5 to the rear line of the farms fronting on the east side of the Western Road, then south to the Trout River, then west following Trout River and crossing the Western Road (Route # 2) to the east boundary line of Township lot 9, then following the east boundary line of Township lot 9, to Grande Digue Point at Percival Bay. then southwardly crossing Percival Bay to Higgins Wharf being at the northwardly extension of the Higgins Road (Route # 129), then south to the Harmony Road (Route 128), then east to the Western Road (Route # 2), then south along the Western Road to the south boundary line of Township lot 16, then following the south boundary line of Township lot 16 east to the Grand River Road (Route # 12) and crossing the Grand River Road at Farrells Brook and following Farrells Brook, to Bentick Cove, Malpeque Bay and Malpeque Harbour to the point of commencement and includes Lennox Island, Bird Island and the Malpeque and Conway Sand Hills.

**Electoral District No. 24 Evangeline - Miscouche**

The electoral district of Evangeline - Miscouche is bounded as follows:

Commencing at the intersection of Bentick Cove and Farrells Brook, and bounded on the north by Farrells Brook to the Grand River Road (Route # 12) at Farrells Brook, then along the south boundary line of Township lot 16 west to the Western Road (Route # 2), then north along the Western Road to the Harmony Road (Route # 128), then west to the Higgins Road (Route # 129), then north to Higgins Wharf on the shore of Egmont Bay; Bounded on the west by Egmont Bay; Bounded on the south by Northumberland Strait and the Bedeque Bay; Bounded on the east commencing at Bedeque Bay and Miscouche Cove at Linkletter Shore at the southwardly extension of the Kinsman Road, then north following the Kinsman Road extension crossing the Linkletter Creek to the lower Miscouche Road (Route # 11), then west along the lower Miscouche Road to the Kinsman Road, then north following the Kinsman Road to the Western Road (Route # 2), then east along the Western Road (Route #2) to the North St. Eleanors Road, then following the Road and the extension thereof northeast and north to the shore of Malpeque Bay to the point of commencement.

**Electoral District No. 25 West Point - Bloomfield**

The electoral district of West Point - Bloomfield is bounded as follows:

Commencing at the intersection of Mill River and the eastwardly extension of the road leading from Bloomfield Corner to Mill River, then west along the said road to the Western Road (Route # 2), crossing the Western Road and west along the O'Halloran Road (Route # 145) to a road extending from the O'Halloran Road to the Dock Road (Route # 150), then north on said road to the Dock Road (Route #150), then west on the Dock Road (Route # 150) to the O'Halloran Road (Route # 145) and then westwardly along the O'Halloran Road and an extension thereof to the shores of the Northumberland Strait; Bounded on the west by the Northumberland Strait; Bounded on the south by the Egmont Bay to Grand Digue Point; Bounded on the east commencing at Grande Digue Point on the shore of Percival Bay at the intersection with Township lot line 9 and 10, then north along the east boundary line of Township lot 9 to the Trout River, then east along the Trout River to the rear line of farms fronting on the eastern side of the Western Road, then north to the north boundary line of Township lot 6, then east along the north boundary line of Township lot 6 to the Fortune Cove Road (Route # 172), then north along the Fortune Cove Road and the extension thereof, also being the eastern boundary of the Mill River Golf Course to the shore of Mill River to the point of commencement.

**Electoral District No. 26 Alberton - Miminegash**

The electoral district of Alberton - Miminegash is bounded as follows:

Commencing at the Gulf of St. Lawrence and Township lot 2 and 3 line, then west along the north boundary line of Township lot 3, crossing the Western Road (Route # 2) to the road leading from Alma to St. Louis, then north to the Union Road (Route # 152), then west to the Palmer Road (Route # 155), then north to the DeBlois Road (Route # 157), then west following the western extension of the DeBlois Road to the shore of Northumberland Strait; Bounded on the west by the Northumberland Strait; Bounded on the south commencing at the Northumberland Strait and the western extension of the O'Halloran Road (Route # 145), then west on the O'Halloran Road to the Dock Road (Route # 150), then east to a road extending from the Dock Road to the O'Halloran Road along said road to the O'Halloran Road, then south on the O'Halloran Road (Route # 145) to the Western Road (Route # 2) and Bloomfield Corner, then following the road from Bloomfield Corner southeastwardly and an extension thereof to the Mill River, then following Mill River to Cascumpec Bay and the Gulf of St. Lawrence; Bounded on the east by the Gulf of St. Lawrence to the point of commencement and includes Fox Island, Oultons Island and the Cascumpec Sand Hills.

**Electoral District No. 27 Tignish - DeBlois**

The electoral district of Tignish - DeBlois is bounded as follows:

Commencing on the Gulf of St. Lawrence and Township lot 2 and 3 line and bounded on the east, north and west by the Gulf of St. Lawrence; Bounded on the south commencing on the Northumberland Strait at the westwardly extension of the DeBlois Road, then east to the Palmer Road (Route # 155), then south to the Union Road (Route # 152), then east to the road extending from St. Louis to Alma, then south to the south boundary line of Township lot 2, then following the south boundary line of Township lot 2 eastwardly, crossing the Western Road (Route # 2) to the Gulf of St. Lawrence to the point of commencement.
