(3) HR Associates Inc. is the successor to Human Resource Successors acts Management Services Inc. and all acts with respect to or on behalf of the ratified Agency by HR Associates Inc. are confirmed and ratified both before and after the coming into force of this regulation.

2. These regulations come into force on June 12, 1999.

EXPLANATORY NOTES

HR Associates Inc., as successor to Human Resource Management Services Inc., is substituted as a nominator of representatives of the Department of Education, and its acts as successor are ratified.
