(b) the first \$8 of the material or ingredient cost;

(Approved by His Honour the Lieutenant Governor in Council dated 29 June 1999.)

Pursuant to section 57 of the *Revenue Tax Act* R.S.P.E.I. 1988, Cap. R-14, Council made the following regulations:

1. Subsection 14(1) of the Revenue Tax Act Regulations (EC262/60) is revoked and the following substituted:

Exemption; farmers,
fishermen, aqua-
culturists

14. (1) Where a person who is a farmer, commercial fisherman or aquaculturist purchases goods of a class that are exempt to farmers, commercial fishermen or aquaculturists, the person shall not be required to pay the tax if the person furnishes to the vendor the "Marked Gasoline or Marked Diesel Permit" (plasticized) issued in the person's name pursuant to the *Gasoline Tax Act* R.S.P.E.I. 1988, Cap. G-3.

2. Subsection 40(3) of the said regulations is revoked and the following substituted and added:

Fee

(3) Subject to subsection (3.1), the annual license fee for an entertainment device is \$200 in respect of each device.

Fee, kiddie rides

(3.1) The annual license fee for each entertainment device that is a coin-operated kiddie ride designed for children eight years of age and under is \$50 in respect of each ride.

3. These regulations come into force on July 10, 1999.

EXPLANATORY NOTES

SECTION 1 provides the authority to allow aquaculturists, along with farmers and commercial fishermen, to use their marked gasoline or marked diesel permit issued under the *Gasoline Tax Act* as an identifier, thus enabling them to purchase certain goods, exempt from revenue tax, for use in their occupation.

SECTION 2 reduces the annual fee for kiddie ride entertainment devices (coin-operated devices designed for children eight years of age and under) from \$200 to \$50.

Pursuant to section 28 of the *Wildlife Conservation Act* R.S.P.E.I. 1988, Cap. W-4.1, Council made the following regulations:

1. The open seasons, daily limits and possession limits
 - (a) in respect of hunting, are set out in Schedule I;
 - (b) in respect of trapping, are set out in Schedule II.
