HEALTH AND COMMUNITY SERVICES ACT
REGIONAL AUTHORITIES REGULATIONS

(Approved by His Honour the Lieutenant Governor in Council dated 26 October 1999.)

Pursuant to section 19 of the *Health and Community Services Act* R.S.P.E.I. 1988, Cap. H-1.1, Council made the following regulations:

1. (1) The West Prince Regional Authority shall consist of four electoral zones, as set out in Schedule A, with
 - (a) one elected board member to represent each zone; and
 - (b) three board members at large who shall be appointed by the Lieutenant Governor in Council in the month of December.

West Prince
Regional Authority

- (2) The East Prince Regional Authority shall consist of five electoral zones, as set out in Schedule B, with
 - (a) one elected board member to represent each zone; and
 - (b) four board members at large who shall be appointed by the Lieutenant Governor in Council in the month of December.

East Prince
Regional Authority

- (3) The Queens Regional Authority shall consist of five electoral zones, as set out in Schedule C, with
 - (a) one elected board member to represent each zone; and
 - (b) four board members at large who shall be appointed by the Lieutenant Governor in Council in the month of December.

Queens Regional
Authority

- (4) The Southern Kings Regional Authority shall consist of four electoral zones, as set out in Schedule D, with
 - (a) one elected board member to represent each zone; and
 - (b) three board members at large who shall be appointed by the Lieutenant Governor in Council in the month of December.

Southern Kings
Regional Authority

- (5) The Eastern Kings Regional Authority shall consist of four electoral zones, as set out in Schedule E, with
 - (a) one elected board member to represent each zone; and
 - (b) three board members at large who shall be appointed by the Lieutenant Governor in Council in the month of December.

Eastern Kings
Regional Authority

2. (1) Subject to subsection (2), every candidate for election as a regional authority board member shall be
 - (a) a Canadian citizen;

Qualifications for
elected board
members

- (b) eighteen years of age or older on election day; and
- (c) ordinarily resident in the zone of the regional authority for which the candidate is seeking election for the six months immediately preceding the date of the election.

Ineligibility as
electoral candidates

(2) The following persons are not eligible for election to the board of a regional authority:

- (a) persons who do not satisfy the requirements of subsection (1);
- (b) employees of any regional authority;
- (c) employees of the Department of Health and Social Services;
- (d) physicians who are licensed to practice in the province; and
- (e) any auditor or lawyer representing the regional authority.

Removal from
jurisdiction

(3) Where a board member ceases to be ordinarily resident within the zone for which the board member was elected, the board member's term is deemed to be rescinded upon the date the board member ceased to be ordinarily resident in the zone.

Disqualification of
elected member

(4) The board may disqualify an elected member from membership on the board where

- (a) the member has been absent from three or more consecutive meetings of the board without reasons satisfactory to the board; or
- (b) while a member of the board, the member has been convicted of an indictable offence that in the opinion of the board renders the member unfit to continue to hold office as a member of the board.

Eligibility to vote

3. (1) Subject to subsection (2), in order to be eligible to vote, a person shall

- (a) be eighteen years of age or older on or before the date on which the election is held;
- (b) be a Canadian citizen;
- (c) have been ordinarily resident within the geographic jurisdiction of the regional authority for the 6 months immediately preceding the date of the election; and
- (d) be resident in the geographic jurisdiction of the regional authority on the date of the election.

Eligible where
resident

(2) Eligible voters shall vote only in the electoral zone of the regional authority in which they reside on the date the election is held.

Qualifications for
appointed board
members

4. (1) Subject to subsection (2), every candidate for appointment as a regional authority board member shall be

- (a) a Canadian citizen;
- (b) eighteen years of age or older on the date the appointment becomes effective;
- (c) ordinarily resident within the geographic jurisdiction of the regional authority for the six months immediately preceding the date the appointment becomes effective.

(2) The following persons are not eligible for appointment as regional authority board members:

- (a) persons who do not satisfy the requirements of subsection (1);
- (b) employees of any regional authority;
- (c) employees of the Department of Health and Social Services;
- (d) physicians who are licensed to practice in the province; and
- (e) any auditor or lawyer representing the regional authority.

Ineligibility of
appointed
candidates

(3) Notwithstanding clause (2)(d), any person who is an appointed board member on the date these regulations come into force may be re-appointed for a term beginning November 30, 1999 and ending June 30, 2000.

Exception

(4) Where a board member ceases to be ordinarily resident within the geographic jurisdiction of the regional authority which the board member was appointed to represent, the board member's appointment is deemed to be rescinded upon the date the board member ceases to be ordinarily resident in the geographic jurisdiction of the regional authority.

Removal from
jurisdiction

(5) The board may disqualify an appointed member from membership on the board where

- (a) the member has been absent from three or more consecutive meetings of the board without reasons satisfactory to the board; or
- (b) while a member of the board, the member has been convicted of an indictable offence that in the opinion of the board renders the member unfit to continue to hold office as a member of the board.

Disqualification of
appointed member

5. The board of every regional authority shall establish procedures to establish and maintain mechanisms to ensure regular and meaningful consultation with and involvement of physicians and employees in the affairs of the regional authority.

Consultation

6. (1) Subject to subsection (2) and sections 13 to 17, regional authority board members shall be elected or appointed in accordance with these regulations for a term of three years.

Board members
term

Also includes Rustico Island.

Zone No. 3

The electoral zone **Queens Regional Authority - Zone No. 3:**

Shall be bounded as follows commencing at the intersection of Township No. 34 and 35 (Dalvay) and the Gulf of St. Lawrence; thence eastwardly along said gulf to St. Peters Bay; thence southwardly along said bay to the intersection of Township No. 39 and 40; thence southwardly along said line to Township No. 52; thence westwardly along said line and the north boundary of Township No. 51 and 66 to Township No. 49 (county line); thence southwardly along said county line to Township No. 49 and 50; thence westwardly along said line to Pownal Bay; thence along said bay to Hillsborough River; thence northeastwardly along the said river to the intersection of the said river and Township No. 34 and 35; thence northwardly along the said line to the Gulf of St. Lawrence (Dalvay), the point of commencement.

Zone No. 4

EXPLANATORY NOTES

These regulations provide for elections to, and appointments by Executive Council to, the five regional authorities established under the Health and Community Services Act for the delivery of health and community services.

SECTION 1 details the composition of the board of each regional authority, and divides each regional authority into electoral zones (as set out in Schedules A through E) for the purpose of holding elections.

SECTION 2 establishes the qualifications required of candidates for election as board members and the categories of persons ineligible for election as board members.

SECTION 3 sets out the eligibility requirements for voters in regional authority elections.

SECTION 4 establishes the qualifications required of persons for appointment as board members and the categories of persons ineligible for appointment as board members.

SECTION 5 requires boards of regional authorities to consult with physicians and employees regarding the affairs of the regional authority.

SECTION 6 establishes a three-year term for board members.

SECTION 7 provides for the replacement of vacancies on the boards.

SECTION 8 establishes the procedure for elections in regional authorities.

SECTION 9 establishes the duties of eligible voters.

SECTION 10 sets out the duties of the returning officer in a regional authority election.

SECTION 11 requires the Minister to cause the names of board members elected to each regional authority to be published in the Gazette.

SECTION 12 requires the board of each regional authority to elect a chair, vice-chair, and any other executive members and officers the board considers necessary.

SECTIONS 13 through 17 provide for transitional provisions applicable to each board for the years 1999 through 2001.

SECTION 18 deems these regulations to have come into force on October 26, 1999.

SCHEDULES A through **E** establish electoral zones for use in elections in each regional authority.

FORMS 1 through **3** are required by **SECTIONS 9** and **10** of these regulations.
