## INSURANCE ACT AUTOMOBILE LEVY REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 2 November 1999.)

Pursuant to section 84 of the *Insurance Act* R.S.P.E.I. 1988, Cap. I-4, Council made the following regulations:

**1.** Subclause 1(a)(i) of the Insurance Act Automobile Levy Regulations (EC692/91) is amended by the deletion of the words "1992, \$5.95" and the substitution of the words "2000, \$19.50".

## 2. These regulations come into force on January 1, 2000.

## EXPLANATORY NOTE

These regulations enable the Province of Prince Edward Island to recover a portion of hospital and medical costs incurred as a result of automobile accidents. The levy is charged to insurance companies based on the number of vehicles insured by them in this province. The base rate per vehicle was first established in 1992 at \$5.95 per vehicle and was increased annually by an inflation factor, resulting in a rate of \$8.52 for 1999. Following a recent assessment of increased health care costs associated with motor vehicle accidents, a new base rate levy per insured vehicle is established at \$19.50 effective January 1, 2000.

## WELFARE ASSISTANCE ACT REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 2 November 1999.)

Pursuant to section 7 of the *Welfare Assistance Act* R.S.P.E.I. 1988, Cap. W-3, Council made the following regulations:

# **1.** Subclause 18(c)(iii) of the Welfare Assistance Act Regulations (EC746/84) is revoked and the following substituted:

(iii) the Director may grant assistance

(A) not exceeding \$1065 per month, for board, lodging and care of a resident of a licensed community care facility, or (B) not exceeding \$470 per month, for board and lodging of a resident of a community care facility who is determined, by an assessor authorized by the Director, to require only board and lodging;

2. Clause 19(5)(c) of the regulations is revoked.

**3.** These regulations shall be deemed to have come into force on April 1, 1999.

## EXPLANATORY NOTES

The amendments specify the amounts of assistance for which a resident of a community care may be eligible. The amendments are retroactive to April 1, 1999.
