**EC1999-756**

**ROADS ACT**  
**HIGHWAY ACCESS REGULATIONS**  
**AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 21 December 1999.)

Pursuant to subsection 29(1) of the *Roads Act* R.S.P.E.I. 1988, Cap. R-15, Council made the following regulations:

**1. Schedule A-3 of the Highway Access Regulations (EC580/95) is amended by the revocation of clause 1(3)(f) and the substitution of the following:**

(f) in the City of Charlottetown, that segment of highway that lies between Melody Lane and the existing western boundary of the City of Charlottetown.

**2. These regulations come into force on January 1, 2000.**

**EXPLANATORY NOTE**

This amendment provides for extension of an existing infilling area to include that portion of Route 2 between Melody Lane and the Western Boundary of the City of Charlottetown.
