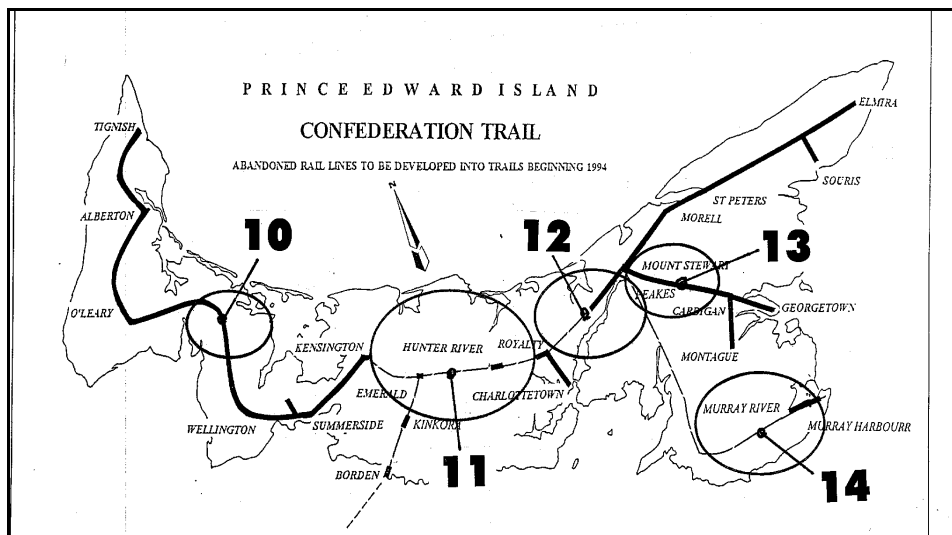

CLASS 1 MILK PRICE DETERMINATION ORDER

The Prince Edward Island Milk Marketing Board shall use a standard component test value of 3.3735 kilograms per hectolitre for protein and 5.7622 kilograms per hectolitre of other solids for billing purposes.
4. The price of milk components paid to the Prince Edward Island Milk Marketing Board by processors for components sold in Class 1(b) products shall be \$5.6355 per kilogram of butterfat, \$4.5318 per kilogram of protein and \$4.5318 per kilogram of other solids. The Prince Edward Island Milk Marketing Board shall use a standard component test value of 2.8270 kilograms per hectolitre for protein and 4.8411 kilograms per hectolitre of other solids for billing purposes.
5. The price of milk components paid to the Prince Edward Island Milk Marketing Board by processors for components sold in Class 1(c) products shall be \$5.6355 per kilogram of butterfat, \$4.8735 per kilogram of protein and \$4.8735 per kilogram of other solids. The Prince Edward Island Milk Marketing Board shall use a standard component test value of 3.3390 kilograms per hectolitre for protein and 5.7027 kilograms per hectolitre of other solids for billing purposes.
