(iii) the ordinary assistance for food in accordance with the schedule in subclause (i) shall be increased by \$48 per month for pregnant women;

(d) in paragraph (c)(iii)(A) by the deletion of the words “\$1065” and the substitution of the words “\$1369”;

(e) by the insertion of the following clauses:

(g) Local transportation

The Director may grant assistance for local transportation expenses not exceeding \$14 per month per household;

(h) Healthy child allowance

The Director may grant assistance for cultural and recreational activities not exceeding \$14 per month per dependent minor child.

2. Clause 19(14)(b) of the regulations is amended by the deletion of the words “\$42” and the substitution of the words “\$50”.

3. Subsection 46(1) of the regulations is amended by the deletion of the words “eighty-two” and the substitution of the words “\$103”.

4. (1) These regulations, with the exclusion of clauses 1(b), (c) and (d) are deemed to have come into force on April 1, 2000.

(2) Clauses 1(b), (c) and (d) of these regulations are deemed to have come into effect on January 1, 2000.

EXPLANATORY NOTES

SECTION 1 provides for the addition of items with regard to assistance be added to section 18 of the regulation, including local transportation allowance and healthy child allowance. The section also changes the amounts payable for food allowance, pregnant women allowance, for residence in a community care facility.

SECTION 2 changes the amount payable for an optical assessment from \$42 to \$50.

SECTION 3 changes the comfort allowance for residents of a nursing home from \$82 to \$103.

SECTION 4 sets out effective dates for the amendments.
