**EC2001-17**

**ELECTRIC POWER AND TELEPHONE ACT**  
**CITY OF SUMMERSIDE ELECTRIC UTILITY**  
**EXEMPTION REGULATIONS**  
**AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 16 January 2001.)

Pursuant to section 46 of the *Electric Power and Telephone Act* R.S.P.E.I. 1988 Cap. E-4, Council made the following regulations:

**1. The City of Summerside Electric Utility Exemption Regulations (EC99/96) are amended by the addition of the following:**

3. (1) For the purpose of these regulations, the amount that would be payable if customers were served in New Brunswick by the New Brunswick Power Corporation shall be adjusted to the extent necessary to remove any subsidy or the benefit of any subsidy which is provided directly or indirectly by any government or governmental agency to reduce the cost of electricity in New Brunswick to customers generally, or to particular customers or classes of customers, and the amount used as the amount that would be payable is the sum of the amount that is payable, and the subsidy or the benefit thereof.

(2) For greater certainty, any reduction in the cost of service inherent in the status of the New Brunswick Power Corporation as a Crown corporation in New Brunswick does not, in itself, constitute a subsidy within the meaning of subsection (1).

**2. These regulations come into force on January 27, 2001.**

**EXPLANATORY NOTES**

The amendment provides the City of Summerside with the same powers regarding New Brunswick government subsidies as enjoyed by Maritime Electric Company Limited and allows the City to recover the benefits of subsidies received by the New Brunswick electrical consumers.
