EFFECTIVE:October 1, 2001

Under the Prince Edward Island Milk Marketing Regulations and under the *Natural Products Marketing Act*, R.S.P.E.I., Cap. N-3, the Prince Edward Island Milk Marketing Board makes the following Order:

LEVIES ORDER AMENDMENT

Application

1. This Order amends the promotion levy rate contained in Section 3(b) of Board Order MMB01-05 that applies to butterfat delivered by milk and cream producers but does not include butterfat in milk and cream produced and delivered for manufacture into milk products for export from Canada under contractual commercial export activity as defined in the Prince Edward Island Milk Marketing Regulations.

Definitions

2. The words herein shall have the meanings as found in the *Natural Products Marketing Act* and the Prince Edward Island Milk Marketing Regulations.

Amendment

3. Section 3(b) of Board Order MMB01-05 is deleted and replaced with the following:

3(b) Each producer who delivers milk in Prince Edward Island shall pay to the Board a levy of \$0.3620 per kilogram of butterfat on all milk delivered by him, for product promotion and product research and development.

**AMENDMENTS TO
LEGAL PROFESSION ACT
REGULATIONS**

Pursuant to Section 55 of the *Legal Profession Act*, S.P.E.I. 1992, Cap.39, the Law Society of Prince Edward Island approved the following amendments to the *Legal Profession Act Regulations* at the MidWinter and Annual Meetings of the Society held on February 2, 2001 and June 16, 2001.

A. *Regulation 14(2)* is amended by adding the word “*mandatory*” following the word “*stipulate*” and immediately before the word “*guidelines*”.

B. *Regulation 15(9)* is added which reads as follows:

(9) Upon completion of the required period of articles, an articulated clerk and the clerk’s principal must complete the Articling Checklist approved by Council and submit it with his or her petition for admission to practice as a barrister, solicitor and attorney.

C. *Regulation 37* is amended as follows:

37(1) delete “*Form 7*” and insert “*Form 17*”

37(3) delete entire section

insert “*Each firm shall file annually, by July 1 a completed Form 17 signed by the member, in the case of a sole practitioner, or by a partner in the firm authorised by all of the members in that firm.*”

37(4) delete entire section

37(5) -renumber to 37(4)

-where reference to “*7*” occurs in subsections (a) and (b), change to “*17*”
-in the new 37(4)(c), change “*clause (5)(b)*” to “*clause (4)(b)*”

37(6) renumber to be 37(5)

Delete the remainder of 37

Insert the following *Regulations 37A* and *37B*

37A. (1) *Review of a firm’s accounts and procedures for accounting for trust monies will be carried out on a random basis by a public accountant as defined in the Public Accounting and Audit Act, R.S.P.E.I. 1988 Cap. p-28, engaged by the Society for that purpose.*

(2) *Reviews will be carried out on a schedule approved by the Secretary-Treasurer and designed to ensure that all firms will be reviewed within a period set by Council.*

(3) *Firms will be provided with 7 days notice of a review under this section.*

(4) *The Secretary-Treasurer will set the standards and procedures to be followed by the accountant in carrying out the review.*

(5) *Failure to cooperate fully with the accountant appointed pursuant to (1) shall constitute unprofessional conduct and each member of the firm involved may be subject to disciplinary action.*

(6) *Following the review, a report of the review will be sent to the Secretary-Treasurer and to the firm which was the subject of the review.*

- 37B. (1) *Upon receipt of the report referred to in 37A (6), the Secretary-Treasurer may order an audit of the books, records, and accounts of any firm which the report indicates are in non-compliance with s. 44 of the Act or these Regulations.*
- (2) *Audits carried out under subsection (1) will be carried out without notice and failure to cooperate with an auditor shall constitute unprofessional conduct and the appropriate disciplinary action will be taken.*
- (3) *The report carried out in accordance with this regulation will be forwarded to the Secretary-Treasurer and firm which was the subject of the audit.*

PLANNING ACT
SUBDIVISION AND DEVELOPMENT REGULATIONS
AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 18 September 2001.)

Pursuant to section 8 of the *Planning Act* R.S.P.E.I. 1988, Cap. P-8, Council made the following regulations:

1. Subsection 12(1) of the *Planning Act* Subdivision and Development Regulations (EC693/00) is revoked and the following substituted:

12.(1) No person shall, without first obtaining final approval from the Minister, subdivide land for development purposes. Subdivision approval

2. Subsection 31(1) of the regulations is amended by the addition of the words “from the Minister,” after the words “without first obtaining a development permit”.

3. These regulations come into force on September 18, 2001.

EXPLANATORY NOTES

The amendments clarify the authority of the Minister of Community and Cultural Affairs to issue subdivision final approvals and development permits.
