FINANCIAL ADMINISTRATION ACT
SPECIAL PROJECTS FUND REGULATIONS
AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 6 November 2001.)

Pursuant to section 14.8 of the *Financial Administration Act* R.S.P.E.I. 1988, Cap. F-9, Council made the following regulations:

1. Section 7 of the *Financial Administration Act* Special Projects Fund Regulations (EC639/99) is revoked and the following substituted:

7. (1) The funds allocated to the Education Stabilization Fund shall be disbursed through the Teacher Technology Training Program and through the Education Special Projects Program. Allocation of Education Stabilization Fund

(2) There is established a Teacher Technology Training Program that shall be administered by the Department of Education. Teacher Technology Training Program

(3) The Teacher Technology Training Program shall be used to promote and improve the use of technology in the schools of the province by *Idem*

- (a) providing technology training and support to teachers;
- (b) improving computer hardware and software in schools; and
- (c) supporting the integration of technology into the school curriculum.

(4) A project proposed under the program is eligible for funding through the Teacher Technology Training Program where the project Eligibility

- (a) is consistent with goal statements of the Department of Education Strategic Plan and, wherever possible, provides access to federally funded programs;
- (b) is initiated by the Department of Education with assistance from other departments of government as appropriate; and
- (c) specifies the purpose and cost of the project.

8. (1) There is established an Education Special Projects Program which shall be administered by the Department of Education. Education Special Projects Program

- Use of the Program (2) The Education Special Projects Program may be used for the implementation of new initiatives and for the maintenance or expansion of existing programs.
- Requirements (3) A proposed project is eligible for funding under the Program where the project
(a) is consistent with goal statements of the Department of Education Strategic Plan and wherever possible, provides access to federally funded programs; and
(b) is initiated by the Department of Education.
- Disbursement **9.** Where an application for disbursement of an amount from the Teacher Technology Training Program or the Education Special Projects Program has been
(a) approved by the Minister of Education;
(b) approved by Treasury Board;
(c) approved by Executive Council,
the Board shall disburse the approved amount.

2. These regulations are deemed to have come into force on April 1, 2000.

EXPLANATORY NOTES

The amendments create two programs under the Education Stabilization Fund - the Teacher Technology Training Program, and the Education Special Projects Program.

HEALTH AND COMMUNITY SERVICES ACT REGIONAL AUTHORITIES REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 6 November 2001.)

Pursuant to section 19 of the *Health and Community Services Act* R.S.P.E.I. 1988, Cap. H-1.1, Council made the following regulations:

1. The Regional Authorities Regulations (EC598/99) are amended

(a) in subsections 1(1), 13(1) and in Schedule A wherever they appear, by the deletion of the words “West Prince Regional Authority” and the substitution of the words “West Prince Health Region”;

(b) in subsections 1(2), 16(1) and in Schedule B wherever they appear, by the deletion of the words “East Prince Regional Authority” and the substitution of the words “East Prince Health Region”;

(c) in subsection 1(3), 17(1) and in Schedule C wherever they appear, by the deletion of the words “Queens Regional Authority” and the substitution of the words “Queens Health Region”;

(d) in subsections 1(4), 15(1) and in Schedule D wherever they appear the deletion of the words “Southern Kings Regional Authority” and the substitution of the words “Southern Kings Health Region”;

(e) in subsections 1(5), 14(1) and in Schedule E wherever they appear by the deletion of the words “Eastern Kings Regional Authority” and the substitution of the words “Eastern Kings Health Region”.

2. Subsection 8(8) is repealed and the following substituted:

(8) A candidate shall be declared elected by acclamation as a board member where that candidate is the only one being nominated for a vacancy on the board, whether the candidate is presented by the nominating committee or is a nomination from the floor. Acclamation

3. Section 10 is amended by adding after subsection (9) the following:

(9.1) Where a candidate disputes the results of an election, the candidate may request a recount of the ballots as follows: Request for a recount

(a) the request must be in writing and signed by the candidate;

(b) the original request must be filed with the Chief Electoral Officer of Elections PEI no later than two working days after the day of election.

(9.2) As soon as is practicable after receiving the request for a recount as required by subsection (9.1), the Chief Electoral Officer shall notify the candidates, the returning officer, the chief executive officer of the region in which the election was held, and the Minister of the date, time and place of the recount. Notification

Recount	(9.3) The Chief Electoral Officer shall carry out the recount at the time and place arranged, no later than two working days after the receipt of the request for a recount.
Material to be delivered	(9.4) The returning officer shall ensure that the following are delivered to the Chief Electoral Officer prior to the arranged time for the recount: (a) all sealed ballot boxes; (b) the original copy of the Declaration of Results completed pursuant to subsection 10(8); (c) any other requested election materials.
Attendance at recount	(9.5) Those who may attend the recount are: (a) the Chief Electoral Officer; (b) the returning officer; (c) the candidates, each of whom may be accompanied by an agent or representative.
Performing the recount	(9.6) In performing the recount, the Chief Electoral Officer shall recount the ballots, review any other election materials, and verify or correct the number of votes cast for each candidate and the total number of ballots rejected as recorded in the Declaration of Results.
After recount	(9.7) After determining the results of the recount, the Chief Electoral Officer shall return the ballot boxes and all documentation and provide written certification of the results of the recount to the returning officer.
Confirmation of candidate	(9.8) If the result of the recount indicates a tie vote and the recount was requested following a tie-breaking vote pursuant to subsection 10(7), the Chief Electoral Officer shall confirm the candidate declared elected by the returning officer.
<i>Idem</i> , where recount indicates tie	(9.9) Where the election did not result in a tie vote, but the recount indicates a tie, the Chief Electoral Officer shall (a) first carry out the procedures outlined in clauses 10(7)(a) to (c); and (b) then withdraw a single sheet from the receptacle and declare elected the candidate whose name appears on the sheet of paper drawn.
Declaration of Recount Results	(9.10) Immediately following the recount procedure, the returning officer shall complete a Declaration of Recount Results, and submit, before close of business on the first working day after the recount (a) the original Declaration of Recount Results to the chief executive officer of the regional authority in which the election was held; and (b) a copy of the Declaration of Recount Results to the Minister.
Delivery to chief executive officer of regional authority	(9.11) Where a recount has been made, the items referred to in subsection (9.4) shall be delivered by the returning officer to the chief

executive officer of the regional authority in which the election was held before close of business on the first working day after the recount.

4. The regulations are amended

(a) in clause 13(4)(a) by the by the deletion of the words “November 30” and the substitution of the words “December 31”;

(b) in clause 14(4)(a) by the deletion of the words “November 30” and the substitution of the words “December 31”;

(c) in clause 15(4)(a) by the deletion of the words “November 30” and the substitution of the words “December 31”;

(d) in clause 16(4)(a) by the deletion of the words “November 30” and the substitution of the words “December 31”;

(e) in clause 17(4)(a) by the deletion of the words “November 30” and the substitution of the words “December 31”.

5. These regulations come into force on November 17, 2001.

EXPLANATORY NOTES

SECTION 1 amends the relevant provisions of the regulations to reflect a change in names of the regional authorities.

SECTION 2 provides that a candidate for membership on the Board can become a member by acclamation whenever that candidate is the only one nominated, whether the nomination came from the floor or from the nominating committee.

SECTION 3 adds provisions relating to a recount.

SECTION 4 changes the three year term beginning November 30 to a three year term beginning December 31 for terms of appointments of members, commencing with the election year 2001.
