HIGHWAY TRAFFIC ACT
TRAFFIC SIGNS REGULATIONS
AMENDMENT

Pursuant to sections 242 and 243 of the *Highway Traffic Act* R.S.P.E.I. 1988, Cap. H-5, the Minister of Transportation and Public Works made the following regulations:

1. Subsection 5(1) of the *Highway Traffic Act* Traffic Signs Regulations (Jan. 19/84) is amended by the deletion of the words “A maximum speed” and the substitution of the words “Subject to section 5.1, a maximum speed”.

2. The regulations are amended by the addition of the following:

- 5.1** (1) “Variable speed sign” means an electronic sign that
- (a) uses an illuminated screen to display the maximum speed limit in kilometres per hour; and
 - (b) is capable of being varied to indicate a maximum speed for a highway or part of a highway as any two-digit number ending in zero.
- (2) Where permitted by the Minister, a variable speed sign may be used on a highway or any part of a highway.
- (3) Where use of a variable speed sign is permitted pursuant to subsection (2), the maximum speed on the highway or part of the highway shall be the number displayed on the variable speed sign.
- (4) A variable speed sign shall be as depicted in Diagram 5.1 of Schedule A.
