**AMENDMENTS TO
LEGAL PROFESSION ACT REGULATIONS**

Pursuant to Section 55 of the *Legal Profession Act*, S.P.E.I. 1992, Cap.39, the Law Society of Prince Edward Island approved the following amendments to the *Legal Profession Act Regulations* at the Mid-Winter Meeting of the Society held on January 31, 2003. The purpose of these additions and changes is to allow for electronic funds transfers.

Reg 36(1)(e): after “---- bank money orders”, add “, and funds transferred by way of Electronic Funds Transfer;”

Reg 36(3): Add “(a)” in front of “Trust money required ----“

Add new sub-section:

“(b) In the case of Electronic Funds Transfer, trust money shall be deemed deposited in a trust account when the member receives written confirmation from the member’s financial institution providing details of the deposit.”

And add new sub-section:

“(c) The member shall seek the written confirmation identified in (b) no later than the close of the banking day immediately after the day on which the member has notice of the Electronic Funds Transfer into the trust account.”

Reg 36(9): Delete current section entirely and replace with:

- “(9) A member shall only withdraw money from a trust account,
- (a) by a cheque clearly marked as a trust account cheque and made payable to a named payee or,
 - (b) by Electronic Funds Transfer in accordance with *Regulation 36(9A)* and;

no money shall be withdrawn from the trust account on behalf of the member except by cheque, Electronic Funds Transfer, or transfer form payable to himself or his account.”

Reg 36(9A): Add new section:

“(9A) Money withdrawn from a trust account by Electronic Funds Transfer shall be withdrawn only in accordance with this section.

(a) Money shall not be withdrawn from a trust account by electronic transfer unless the following conditions are met:

(i) The electronic transfer system used by the member must be one that does not permit an electronic transfer unless, the system requires the use of a password or access code to authorize the financial institution to carry out the transfer and the password or code is maintained by the member.

(ii) The electronic transfer system used by the member must be one that will produce, not later than the close of the banking immediately after the day on which the electronic transfer is authorized, a written confirmation from the financial institution confirming that the data describing the details of the transfer and authorizing the financial institution to carry out the transfer were received.

- (iii) The confirmation required by (ii) must contain the number of the trust account from which the money is drawn, the name, branch name, and address of the financial institution in which the account to which the money was transferred is kept, the name of the person or entity in whose name the account to which the money is transferred is kept, the number of the account to which the money is transferred, the time and date that the data describing the details of the transfer and authorizing the financial institution to carry out the transfer are received by the financial institution, and the time and date that the confirmation from the financial institution is sent to the member.
- (iv) Before any data describing the details of the transfer or authorizing the financial institution to carry out the transfer is entered into the electronic trust transfer system, an electronic trust transfer requisition must be signed by the member or a person who is not a member if the person has signing authority on the trust account from which the money will be drawn.
- (v) The data entered into the electronic trust transfer system describing the details of the transfer and authorizing the financial institution to carry out the transfer must be as specified in the electronic trust transfer requisition.
- (b) Not later than the close of the banking day immediately after the day on which the confirmation required by paragraph (a) (ii) is sent to a member, the member shall,
- (i) produce a printed copy of the confirmation,
 - (ii) compare the printed copy of the confirmation and the signed electronic trust transfer requisition relating to the transfer to verify whether the money was drawn from the trust account as specified in the signed requisition,
 - (iii) indicate on the printed copy of the confirmation the name of the client, the subject matter of the file, and any file number in respect of which money was drawn from the trust account, and
 - (iv) after complying with clauses (i) to (iii), sign and date the printed copy of the confirmation.
- (c) The tasks required by subsection (b) may be performed by a person other than the member, if the person has signing authority on the trust account from which the money will be drawn.
- (d) The electronic trust transfer requisition required under (a)(iv) will be in the form specified by Council.
- (e) For greater certainty, in no circumstances shall cash withdrawals be made by way of debit card.
