Pursuant to section 27 of the *Securities Act* R.S.P.E.I. 1988, Cap. S-3, Council made the following regulations:

- 1. The heading and subheading immediately before section 45.1 and sections 45.1 to 45.8 of the *Securities Act* Regulations (EC165/89) are revoked.**
- 2. These regulations come into force on December 15, 2003.**

EXPLANATORY NOTES

This amendment revokes transitional provisions in the regulations respecting the implementation of the national registration data base. A rule made under the Act will replace the revoked provisions.
