**CHANGE OF NAME ACT**  
**REGULATIONS**  
**AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 4 May 2004.)

Pursuant to section 16 of the *Change of Name Act* R.S.P.E.I. 1988, Cap. C-3.1, Council made the following regulations:

- 1. Clause 9(1)(a) of the *Change of Name Act Regulations* (EC247/02) is amended by the deletion of the words “\$160” and the substitution of the words “\$185”.**
- 2. These regulations come into force on May 15, 2004.**

**EXPLANATORY NOTES**

This amendment increases the fee for an application for a change of name by \$25. The application fee includes a charge for registration of a change of name notice at the Registry Office. As the fee for registrations at that Office has recently increased by \$25, a similar increase is required in the application fee set out in these regulations.

WATER QUALITY CERTIFICATE REGULATIONS  
AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 4 May 2004.)

Pursuant to section 25 of the *Environmental Protection Act* R.S.P.E.I. 1988, Cap. E-9, Council made the following regulations:

**1. Section 4 of the *Environmental Protection Act* Water Quality Certificate Regulations (EC583/95) is amended by the deletion of the words “\$100” and the substitution of the words “\$140”.**

**2. These regulations come into force on May 15, 2004.**

**EXPLANATORY NOTES**

**SECTION 1** allows for an increase in the fee for the application for a water quality certificate from \$100 to \$140 to reflect increased costs for bacteria and inorganic chemistry analysis.

**SECTION 2** provides for the commencement of these regulations.
