**CIVIL SERVICE SUPERANNUATION ACT**  
**PARTICIPATING EMPLOYER REGULATIONS**  
**AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 4 August 2004.)

Pursuant to section 28 of the *Civil Service Superannuation Act* R.S.P.E.I. 1988, Cap. C-9, Council made the following regulations:

**1. Section 1 of the *Civil Service Superannuation Act* Participating Employer Regulations (EC414/01) is amended**

**(a) in subsection (2), by the addition of the following after clause (1):**

(1.1) Prince Edward Island Energy Corporation;

**(b) by the addition of the following after subsection (4):**

(5) Notwithstanding clause (2)(1.1), Prince Edward Island Energy Corporation is not a participating employer in the Fund with respect to any employee employed by a subsidiary of the Corporation. *Idem*

**2. These regulations come into force on August 14, 2004.**

**EXPLANATORY NOTES**

The amendment adds the Prince Edward Island Energy Corporation to the list of employers who contribute and participate in the Fund, but does not include as an employer a subsidiary of the Corporation.
