GREETING

A PROCLAMATION

WHEREAS in and by section 60 of Chapter 13 of the Acts passed by the Legislature of Prince Edward Island in the 2nd Session thereof held in the year 2004 and in the fifty-third year of Our Reign intituled "Public Accounting and Auditing Act" it is enacted as follows:

"This Act comes into force on a date that may be fixed by the Lieutenant Governor in Council.",

AND WHEREAS it is deemed expedient that all sections except sections 24 and 48 of the said Act, Stats. P.E.I. 2004, 2nd Session, c. 13 should come into force on the 4th day of January, 2005,

NOW KNOW YE that We, by and with the advice and consent of our Executive Council for Prince Edward Island, do by this Our Proclamation ORDER AND DECLARE that all sections except sections 24 and 48 of the said Act being the "Public Accounting and Auditing Act" passed in the fifty-third year of Our Reign shall come into force on the fourth day of January, two thousand and five of which all persons concerned are to take notice and govern themselves accordingly.
