SOLIDS NOT FAT PAYMENT LIMIT ORDER

Application

1. This Order provides for the establishment of a limit on the amount of solids not fat in milk for which a producer will be paid.

Definitions

2. The words herein shall have the meanings as found in the *Natural Products Marketing Act* and the Dairy Farmers of Prince Edward Island Regulations.

Payment Limit

3. Payments for solids not fat delivered by a milk producer in each calendar month shall be limited to a maximum number of kilograms of protein and other solids represented by two and thirty-five one hundredths (2.35) multiplied by the producer's kilograms of butterfat production delivered in the same calendar month.

Application of Payment

4. The monthly payment for solids not fat within the stated limit shall be allocated between protein and other solids in the same proportion as that of total protein and total other solids contained in the producer's milk delivered in the same period.
