EC2006-601

REVENUE TAX ACT REGULATIONS AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated 17 October 2006.)

Pursuant to subsections 57(1) and (2) of the *Revenue Tax Act* R.S.P.E.I. 1988, Cap. R-14, Council made the following regulations:

- 1. Clause 1(1)(q.2) of the *Revenue Tax Act* General Regulations (EC262/60) is amended
 - (a) by the deletion of the semicolon following subclause (vi) and the substitution of the words ", and"; and
 - (b) by the addition of the following after subclause (vi):
 - (vii) an organic combustion system that
 - (A) has a name plate rating of 100 kilowatts or less, and
 - (B) complies with Canadian Standards Association (CSA) B415 or holds a US Environmental Protection Agency (EPA) certification,

and includes the combustion appliance, stoking and fuel delivery system of such appliance and the blowers and fans attached to the appliance, but does not include the breaching, exhaust or chimney structure of the system or any materials or services necessary to house the system;

- 2. Clause 1(1)(q.2) is amended
 - (a) by the deletion of the words ", and" following subclause (vi) and the substitution of a semicolon; and
 - (b) by the revocation of subclause (vii).
- 3. (1) Subject to subsection (2), these regulations are deemed to have come into force on April 1, 2006.
 - (2) Section 2 comes into force on March 31, 2008.

EXPLANATORY NOTES

These regulations amend the definition of "renewable energy equipment" to include organic combustion systems for a two-year period. This will extend tax exempt status to the purchase of these systems for the period from April 1, 2006 to March 31, 2008.
