Pursuant to subsection 9(2) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council cancelled the condition, made pursuant to section 2 of the Land Identification Regulations (EC606/95), prohibiting subdivision of approximately sixteen decimal nine five (16.95) acres of land in Lot 23, Queens County, Prince Edward Island, being Provincial Property No. 883892 (currently owned by Frank J. Nowak of New Glasgow, Prince Edward Island) and Provincial Property No. 883900 (currently owned by River Ridge Vineyard Estates Ltd., also of New Glasgow).

Council noted that Provincial Property No. 883900 consists of the approximately eight decimal eight (8.8) acres that remained following the subdivision of Provincial Property No. 883900 into two parcels in August 2002. Council further noted that pursuant to Order-in-Council EC2002-499 of 13 August 2002, this 8.8 acre portion of the said property was to have been consolidated with the adjacent Provincial Property No. 883892 but that the two parcels have remained separate, while the balance of Property No 883900, the approximately eleven decimal one (11.1) acres severed in 2002, has been assigned a new Property Identification Number (907634).

INDUSTRIAL OPERATION  
DETERMINATION

Pursuant to clause 20(1)(c) of the *Roads Act* Highway Access Regulations (EC580/95) Council determined that

- (a) a manufacturing operation for the fishing industry to be established on Provincial Property No. 50880 at Conway, Lot 11, Prince County, is a new industrial operation, and
- (b) establishment of this operation adjacent to Route 2 at Conway is in the best interest of the province.
