Pursuant to clause 10(a) of the *Executive Council Act* R.S.P.E.I. 1988, Cap. E-12 Council authorized the Minister of Community and Cultural Affairs to enter into an agreement with the Government of Canada, as represented by the Parks Canada Agency, to set out the terms and conditions for continuation of the Historic Places Initiative the object of which is to improve the state of conservation in Canada and increase Canadians' access to, and understanding of, their heritage by actively engaging in its preservation, and to outline contribution provisions for the fiscal years 2006/07 to 2008/09, such as more particularly described in the draft agreement.
