**EXEMPTION REGULATIONS  
AMENDMENT**

Pursuant to clause 17(1)(b) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council made the following regulations:

**1. Subsection 1.1(2) of the *Prince Edward Island Lands Protection Act, Exemption Regulations (EC368/88)* is amended by the deletion of the words “in respect of the specific land holdings identified in the approval granted under subsection (6)”.**

**2. These regulations come into force on 26 August 2006.**

**EXPLANATORY NOTES**

The amendment clarifies that the exemption applies to the aggregate land holding of an approved cooperative venture.
