### **CHAPTER A-15.1**

## APPRENTICESHIP AND TRADES QUALIFICATION ACT

#### REGULATIONS

Pursuant to section 10 of the Apprenticeship and Trades Qualification Act R.S.P.E.I. 1988, Cap. A-15.1, Council made the following regulations:

## **1.** In these regulations

Definitions

- (a) "Act" means the Apprenticeship and Trades Qualification Act Act R.S.P.E.I. 1988, Cap. A-15.1;
- (b) "credits" means recognition of previous work experience and credits training as suitable for reducing the requirements of the apprenticeship term;
- (c) "in-school training" means off-the-job training provided to in-school training apprentices in a classroom setting;
- (d) "interprovincial trade" means any trade designated by the interprovincial trade Canadian Council of Directors of Apprenticeship as suitable for interprovincial standards:
- (e) "probationary period" means the period of time a new apprentice probationary period must work at the trade before an apprenticeship agreement will be executed. (EC712/95)
- 2. These regulations apply to any trade which has been designated under Application the Act and for which an apprenticeship training or certification program has been established. (EC712/95)
- 3. No person shall become an apprentice in a designated trade unless that Apprenticeship

qualifications

- (a) is at least sixteen years of age;
- (b) has the minimum educational standing established for the trade by the Board; and
- (c) is employed by an employer who meets the requirements established by the Board; and
- (d) is willing to abide by the conditions set out in the apprenticeship agreement. (EC712/95)
- 4. (1) The Minister, upon recommendation of the Board, may designate Designation of any trade or occupation for apprenticeship training and certification.

(2) The designated trades are: all interprovincial trades, drafting, motor vehicle mechanic-electrical and fuel technician, motor vehicle mechanic-transmission technician, production equipment mechanic, small equipment mechanic, service station mechanic, secretary, and such other trades as may be designated by the Minister. (EC712/95)

Certified trades

**5.** The certified trades are: plumber and automotive service technician, construction electrician, and such other trades as may be certified by the Lieutenant Governor in Council. (EC712/95; 180/04)

Duration of apprenticeship

- **6.** (1) The term of apprenticeship for each trade shall be established by the Board and shall include a probationary period, for new apprentices, of
  - (a) two months for those who have completed a pre-apprentice training course approved by the Manager; and
  - (b) three months for those who have not competed a pre-apprentice training course.

Extension

(2) Probationary periods may be extended, upon approval of the Manager, to a maximum of six months.

Agreement

(3) Upon completion of the probationary period, an apprenticeship agreement shall be executed and registered with the Manager. (EC712/95)

Credit

- **7.** (1) The Board shall establish guidelines for the granting of credits toward a term of apprenticeship to persons who have
  - (a) graduated from a training institution whose course has been determined to be of acceptable standards;
  - (b) previous work experience in the trade; or
  - (c) been registered apprentices in another province or territory in Canada.

Evidence

(2) The Board may require documented evidence of previous work experience and training, and of registration as an apprentice in another province or territory. (EC712/95)

Completion of program

**8.** (1) Apprentices shall complete, to the satisfaction of the Manager, the training programs established for the trades in which they are registered.

Attendance

(2) An apprentice shall attend all in-school classes, required by the program, at a training institution approved by the Board.

Failure to attend

- (3) If an apprentice fails to attend authorized in-school training classes, the Manager, after investigation, may
  - (a) impose a penalty of additional time on the apprenticeship term; or

(b) cancel the apprenticeship agreement. (EC712/95)

9. (1) Upon completion of the term of apprenticeship, an apprentice shall sit the final examination for the trade.

Final examination

Issue of certificate.

- (2) If successful, the Minister shall issue to the apprentice
  - (a) a Completion of Apprenticeship certificate;
  - (b) a Certificate of Qualification; and
  - (c) a pocket card.
- (3) If unsuccessful on the first attempt of the examination, the Resetting apprentice may be permitted a second attempt
  - (a) after serving a waiting period of three months; or
  - (b) upon completion of a program of training approved by the Manager.
- (4) After the second attempt of the examination, subsequent attempts Additional training may be made only after completion of a program of training approved by the Manager. (EC712/95)

examination

10. (1) Tradespersons desiring to be examined for a Certificate, shall Application for apply on a form approved by the Minister.

(2) Tradespersons may be examined for a Certificate of Qualification if Extra work they have worked at the trade at least twelve months more than the full experience term of apprenticeship established for the trade,

- (a) within the previous ten years; and
- (b) since reaching the age of sixteen years.
- (3) Tradespersons may be examined for a Certificate of Proficiency if Certificate of they have worked at the trade at least eighty months

proficiency

- (a) within the previous ten years; and
- (b) since reaching the age of sixteen years.
- (4) Tradesperson may be examined for a Certificate of Achievement if Certificate of they have worked at the trade at least the time period established for the achievement trade by the Board, and since reaching the age of sixteen years.

(5) If tradespersons fail the examination, they are not eligible for re- Conditions examination until

precedent to reexamination

- (a) three months have elapsed after the first attempt;
- (b) twelve months have elapsed after the second attempt, or they have completed a period of technical training satisfactory to the Manager; and
- (c) eighteen months have elapsed after subsequent attempts, or they have completed a period of technical training satisfactory to the Manager. (EC712/95)

PEI certificates

- **11.** (1) The Minister shall issue Prince Edward Island certificates to apprentices and tradespersons who
  - (a) successfully complete the prescribed examination; or
  - (b) hold an out-of-province certificate with an interprovincial Red Seal affixed; or
  - (c) hold a certificate issued under similar legislation by another province or territory.

National status

(2) Apprentices, and tradespersons who successfully complete an interprovincial examination, will have a Red Seal, emblematic of national standing, affixed to their certificates. (EC712/95)

Suspension and cancellation

**12.** (1) The Minister, upon recommendation of the Board or the Manager, may suspend or cancel a certificate if the holder thereof has obtained it by fraud, or is incompetent or grossly negligent in the discharge of his or her duties.

Notice

(2) If a certificate is suspended or cancelled, the holder shall be notified within twenty one days by registered letter.

Return of certificate

(3) Where a certificate is suspended or cancelled, the holder shall return the certificate to the Minister within seventy-two hours after receiving a written notice of suspension or cancellation. (EC712/95)

Plan of apprenticeship training **13.** (1) A plan of apprenticeship training for a designated trade shall not be activated unless it has first been approved by the Board.

Content of plan

- (2) The following shall be include in the plan of apprenticeship training:
  - (a) the Apprenticeship Agreement;
  - (b) the trade scope and content;
  - (c) an outline of both the in-school and on-the-job training components;
  - (d) the process for developing examinations for determining apprentice progress and completion;
  - (e) the ratio of apprentices to journeypersons; and
  - (f) other factors determined by the Board to be essential to a successful apprenticeship. (EC712/95)

Trade Advisory Committees **14.** (1) The Board, in consultation with the Manager, may establish a trade advisory committee in respect to any designated trade.

Membership

(2) The Board shall appoint not less than four persons as members of each committee established under subsection(1), one-half of whom are qualified tradespersons representative of the views of employees, and one-half representative of the views of employers.

- (4) Each member shall be appointed for a three year term, and may be Term re-appointed.
  - (5) A committee established in respect of a trade shall

Functions

Cap. A-15.1

- (a) determine the examination that a candidate for a certificate in that trade is required to complete, and the degree of proficiency required to complete the examination;
- (b) designate one or more members of the committee who shall conduct practical sections of examinations for a certificate;
- (c) advise the Board on the details of a plan of apprenticeship; and
- (d) advise the Board on apprenticeship matters in general.
- (6) All examination papers and other documents pertaining to the work Documents of trade advisory committees shall be the property of government and shall be filed with the Minister.

(7) The Board, in lieu of establishing a trade advisory committee in Joint committee respect of a trade, may appoint members to a joint trade advisory committee, or a similar committee, that is co-sponsored and co-managed by the Board and other training partners. (EC712/95)

## 15. The Manager shall

Functions of Manager

- (a) register all apprentices and journeypersons;
- (b) file and keep a registry of all apprenticeship agreements, cancellations, terminations, transfers and completions apprenticeship;
- (c) maintain and promote interest in the role of apprenticeship;
- (d) plan and carry out plans of apprenticeship in a designated trade;
- (e) provide such information and make such investigations, pursuant to a complaint or report, as required by the Minister or the Board;
- (f) undertake studies or investigations of a trade and of the requirements for the supply and training of persons therefor, and collaborate with appropriate authorities in carrying out such studies and investigations;
- (g) monitor the training of apprentices and inspect facilities being used for such training; and
- (h) submit a report annually to the Minister. (EC712/95)
- **16.** (1) The fees payable for the examination of candidates for Certificate Fees of Qualification are listed below. The issuing of certificates is included in the fees.
