## **CHAPTER M-13**

## MUNICIPALITIES ACT

#### REGULATIONS

Pursuant to section 67 of the *Municipalities Act* R.S.P.E.I. 1988, Cap. M-13, Council made the following regulations:

**1.** For the purposes of subsection 27(4) of the Act the amount prescribed amount is \$50,000. (EC252/84; 18/92)

**4.** The form of warrant to the returning officer directing him to hold a Form 3 poll pursuant to subsection (15) of Schedule 2 of the Act is set out in Form 3 of the Schedule. (EC252/84)

**5.** The form of the oath of an elector voting at an advance poll pursuant Form 4 to subsection (18) of Schedule 2 of the Act is set out in Form 4 of the Schedule. (EC252/84)

**6.** The form of the oath of office to be taken by the returning officer or Form 5 deputy returning officer pursuant to subsection (21) of Schedule 2 of the Act is set out in Form 5 of the Schedule. (EC252/84)

**7.** The form of the oath of office to be taken by a poll clerk pursuant to Form 6 subsection (22) of Schedule 2 of the Act is set out in Form 6 of the Schedule. (EC252/84)
