CHAPTER S-2.1

SCHOOL ACT

SCHOOL BOARDS REGULATIONS

Pursuant to section 147 of the School Act R.S.P.E.I. 1988, Cap. S-2.1 Council made the following regulations:

School Units

1. (1) The English school system shall be divided into two geographical English school units units known as (a) the Eastern school unit with jurisdiction under the Act over the areas of the province situate to the east of the boundary line described in section 3; and (b) the Western school unit with jurisdiction under the Act over the areas of the province situate to the west of the boundary line described in section 3. (2) The English school units shall be administered by school boards as English school follows: boards (a) the Eastern school unit by a school board known as the Eastern School District of Prince Edward Island or the Eastern School District: and (b) the Western school unit by a school board known as the Western School Board of Prince Edward Island or the Western School Board. (EC225/96)

2. (1) The French school system shall consist of one geographical unit French school unit known as the French school unit, with jurisdiction under the Act over the entire province.

(2) The French school unit shall be administered by a school board French school board known as La Commission scolaire de langue française or the French Language School Board. (EC225/96)

Unit Boundaries

3. (1) The boundary line between the Eastern and Western school units Refer to reference shall be determined by referring to the reference line described in $^{\text{line}}$ subsection (2), with the following modifications:

(a) where the reference line follows the Bradford Road and the River Road (Route 117), between the Trans Canada Highway and the Augustine Cove Road (Route 10), the boundary shall follow the centre line of the Bradford Road and of the River Road (Route 117); and

(b) for all other points on the reference line, the boundary line shall be 3/10 kilometre to the west of the reference line.

Reference line

(2) There shall be a reference line between the Eastern school unit and the Western school unit as follows:

Commencing at a point on the southern shore of New London Bay at the high water mark, where the said bay is intersected by an imaginary line extending the Simpsons Mill Road northwardly to the said bay;

Thence southwardly along the extension and continuing on the Simpsons Mill Road to the New London Road (Route 224);

Thence southeastwardly to the road leading to North Road (Route 240);

Thence southwestwardly along the said road and an extension thereof to the Trout River Road (Route 239);

Thence southwardly along the Trout River Road (Route 239) to the Millvale Road (Route 231);

Thence in a southwardly, westwardly and southwardly direction along the Millvale Road (Route 231) crossing the Charlottetown to Summerside Road (Route 2) and continuing along Route 231 to the North Breadalbane Road;

Thence westwardly along the said road to the South Breadalbane Road;

Thence eastwardly along the said road to the Inkerman Road (Route 231);

Thence southwardly along the said road to the Balaklava Road (Route 232);

Thence westwardly along the said road to the County Line Road;

Thence northwardly along the said road to the Branch Road (Route 232); Thence westwardly along the Branch Road (Route 232) to the intersection with Trans Canada Highway (Route 1);

Thence westwardly along the said highway to the Bradford Road;

Thence southwardly along the said road to the River Road (Route 117);

Thence southwardly along the said road to the Augustine Cove Road (Route 10);

Thence eastwardly along the said road to the Enman Road; and

Thence southwardly along said road and continuing in a straight line following the eastern boundary of John M. Leard (1880) and Edward McFayden (1926) to the north shore of Northumberland Strait, until it reaches the high water mark of the southern shore of Prince Edward Island.

Being and intended to be the reference line for the boundary line between the Eastern and Western school units, as described in subsection (1). (EC225/96)

Electoral Zones

4. (1) The Eastern school unit shall have eleven zones for the purpose Eastern unit, eleven zones of trustee elections, with one trustee to represent each zone. (2) The Western school unit shall have nine zones for the purpose of Western unit, nine zones trustee elections, with one trustee to represent each zone. (3) The French school unit shall have six zones for the purpose of French unit, five trustee elections as follows: zones (a) Zone 1 shall have three trustees; (b) Zones 2, 3, 4 and 6 shall have one trustee each; and (c) Zone 5 shall have 2 trustees. (4) The school zones for trustee elections shall be as described in Zone descriptions Schedule A to these regulations. (EC225/96; 181/05) **Eligibility of Voters** 5. Any person, who meets the criteria set out in section 29 or 32 of the Voter eligibility Act as applicable, is eligible to vote in a school board election. (EC225/96) 6. (1) Subject to subsection (2), eligible voters may vote in the electoral Eligible where zone and school unit in which they resided on the date the election was resided called. (2) Students who otherwise qualify to vote in a school board election students determine the electoral zone in which they vote as follows: (a) single students shall vote in the electoral zone and school unit in which their parents (or custodial parent) resided on the date the election was called; or (b) married students shall vote in the electoral zone and school unit in which they actually resided on the date the election was called. (EC225/96) Elections 7. (1) School board elections shall be held every 3 years on a date to be School board elections every 3 fixed by the Minister, as follows: years (a) ordinary polling shall be set on a Monday in May of an election year;

(b) the date of ordinary polling day shall be not more than thirty-two clear days and not less than twenty-six clear days from the beginning date of the election campaign; and

(c) the beginning date of the election campaign shall be the date the call for nominations is published as required by subsection (2).

Call for nominations

(2) The Chief Electoral Officer shall publish a call for nominations within the requirements set out in this section, in the newspapers, as required by section 9.

Polling stations open election day (3) On election day, the polling stations shall open at 12:00 noon and close at 8:00 p.m. (EC225/96)

Chief Electoral Officer

Chief Electoral Officer **8.** (1) The Chief Electoral Officer of the province, appointed under the *Election Act* R.S.P.E.I. 1988, Cap. E-1.1, shall administer school board elections.

Idem

(2) The Chief Electoral Officer may appoint such employees as the Chief Electoral Officer considers necessary to perform the duties of the office. (EC225/96)

Employees

Powers and duties of Chief Electoral Officer **9.** (1) The Chief Electoral Officer shall

(a) exercise general direction and supervision over the conduct and administration of school board elections;

(b) instruct each Zone Returning Officer and provide such supervision as the Chief Electoral Officer considers necessary to ensure the effective conduct of school board elections;

(c) furnish official ballot boxes and papers to the polling stations and make rules respecting the use, transport and security of the ballot boxes and papers;

(d) develop and approve any forms necessary for the conduct of elections under the Act;

(e) have the discretion to adapt the provisions of these regulations to existing circumstances where the Chief Electoral Officer considers it necessary;

(f) be responsible solely to the Lieutenant Governor in Council;

(g) publish notices respecting the nomination and election of school trustees in daily and weekly newspapers, in English and French, as appropriate;

(h) enforce, on the part of elections officers, fairness, impartiality and compliance with the Act and these regulations; and

(i) exercise such powers as may be necessary to fulfil the office of Chief Electoral Officer, in conducting the school board elections.

Special powers for (CEO time

(2) If during the course of any election it transpires that insufficient time has been allowed, or insufficient election officers or polling stations have been provided, for the execution of any of the purposes of these regulations, by reason of the operation of any provision of these regulations, any mistake or miscalculation or any unforeseen emergency,

the Chief Electoral Officer may, notwithstanding anything in these regulations,

(a) except provided in this subsection, extend or abridge the time for doing any act;

- (b) increase the number of election officers;
- (c) increase the number of polling stations;

(d) generally adapt the provisions of these regulations to existing circumstances,

but the Chief Electoral Officer may not extend the hour for the opening or closing of an ordinary polling station, or for accepting a nomination paper on nomination day or change the date of ordinary polling day as fixed by the Minister. (EC225/96; 342/96)

Zone Returning Officers

10. (1) The Chief Electoral Officer shall appoint one Zone Returning Zone Returning Officer for each zone in each school unit.

Officers

(2) Zone Returning Officers shall have the following duties:

(a) to report to and to be responsible to the Chief Electoral Officer; (b) to exercise direction and supervision over the administration of

elections for which the person was appointed, subject to the rules and instructions issued by the Chief Electoral Officer;

(c) to deliver the nomination papers filed for the school unit to the Chief Electoral Officer not later than 24 hours after the closing of nominations:

(d) to designate places for polling stations in each electoral zone for eligible voters to register and to vote;

(e) to require eligible voters to register by completing a credential certificate in accordance with the instructions of the Chief Electoral Officer;

(f) on election day, to prominently display voting instructions at the entrance to and within polling stations;

(g) on election day, to maintain order within the polling stations;

(h) to appoint at least two scrutineers to perform such duties as may be specified in the Chief Electoral Officer's instructions;

(i) to inform the Chief Electoral Officer as soon as possible on election night of the results of ballot counts;

(j) to ensure the delivery, after election day, to the Chief Electoral Officer of ballots, ballot boxes and other materials in accordance with the instructions of the Chief Electoral Officer:

(k) to exercise such other powers as may be prescribed by the regulations or assigned by the Chief Electoral Officer.

(3) Where more than one polling station is established within a zone, Deputy Zone the Zone Returning Officer shall appoint a Deputy Zone Returning Returning Officer

Duties of Zone Returning Officers

Officer who shall exercise supervision over one of the polling stations and perform all of the duties of a Zone Returning Officer, except that the Deputy Zone Returning Officer shall report and be responsible to the Zone Returning Officer. (EC225/96)

Ten persons nominate candidate **11.** (1) Any ten or more persons, qualified under section 32 of the Act, may nominate a candidate for school trustee for the zone in which the nominator resides, by filing with the Zone Returning Officer, a nomination paper in the form approved by the Chief Electoral Officer, at any time between the beginning date of the election campaign and 4:00 p.m. on nomination day.

Nomination day (2) Nomination Day shall be Friday, the seventeenth day before ordinary polling day. (EC225/96)

Delivery of nomination papers **12.** (1) Within twenty-four hours of the closing of nominations, Zone Returning Officers shall deliver the nomination papers collected to the Chief Electoral Officer.

(2) After nomination day, the Chief Electoral Officer shall

- (a) determine the eligibility of candidates; and
- (b) publish in the daily and weekly newspapers of the province

(i) the names of all eligible candidates,

(ii) the names of their respective electoral zones, and

(iii) the location of the polling stations in each electoral zone. (EC225/96; 225/02)

Voters

13. An eligible voter shall

(a) register with the Zone Returning Officer by giving the voter's name and address;

(b) complete a credential certificate;

(c) exchange the credential certificate for a ballot paper;

(d) mark the ballot in accordance with the posted instructions, indicating the candidate for whom the voter intends to vote; and

(e) fold the ballot paper and return it to the Zone Returning Officer for placement in the ballot box. (EC225/96)

14. Where an eligible voter is unable to vote in the manner referred to in section 13 because the voter is unable to read, write, or is incapacitated by blindness or other physical infirmity, the voter may request a friend or a scrutineer to assist:

(a) by reading the credential certificate and having the voter sign the same or make a mark with an "X";

(b) by signing the certificate as witness and endorsing the name of the voter thereon; and

(c) by marking the ballot paper in the manner directed by the voter, folding it and giving it to the Zone Returning Officer for placement in the ballot box. (EC225/96)

Agents

15. Each candidate may appoint one agent only to represent the Candidate's agent candidate at each polling station, and the agent shall carry a certificate of appointment as agent signed by the candidate. (EC225/96)

Poll Closing and Counting Ballots

16. At the close of the poll, and in the presence of the poll clerk, the Duties of Zone candidates or agents, or if none are present, then in the presence of at Returning Officer at least two electors, the Zone Returning Officer shall

(a) open the ballot box or boxes;

(b) count the votes by using the following method:

(i) the Zone Returning Officer shall give a tally sheet to the poll clerk and to at least two other persons present in the polling station,

(ii) after each person present is given full opportunity to examine a ballot, the Zone Returning Officer shall decide whether the ballot should be rejected or counted,

(iii) if the ballot is counted, the Zone Returning Officer shall call out the vote and have it entered on the tally sheet, and

(iv) if the ballot is rejected, the Zone Returning Officer shall place it in a separate envelope;

(c) for zones which elect more than one trustee, the candidates with the highest number of votes to fill the seats required shall be declared elected. (EC225/96)

17. If during the counting of the votes, any person who is officially Objection to ballot present objects to any ballot, a Zone Returning Officer shall hear and decide every question arising out of the objection, and the Zone Returning Officer's decision is final. (EC225/96)

18. (1) After counting the votes, a Zone Returning Officer shall (a) require two electors present during the counting of the votes to sign the tally sheets;

(b) place the ballots for each candidate in marked envelopes and seal them;

(c) complete the required number of statements of poll supplied by the Chief Electoral Officer; and

(d) deposit all ballots, credential certificates, tally sheets and one statement of poll in the ballot boxes.

(2) Where only one polling station exists within a zone, the Zone Returning Officer shall dispose of the statements of poll as follows:

(a) one statement shall be retained;

(b) one statement shall be delivered to the Chief Electoral Officer within twenty-four hours after the date designated as election day together with the ballot box or boxes, credential certificates, ballot papers, envelopes, tally sheets and all other documents or material used at the polling station; and

(c) one statement shall be mailed or delivered to each candidate.

where more than one polling station (3) Where more than one polling station exists within a zone, the Deputy Zone Returning Officer shall, immediately upon completion of the duties outlined in subsection (1), deliver all ballot boxes, with contents and statements of poll to the Zone Returning Officer for that zone or as otherwise determined by the Chief Electoral Officer.

> (4) The Zone Returning Officer shall then complete the required number of copies of a consolidated statement of the polling stations within the zone and shall dispose of them as follows:

(a) one statement shall be retained;

19. (1) Within two working days after ordinary polling day, any candidate may request the Chief Electoral Officer to recount all the ballots cast for trustees in the candidate's electoral zone.

(2) The recount shall commence not later than two working days after

Recount within two days

Time and place of recount

(3) The Chief Electoral Officer shall notify the candidates concerned of the time and place at which the ballots will be recounted, and the final addition will be made.

Recount, who may be present (4) At such recount of the ballots and final addition by the Chief Electoral Officer, the Zone Returning Officer shall be present, and each candidate shall be entitled to be present and to be represented by one agent.

(5) At the time and place appointed and in the presence of the said Final addition persons, the Chief Electoral Officer shall make a final addition from the statement of the poll or polls supplied by the Zone Returning Officer and count all the votes or ballot papers for trustee returned by the Zone Returning Officer and shall, for that purpose, open the sealed envelopes containing the ballot papers.

(6) The Chief Electoral Officer shall recount the ballots according to Chief Electoral the rules set forth for every Zone Returning Officer and shall verify or correct the statement of each poll by recording the ballot paper count and the number of votes cast for each candidate.

(7) Upon the completion of the recount or as soon as the results of the Recount completed, poll are ascertained, the Chief Electoral Officer shall seal the ballot papers in their respective envelopes.

(8) When the Chief Electoral Officer, upon completion of the recount If equality of votes of all polls and the final addition for the zone, finds that an equality of votes exists between the candidates, the winning candidate shall be determined as follows:

(a) out of an opaque container which contains ten balls numbered 1 to 10, the Chief Electoral Officer shall draw one for each tied candidate and, for the purpose of the draw, the numbers drawn shall be attributed to the names of the candidates in alphabetical order; (b) the candidate who draws a 5 or closest to 5 shall be declared the

winner: (c) in the event that the candidates are equally close to 5, the draw shall be repeated until a winner is declared.

(9) The Chief Electoral Officer shall forthwith certify the result of the CEO certifies recount recount and final addition. (EC225/96)

Election Documents

20. (1) The Chief Electoral Officer shall retain contents of the ballot Ballots retained for boxes and all documents pertaining to the election for two months 2 months following election day

(2) The Chief Electoral Officer may destroy election documents after CEO may destroy the expiry of the time required in subsection (1) except where there is any court proceeding pending.

(3) No person may have access to election documents except pursuant Access to election to a court order. (EC225/96)

The Chief Electoral Officer shall declare to be elected the candidates Declared elected, candidates with having the largest number of votes and report to the Minister, within five most votes working days of the date designated as election day, the electoral zones that they represent. (EC225/96)

Publish names of 24. Within twenty-eight days of the date designated as election day, the trustees Minister shall publish the names of the members of each school board in the Royal Gazette. (EC225/96)

Acclamation

25. If, on nomination day, there is officially nominated only the required Declares those elected by number of candidates for a particular zone, the Zone Returning Officer acclamation shall immediately report to the Chief Electoral Officer who shall declare and proclaim such candidates duly elected as trustees. (EC225/96)

Pecuniary Interests

26. (1) If a trustee has any pecuniary interest in any matter and is Trustee's pecuniary interest present at a meeting of the school board in which the matter is considered, the trustee

> (a) shall disclose the general nature of the pecuniary interest prior to any discussion of the matter;

> (b) subject to subsection (3), shall not take part in the discussion of or vote on any question in respect of the matter;

> (c) shall not attempt in any way, whether before, during or after the meeting, to influence the voting on any question in respect of the matter; and

> (d) subject to subsections (2) and (3), shall leave the room in which the meeting is being held until the discussion and voting on the matter are concluded.

(2) If the matter with respect to which the trustee has a pecuniary Funds already allocated interest is the payment of an account for which funds have previously been committed, it is not necessary for the trustee to leave the room.

Pecuniary interest not disclosed

(3) If a trustee's pecuniary interest is not disclosed as required by subsection (1) by reason of the trustee's absence from a meeting, the trustee shall disclose the pecuniary interest and otherwise comply with

the requirements of this section at the next school board meeting attended by the trustee with the pecuniary interest.

(4) The abstention of a trustee under subsection (1) and the disclosure Attention and of a trustee's pecuniary interest under subsection (3), shall be recorded in disclosure in the minutes of the meeting.

(5) If a trustee

(a) has a pecuniary interest in a matter before the school board, any committee of the school board or any committee, commission or agency to which the trustee is appointed as a representative of the school board; and

(b) makes a disclosure of that pecuniary interest in accordance with this section.

that trustee is not disqualified from being a trustee by reason of having that pecuniary interest.

(6) A trustee who contravenes this section is deemed to be disgualified Contravention. deemed as a trustee of the school board, pursuant to subclause 38(1)(f)(ii) of the Act. (EC225/96)

27. For the purposes of sections 26 and 28, the pecuniary interests

(a) of the spouse, children or parents of a person; or

(b) of the parents of the spouse of a person,

that are known to the person or which the person ought reasonably to have known, shall be deemed to be the pecuniary interests of the person. (EC225/96)

28. (1) Section 26 does not apply to a pecuniary interest in any matter Exceptions that a trustee may have

(a) as an elector of the school unit;

(b) by reason of the trustee having a pecuniary interest in the matter which is a pecuniary interest in common with electors generally;

(c) by reason of the trustee's appointment as the representative of the school board to any commission, committee or other body;

(d) by reason of the trustee being entitled to receive any allowance, honorarium, indemnity, benefit, expenses or remuneration payable to a trustee in respect of the matter;

(e) by reason of the trustee's employment with the Government of Canada, the Government of Prince Edward Island or a federal or provincial Crown corporation or agency, except with respect to a matter directly affecting the department, corporation or agency of which the person is an employee;

(f) by reason of the person being a member of a credit union or a cooperative formed under an Act of the Legislature or of the Parliament of Canada; or

(g) by reason only of a pecuniary interest of the trustee that is so remote or insignificant in its nature that it cannot reasonably be regarded as likely to influence the trustee. (EC225/96) 33. An amount not exceeding one-third of the total remuneration paid to One-third of remuneration as a school trustee in any year shall be designated as having been paid in general expenses respect of general expenses incurred by the trustee incidental and necessary to the discharge of the trustee's duties. (EC225/96) **34.** A school trustee may request the school board to deduct a proportion Income tax deduction of the remuneration for income tax purposes and, where a request is

made, the board shall deduct the amounts requested and remit them to Revenue Canada on behalf of the trustee. (EC225/96)






