Introduction

The Municipal Profile Project

This is one of a series of profiles produced in collaboration with the Federation of PEI Municipalities, the member municipalities, and Human Resources Development Canada.

Information for the 30 municipal profiles was gathered from interviews with municipal administrators, from Statistics Canada Census data, from PEI Government publications, and from many other helpful individuals and agencies.

Contact information for this municipality, Human Resources Development Canada, and the Federation of PEI Municipalities may be found at the end of the profile. A list of all 30 municipal profiles is attached in **Appendix I.**

Interpretation of Census Data

The 1996 Census data were collected either from 100 % of the population or on a sample basis (i.e. from a random sample of one in five households) with the data weighted up to provide estimates for the entire population.

For all census products released, procedures are applied to prevent the possibility of associating statistical data with any identifiable individual. The data are randomly rounded and they are suppressed for certain geographic areas. Random rounding is a method whereby all figures in a tabulation, including totals, are randomly rounded (either up or down) to a multiple of "5" and in some cases "10". This technique provides strong protection against disclosure, without adding significant error to census data.



Municipal Profile: Montague, Prince Edward Island

General Overview

Prince Edward Island is located just off the eastern shore of Canada, in the Gulf of St. Lawrence. It is separated from the mainland by the Northumberland Strait.



The Town of Montague is located in Kings County, on the eastern shore of Prince Edward Island. Montague has a population of 1,995 and covers a land area of 3.0 sq. km.

Montague is part of the federal electoral district of Cardigan, and is in the provincial riding of Montague - Baldwin's Road, Provincial District 3.

Montague was incorporated in 1917. The town is situated along the Montague River, approximately 10 km upstream from Cardigan Bay. Highway Route 4 runs through Montague in a north-south direction. The town is surrounded by woodland and farms.

History

Montague has a long and interesting history. The first European settlement in the area was in 1732, when Jean-Pierre Roma, built a town on Brudenell Point which he named Three Rivers. The settlement was burned and looted by the British in 1745, on their way to attack Louisbourg. Montague was incorporated on April 26, 1917 after a heated public debate.



Population

At the time of the 1996 Census, Montague had a population of 1995 people, an increase of 4.9 % over the 1991 Census.

The distribution of the population across the six age categories above is similar to that of the province as a whole, except the 65+ age group comprises 21 % of the Montague population, compared to 13 % provincial population. Women aged 65 and over outnumber males in this age category two to one.

Language and Ethnic Origin

Mother Tongue

In Montague, 1890 people reported English and 15 people reported French as their mother tongue.

Knowledge of Languages

Knowledge of official languages showed 1795 people knowing English only, and 120 people with a knowledge of both English and French. 15 people reported a knowledge of Flemish.

Ethnic Origin

In Montague, the most frequently reported ancestral group was Scottish. The next most reported group origins were English, Canadian and Irish. Together, these four categories made up approximately 86 % of the responses. Smaller groups reported their ethnic origins as French, North American Indian, German, Welsh, Dutch (Netherlands), American, Belgian, Italian, Polish, Jamaican, Spanish, and Austrian.

Employment Income

The average employment income figures for Montague and PEI are shown in the table below.

The income figures for males and females are averages of full time, part time and part year employment. The average income for males was higher than for females, 24% above the female average. This is consistent with the provincial average income rates and occurs because a higher percentage of females work either on a part year or part time basis.

In addition, one third of all females employed on PEI work in; clerical, sales and services, and childcare and home support worker occupations which are typically the lower paid occupations. The average employment income for workers in Montague was 20% below the average employment income for all persons in PEI. This is a reflection of the number of workers who work either on a part year or part time basis, approximately 59% of all persons with employment income in Montague.

There were 360 persons who worked in full year, full time employment in Montague, approximately 38% of all persons with employment income. The average employment income for this group was \$26,100, which is 13% lower than the provincial average.


The Census family income for 480 families in Montague averaged \$38,486.

Education

Of Montague's working age population, 15 years of age and older, (1550), approximately 41% have less than Grade 12 education, and 58% have a high school diploma or higher. 9% of the working age population have obtained a university degree. Montague residents have similar levels of education compared to the province as a whole.

Approximately 71 % of the males reporting post-secondary qualifications were in the fields of engineering and applied science technologies and trades; commerce, management and business administration; and humanities and related fields. The remainder were spread across six categories ranging from 4 % to 8 %.

Approximately 78 % of the females reporting post-secondary qualifications were in the fields of commerce, management and business administration; educational, recreational and counselling services and health professions, sciences and technologies. The remainder were spread across five categories ranging from 3 % to 6 %.

Labour Force Activity

The census reference week was the week of May 5, 1996. The labour force activity reported refers to the conditions during that week. In P.E.I., May is the month in which seasonal activity is beginning to increase as farmers prepare the land, fishers gear up, construction activity picks up and tourism operators begin to prepare for the coming season. Employment reaches its peak in August and remains high through to and including October.

At the time of the 1996 Census, Montague had a working age population of 1,550 persons and a labour force which numbered 935. The participation rate was 60.3%, which is significantly lower than the provincial rate of 68.3%. This may partly be a result of the higher number of seniors living in Montague. Montague's labour force represents 1% of PEI's total labour force. The labour force was composed of 755 persons who were employed and 185 persons who were unemployed. The unemployment rate during the Census reference week was 19.8%, which is considerably higher than the provincial rate of 13.8%. This is an indication of the higher incidence of seasonal industry in Montague.

Major Industries and Occupations

The Census reported that the members of Montague's labour force were shared between the industrial sectors shown in the table below.

Approximately 44 % of Montague's labour force is in the three industrial categories of "Retail trade industries," "Accommodation, food and beverage service industries," and "Health and social service industries." The remainder is spread over 16 categories with a range of 1 % to 9 % in each category.

Fishing

Landings at Montague were approximately 250,000 kg in 1996, with a value of over \$300,000. These landings were from the inshore fishery, mainly on vessels less than 35 feet in length.

Together, mussels, clams and scallops made up 87 % of the total value of the landings. The value of the landings account for less than one half of one percent of the total value of the landings in PEI.

Agriculture

Agriculture is an important economic activity in and around Montague. Due to confidentiality constraints, agriculture data is not available for the community alone. This area has approximately 1.3% of the total number of farms in PEI and represents approximately 1% of the total

provincial acreage. Total gross farm receipts in the area were approximately 1% of the provincial total.

Four occupational groups make up approximately 64 % of Montague's labour force of 935 people. The remainder is spread over seven occupational groups, ranging from 1 % to 10 % in each group.

Labour Force by Occupation, Males and Females

65% of the male labour force, (480) is associated with one of the following categories:

- Occupations unique to processing, manufacturing and utilities, such as machine operators in manufacturing, 19%
- Trades, transport and equipment operators and related occupations, such as transportation equipment operators and related workers, 18%
- Sales and service occupations, such as occupations in protective services, 14%
- Occupations unique to primary industry, such as fishing and farming occupations, 18%

64% of the female labour force, (460) is associated with one of the following three categories:

- Sales and service occupations, such as cashiers, 34%
- Occupations unique to processing, manufacturing and utilities, such as machine operators in manufacturing, 16%
- Business, finance and administrative occupations, such as clerical occupations, 14%

Transportation and Communication

Transportation

Montague is located on Route 4, which is part of the provincial scenic "Kings Byway Drive" tour. As a result, there is substantial tourist traffic in the summer. There are good connections to the Trans Canada Highway for traffic to and from Charlottetown and the Confederation Bridge. Secondary highways connect to the Wood Islands Ferry Terminal.

The Lower Montague wharf facility is administered by the Department of Fisheries and Oceans (DFO). Services include: fresh water, lights, navigation beacon, diesel, gasoline, 110 volt and 220 volt power, unloading hoist, ramp, and garbage disposal.

Two taxi companies serve the community, and there is a Rotary bus service for seniors. It takes senior citizens shopping, to church, and on outings.

Media

Montague is home to the Eastern Graphic, a weekly newspaper for the Kings County region. Three newsletters are published here: Atlantic Fish Farming, Atlantic Tender Call, and The Island Farmer.

There is also a branch office of the Charlottetown Guardian.

Home Page Design is a local internet publisher.

Housing and Real Estate

The Census reported 815 occupied private dwellings in Montague. The largest group was 445 single-detached houses, followed by a total of 240 apartment units. There were smaller numbers of semi-detached houses, row houses and movable dwellings.

Health Care Facilities

The Kings County Memorial Hospital serves Montague and the surrounding area.

Care for elderly patients is provided at Riverview Manor - (Long Term Care Facility), Fraser Valley Inn Care Facility, MacKinnon-Pines Care Facility and Shady Rest Convalescent Home.

EMS Ambulance Service

There are two medical clinics, three pharmacies, an optometrist, one dispensing optician, two vet clinics, and a physiotherapy clinic.

Regional Services Centre

Many government services are accessible at the Southern Kings and Queens Regional Services Centre, which is located in Montague. The Centre has full-time offices for:

Community Access Program

There are Community Access Program (CAP) sites located in the library, the hospital and at Holland College. Residents can use the computers and access the internet. Other internet access points are at the HRC Resource Centre, and Montague Consolidated School.

Other services are available from many of the community groups, which are listed in another section in this report.

Municipal Services

The Town of Montague provides street lights, snow removal, policing through a contract with the RCMP, a Fire Department, street paving, sidewalk maintenance, ball fields and a park through income generated by property tax.

Water services: Currently, about half of dwellings use the Town's water supply, with the rest obtaining water from private wells.

Sewer services: There is currently a sewage treatment plant located by the wharf. Approximately 730 homes and businesses use this facility.

Tax rates for 1998 are \$0.90 per \$100 of assessed value for commercial properties, and \$0.84 per \$100 for non commercial properties. The annual water rates are \$180.00. Sewer rates are \$110 for service within the municipality, and \$121 for service outside the municipality.

Recreation

There is a wide range of recreation opportunities and facilities in and around Montague. These include:

- Iceland Arena
- Iceland Bowling Lanes
- Montague Curling Club
- Montague Driving Range
- Atlantic Fitness East
- Several ball and soccer fields
- Marina
- Town park with playground.

The Confederation Trail is used for walking, bicycling and snow-mobiling.

Three provincial parks are nearby: Buffaloland, Panmure Island, and Brudenell Provincial Parks.

The "Three Rivers" area streams are among the best on the Island for catching Rainbow trout, in addition to the abundant brook trout. Anglers have several opportunities to fish for brook trout. These include, among others, Woodville Mills Road Pond, the Cardigan River at the causeway, Easton's Pond, the Brudenell River, Dewar (Munn's) Pond, Martin's Pond, Knox's Pond, Valleyfield Stream, the Old Maritime Electric Dam, Thompson's Pond, and the Montague River.

Atlantic Salmon can also be caught in the Valleyfield River, but a fly must be used if the fish is to be retained.

Cultural Facilities and Events

Montague residents can enjoy several annual special events.

Annual events include the PEI Street Rod Association Show N' Shine,

Montague Community Festival, and Canada Day celebrations.

Appendix II

Census Definitions

The following definitions are provided to assist readers in understanding the terminology used in the census data in this report. For further explanation or details please contact the Labour Market Information unit of Human Resource Development Canada.

Average Employment Income of Individuals - is calculated from unrounded data by dividing the aggregate employment income of a specified group of individuals by the number of individuals with employment income in that group. It refers to individuals 15 years and over who reported employment income for the calendar year 1995.

Census Family - refers to:

- 1) a now married couple (with or without never -married sons and /or daughters of either or both spouses), or
- 2) a couple living common-law (with or without never-married sons and/or daughters of either or both spouses), or
- 3) a lone parent of any marital status, with at least one never-married son or daughter living in the same dwelling.

Census reference date - May 14, 1996

Census reference week - The census reference week was the week prior to enumeration.

Employed - includes all persons who worked for pay or in self-employment in the paid labour force in the week prior to enumeration. This includes all persons working for wages or salaries, all self-employed persons (with or with out paid help) working in their own business, farm or professional practice, and all persons working without pay in a family farm or business during the reference week. (The "employed " also includes persons who were absent from their job or business for a variety of reasons.)

Employment income by work activity - refers to total income received by persons 15 years of age and over during the calendar year 1995 as wages and salaries; net income from non-farm unincorporated business and /or professional practice and net farm self-employment income for all jobs held. Included in this is both full time work (i.e. 30 hours or more per week) and part time (less than 30 hours per week) as well as those who worked full year (49- 52 weeks of the year) or part of the year (less than 49 weeks per year).

Ethnic origin - refers to the ethnic or cultural group(s) to which the respondents ancestors belonged. (An ancestor was defined as someone from whom a person is descended and is usually more distant than grandparent). Respondents were asked to specify as many groups as applicable.

Knowledge of Official Languages - refers to the ability to conduct a conversation in English only, in French only, in both English and French or in neither of the official languages of Canada.

Knowledge of Non-official Languages - Refers to languages, other than English or French, in which the respondent can conduct a conversation.

Labour Force - refers to those persons 15 years of age and older, excluding institutional residents who were employed or unemployed during the week (Sunday to Saturday) prior to census day

Mother tongue - refers to the first language learned at home in childhood and still understood by the individual at the time of the census.

Participation rate - refers to the total labour force in the week (Sunday to Saturday) prior to Census day, expressed as a percentage of the population 15 years of age and over, excluding institutional residents.

Unemployed - refers to persons 15 years of age and over, excluding institutional residents, who, during the week (Saturday to Sunday) prior to Census Day, were without paid work and were available for work and either; 1) had actively looked for work in the past four weeks; or 2) were on temporary lay-off and expected to return to their job; or 3) had definite arrangements to start a new job in four weeks or less.

Unemployment rate - refers to the unemployed labour force expressed as a percentage of the total labour force in the week (Sunday to Saturday) prior to Census Day. Data are available for persons 15 years of age and over, excluding institutional residents.

Visible minority - the employment equity act definition was used. It defines Visible minorities as persons (other than Aboriginal Persons) who are non-Caucasian in race or non-white in color.

Working age population - refers to the number of persons in the total population who are 15 years of age and over, excluding institutional residents.
