

# Oil Giveaway Contest Rules

## Eligible Participants

---

The contest is open to residents of Prince Edward Island who have reached the age of majority. Employees and immediate families of employees of the Department of Environment, Energy and Forestry and participating oil providers are not eligible to enter.

There is no purchase necessary for entering this contest. To enter the contest, contestants must have a valid PEI Aboveground Oil Tank ID Tag. Entrants must complete the Official Contest Ballot. All information must be provided; incomplete entries will be disqualified. Only one entry per tag is permitted. Photocopies or facsimiles of the Official Contest Ballot will not be accepted. If an entrant submits more than one ballot, all of that entrant's ballots will be disqualified.

Ballots may be mailed to the Department of Environment, Energy and Forestry, 11 Kent Street, PO Box 2000, Charlottetown, PE C1A 7N8 or dropped off at the following locations: Access PEI sites in Alberton, Charlottetown, Montague, O'Leary, Souris, Summerside, Tignish and Wellington; C&C Fuels in Charlottetown; Co-op Fuels Ltd. in Charlottetown and Tignish; Gordie's Irving in Summerside; Island Petroleum in Charlottetown and Summerside; K&M Home Heating in Charlottetown and Summerside; Kenmac Energy in Charlottetown; MacInnis Fuels Ltd. in Souris; Noonan Petroleum Ltd. in Summerside; Palmer Fuels Inc. in Charlottetown; Pineau's Fuels in North Rustico; Souris Petroleum in Souris; and Ultramar HomEnergy Centres in Charlottetown and Montague.

Winners shall agree to have their name, photograph, voice, likeness, and place of residence used for advertising purposes related to this contest, free of charge.

Personal information on the Official Contest Ballot is collected under Section 31(c) of the *Freedom of Information and Protection of Privacy Act* R.S.P.E.I. 1988, c. F-15.01 as it relates directly to and is necessary for judging the validity of entries in the Oil Giveaway contest and notifying winners, and will be used solely for these purposes. ## Draws

---

There are four draws to be made, and depending when a ballot is submitted, participants could be eligible for all four draws. The draw dates are June 15, July 27, September 14 and October 26. One ballot will be randomly drawn for a prize of \$750 worth of home heating oil (including GST). Ballots will be collected from all the drop-off locations at 4 p.m. two days prior to each draw. The draw will be made at or about 12 noon, Atlantic time, from all entries received as of 4 p.m. two days prior to the draw. Winning entries are subject to verification. The Department of Environment, Energy and Forestry will be responsible for verifying that the winning entry has a valid PEI Aboveground Oil Tank ID Tag.

## **Draws cont.**

Winners will be contacted by telephone during the week following the draw. Winners must comply with the contest rules, and correctly answer a mathematical skill-testing question.

Prize winners must claim their prize within one year of the draw date. The prize may be claimed from any one of the following oil providers: Co-op Fuels Ltd.; Irving Oil Limited; Island Petroleum; K&M Home Heating; Kenmac Energy; MacInnis Fuels Ltd.; Noonan Petroleum Ltd.; Palmer Fuels Inc.; Souris Petroleum; and Ultramar Limited.

## **Substitutions**

The prize shall be accepted as is and has no cash value. Refusal to accept the prize releases the Department of Environment, Energy and Forestry and participating oil providers from any obligation toward the winner.

The Department of Environment, Energy and Forestry reserves the right at its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the contest or to be acting in violation of the contest rules.
