Public hours: Tuesday and Thursdays, from 8:00 a.m. to 11:00 a.m. (except holidays)

Processing fees must be paid at the time of the submission of your application. Except for the *permanent residence* fee, the processing fees are **non-refundable** even if your application is refused. Fees are per person unless indicated otherwise.

Cash payments are not accepted.

- The only forms of **acceptable** payments are: bank draft, international money order or certified cheque.
- Personal cheques, credit cards and corporate cheques are **not** accepted.

Payments made at Canadian Embassy in Addis Ababa:

All payments must be made with the use of a certified bank check (C.P.O.) only (in Ethiopian Birr) made at the Addis Ababa Branch of the Commercial Bank of Ethiopia, and addressed to **The Embassy of Canada, Addis Ababa, Ethiopia**.

Payments sent to the Canadian High Commission in Nairobi for processing:

- Payment in **Canadian Dollars** must be made payable to: **Receiver General for Canada**.
- Payment in **American Dollars** or **Ethiopian Birr** must be made payable to: **Canadian Embassy - (Client's name)**.
- Fees payable in **U.S dollars** should be paid by USD draft cleared on a bank in the United States of America.

Bank charges for returned or rejected drafts will be charged to the applicant.
