# Greencover Canada Land Conversion Application Instruction Sheet

#### APPLICATION DEADLINE: August 1, 2003 (Subsequent Years - January 31)

**IMPORTANT:** Review these instructions carefully when completing your application form. The following instructions correspond to specific parts of the form. For more details, refer to Greencover Canada's Land Conversion Component fact sheet (*Converting Environmentally Sensitive Land to Perennial Cover*) provided with the application form. Additional applications are available on-line or through Greencover Canada (see below).

#### PART A and B - APPLICANT AND CONTACT INFORMATION (To be completed by all applicants)

The Greencover Canada Land Conversion Program is only available to registered landowners (renters or leaseholder are not eligible). The names entered in Part A should be identical to those on the "Certificate of Title", "State of Title Certificate", "Certificate of Possession", "Title of Ownership" or "Deed". To verify land ownership and to prepare a Land Use Agreement, a current copy (front and back) or certified copy of the documents listed above is required. If a current certificate or deed or certified copy of the title of ownership is not available, the applicant should request one from the Land Titles Office or Land Registry Office. If the land is registered under joint ownership, please ensure that all owners' names are provided. If owned by a corporation, enter the corporation's legal name. Provide only one Social Insurance Number (SIN), Business Number (BN), or GST Registration Number. For joint applications, the SIN provided should correspond with the first name listed. Contact information (Part B) refers to the person that can be contacted by the program administration if further information is required. Applications will not be processed until the program administration receives satisfactory proof of land ownership.

#### PART C - AREA APPLIED FOR (All applicants must complete Questions 1, 2, 3 and 4 in Part C)

It is important to provide the legal land location and draw the area to be seeded on the diagram. Complete Question 5 if you are planting tame forages or trees or shrubs, and read the Greencover Canada Forage Selection Guide provided with the application. Complete one application form for each quarter section or parcel of land, and only for land that is to be seeded in the current year. The land to be converted on each quarter section must be at least 40 adjacent acres. The land must have been in annual crop production or summerfallow on **July 1**, **2002**, and be in cultivation at the time of application. When completing the table in Question 5, ensure you include the herbicides used. The residue of some herbicides may adversely affect the establishment of certain forages.

#### PART D - NATIVE SEED PROPOSAL (Complete only if you are seeding native forage)

Complete one native seed proposal for each parcel of land that you plan to seed to native forage species. Additional applications are available on-line or through Greencover Canada (see below). Complete an application form only for land to be seeded in the current year. This proposal must be discussed with, and endorsed by, an Agriculture and Agri-Food Canada (AAFC) designated specialist. A list of specialists is available by contacting 1-866-844-5620.

#### PART E - DECLARATION AND SIGNATURES (To be completed by all applicants)

All registered owners of the land listed on this application must sign this form. No application will be processed unless **each and every applicant**, whose name is recorded in Part A, have printed and signed their names. For corporations, please affix the corporate seal, have an authorized officer sign the application, and identify the corporate position of the signing officer. The instructions for signature by estates, partnerships, Indian Bands, etc. are listed above the signature block on the application form.

Please include your **Farm Land Assessment Form** so we can determine the soil quality rating used to prepare an overall assessment of your application. This form can be obtained from your County Office, Municipal District Office, or Special Area Office.
