



Reimbursement for the Purchase of Canadian Radio Frequency Identification (CRFID) Reader Program Application Guide for 2005/06

To ensure that your **Canadian Radio Frequency Identification (CRFID) Reader Program Application Form** is complete and contains the information required to fully consider your application please refer to the instructions below.

Approval of Applications will be based on the applicant eligibility, mandatory CRFID Reader and reader requirements as contained in the CRFID Reader Program eligibility criteria.

PART A - APPLICANT INFORMATION

Ensure the following is complete and included:

- Proof of Purchase including the manufacturer and model number
- Provide the CCIA PIN number or ATQ Stakeholder and premise ID numbers.
- Provide a written statement from the vendor for purchases of more than one reader (refer to CRFID Eligibility Criteria paragraph 2.1 for applicant eligibility)
- Applicant name, mailing address and telephone number(s), Business Number and GST Number.

PART B - STAKEHOLDER INFORMATION

1. Provide the following with your completed application:

- a CCIA PIN number or
- an ATQ Stakeholder number and Premise ID

2. The CRFID Reader Program applies to Cattle only. Estimate the maximum number of cattle to be read per annum.

Example: Cattle - quantity 80 head
