I, the undersigned Official Veterinarian, duly authorized by the Government of Canada, hereby certify that, after due enquiry and to the best of my knowledge and belief, the birds described below meet the following requirements:

1. The birds shall be raised for 6 months prior to export or since hatching in farms which are under the supervision and regular inspection by the animal quarantine authority (CFIA) of the Canada.
2. Newcastle disease, pullorum disease and fowl cholera have not occurred in the farm in the previous year: and avian influenza (H5 and H7 subtype), psittacosis and infectious coryza have not occurred in the farm of origin for the past 6 months.
3. The birds were detained for pre-export quarantine in a mosquito-proof facility for 21 days under the supervision of CFIA. During pre-export quarantine, the birds shall be inspected and found free from clinical evidence of any communicable disease and subjected to the following tests at a CFIA approved laboratory with negative results. A minimum of 20 samples should be taken from each consignment. In the case where consignments are less than 20, all birds must be tested. \_\_\_\_\_ Dates of quarantine

Test methods should follow the Manual of Diagnostic Tests and Vaccines for Terrestrial Animals of the OIE.

4. The birds shall not be vaccinated with vaccines against avian influenza.
5. Within forty-eight (48) hours prior to shipment, the birds were inspected by an official veterinarian and found free of clinical signs of communicable diseases and were transported to the nearest port without contacting any other bird.
6. The birds shall be shipped in clean, disinfected and sealed containers, and shall not be transhipped through a country or zone where HPAI is know to occur. No additional feed, beddings, and poultry or bird shall be loaded during the journey.
