What's new?

Higher Payments – In July 2006, the maximum CCTB amount that an individual can receive has increased. This includes increases to the basic benefit, the National Child Benefit Supplement (NCBS) and the Child Disability Benefit (CDB).

New Payment period – CCTB payments for this new period will be paid monthly from July 2006 to June 2007 and are calculated using your 2005 family's net income.

Important

To receive the CCTB, you AND your spouse or common-law partner **must file an income tax return every year**, even if you have no income to report. If you haven't done so yet, both of you must file the *2005 Income Tax and Benefit Return* as soon as possible to make sure you don't miss any payments.

Check your notice carefully

The enclosed notice shows you the information we use to calculate your CCTB payments.

Please make sure our information is correct. Check your notice for the following:

- your address;
- the names and birthdays of all eligible children;
- your marital status;
- the province or territory where you live, and
- your 2005 family net income.

If any of the information is wrong or if it changes at any time during the year, contact us **right away**. That way, you will receive the exact amount you are entitled to.
