

EXPORT SWINE TO NICARAGUA

ADE	ORTER ORESS e undersigned, an official veterinarian of the Government of Canada, certify that: Canada is free of foot and mouth disease, African swine fever, porcine infectious encephalomyelitis (Teschen disease), swine vesicular disease and classical swine fever. The swine were born or raised in Canada or if legally imported from another country have been resident in Canada for at least three (3) months. The farm of origin from which the animals were shipped has not been subject to official health restrictions during the six (6) months prior to the date of shipment. The herd of origin is free of brucellosis and Aujeszky's disease.

4.	The herd of origin is free of brucellosis and Aujeszky's disease.			
5.	The swine for export were kept in isolation from other animals not being exported under official supervision for a period of not less than thirty (30) days prior to export.			
6.	During the thirty (30) days prior to export, the animals were tested for transmissible gastroenteritis with negative results with the use of the serum neutralization test and, as required, the competitive ELISA to differentiate from porcine respiratory coronavirus.

7.	The swine originate from farms where no clinical case of porcine reproductive and respiratory syndrome (PRRS) has been seen during the previous three (3) months, and which have not introduced swine from farms where PRRS has been identified during the previous thirty (30) days.			
8.	The swine for export received no immunogen in the fourteen (14) days prior to the date of export.			
9.	Within seventy-two (72) hours of export, the swine were treated against leptospirosis through the administration of 25 mg of streptomycin per kg of live body weight.

10.	Within the fifteen (15) days prior to export, the swine for export were treated with products authorized by the country of origin against Endo and ectoparasites.

- 11. The swine were examined at the time of loading by an official veterinarian and showed no signs of tumours, fresh wounds or wounds in the process of healing, nor any signs of infectious, contagious or transmissible disease, nor the presence of ectoparasites.

The swine were transported directly from the place of isolation to the place of loading, in clean, disinfected vehicles, and had no contact with other animals, except those having the same health status and were exported in containers or aircraft that were new or had been cleaned and disinfected.
