

Annex 4.1: Services Coverage for the WTO-AGP Defined by the Common Classification System

The World Trade Organization Agreement on Government Procurement (WTO-AGP) services coverage is contained in [Annex 4](#) of the WTO-AGP and is defined in terms of the United Nations Central Product Classification (CPC). To ensure a consistent application of services coverage by Public Works and Government Services Canada contracting officers, the WTO-AGP list of covered services has been translated into the North American Free Trade Agreement Common Classification System (CCS). The CCS list is an exhaustive list of services covered by the WTO-AGP and is provided below. The list also identifies the corresponding CPC system codes.
