been able to fund more and more research teams in areas of shared strategic importance spanning a wide range of health challenges. Partnerships have also helped provide a united and strong voice to stress the need for continued investments in health research.

Successful partnerships grow and flourish in an environment of trust and open communication. The purpose of this new publication is to provide even more focus on communications, providing timely news to keep everyone informed of new developments at CIHR.

INTERNATIONAL REVIEW OF CIHR

In early 2006, CIHR assembled a 27-member International Review Panel to review CIHR's mandate and performance. Chaired by Dr. John Bell, Regius Professor of Medicine at Oxford University, the Panel met with more than 100 young and well-established investigators, university and government leaders, partners in industry, the health charities and the provinces, and CIHR management and staff. In their Report to Governing Council, the Panel applauds CIHR for what has been accomplished to date, noting that Canada is setting an example to the world. The Report also includes, at an appropriately high level, important observations on the future directions CIHR might consider in the next stage of its evolution. RESEARCH NEWS

• The Small Health Organization Partnership Program (SHOPP) is a program designed to foster partnership opportunities with small health charities and not-for-profit organizations with modest health research funding (under \$250K per year) by co-funding training and salary awards. We are currently partnering with 17 organizations to co-fund Doctoral Research Awards, Fellowships and New Investigator Salary Awards. - CIHR has introduced new stipend levels for Salary Awards (i.e. New Investigator, Clinician Scientist Phase Two and Mid Career awards). The stipend level has been increased to \$60,000 including fringe benefits and will take effect beginning with the September 2006 competitions. The reason for this change is to ease the administrative burden of paying the fringe benefits. For example, in many cases, reconciliations to resolve fringe benefits were done late, with the result that funding payouts overlapped several fiscal years. Administrative Changes to

Transfer Payments: The Finance Branch has implemented a plan to phase out collaborative agreements with third-party delivery as a method of payment as this process does not comply with the Treasury Board Policy on Transfer Payments. This method of payment was removed as an option for all new collaborative agreements as well as for agreements that were up for renewal or revision. Currently, there are several agreements still in place that use third-party delivery. Finance will be working with the partners to transition these agreements by March 31, 2007.

CIHR Budget 2006-07:

CIHR received \$17 million in new funding in the May 2 federal budget, which represents a 2.4% increase. CIHR was also awarded \$21.5 million over five years to fund research into pandemic preparedness. Despite the budget increase, CIHR's uncommitted funds for 2006-07 were still lower than in recent years. As a result, CIHR was obliged to make some changes in its 2006-07 budget. These changes were made after extensive consultations with the program directors and Scientific Directors and the revised budget was approved by Governing Council in June 2006. In making these decisions, management made a conscious effort to not reduce/delay programs which were partnered. As such, it is expected that the impact on partnered initiatives will be negligible.
