Overview

This action plan addresses the recommendation of the audit on the *Recommendations of the Brooke Claxton Coroner's Jury* and provides an update and comments on RPS commitments relating to construction safety with regards to the coroner's Jury recommendations of the Brooke Claxton incident made in 1997.

Recommendation

1. The ADM, RPS establish and communicate a management control framework including clear accountabilities, roles and responsibilities, in support of planning, implementing and reporting on the Departmental commitments relating to construction safety in general and the Coroner's Jury recommendations in particular.

The Management Control Framework (MCF) has been developed to address the broad spectrum of Safety and Health activities in RPS and PWGSC and a specific piece relates to construction safety. Included in this MCF are: concise roles, responsibilities and a reporting/monitoring framework. Policy directives on the application of these accountabilities are provided in DM directive 073. Reporting and monitoring to the ADM on health and safety issues in general and specifically on the implementation of this Action Plan will be done semi annually. RPS is developing codes of practice which will operationalize best practices.
