Preface

Canada's co-operative's play a vital role in the Canadian economy. They provide essential goods and services to a significant portion of the Canadian population in areas such as retail, agriculture, manufacturing, housing and health care. This publication presents an overview of the co-operative system in Canada to a wide and diverse audience.

Data on non-financial co-operatives are presented by activity and by area of incorporation (provincial/territorial/federal). Data on Credit unions and *caisses populaires* are presented by province.

Methodology

The statistics used in this publication are based on various sources:

- Reporting by non-financial co-operatives to the "Canadian Annual Survey of Co-operatives" undertaken by the Co-operatives Secretariat
- Similar information to our survey collected by provincial/territorial governments and Industry Canada as well as non-financial data such as incorporations, dissolutions, name changes and amalgamations
- In the case of financial co-operatives, data is extracted from Credit Union Central of Canada (CUCC) website and Statistics Canada
- Some estimations are used in cases of non-reporting where it is established that the co-operative is still actively operating

CO-OPERATIVES IN CANADA

SITUATION - 2002

The 2002 statistics are based on data received from 5,719 non-financial co-operatives representing 5.1 million members, \$26.1 billion in total revenues and \$16.8 billion in assets. These co-operatives employed over 83,000 people of which 75 percent were full-time employees. This includes data provided by wholesale co-operatives and federations. Of these co-operatives, 971 are agricultural, and represent over 386,000 active memberships and employ over 35,000 individuals with total revenues of \$14.5 billion and assets of \$5.7 billion.

The number of non-financial co-operatives reporting was up 0.7 per cent from 2001 and membership was up 0.8 per cent. Volume of business, assets and number of employees were down 11.0 per cent, 5.9 per cent and 3.9 per cent respectively. These downturns were predominately caused in the agricultural sector by the conversion to a private company of Agricore, a major player in the grains and oilseeds sector and also a downturn generally in the grains and oilseeds sector in the West caused by a severe drought combined with a substantial drop in agri-product sales.

The number of agricultural co-operatives reporting was virtually unchanged down 0.1 per cent and active memberships were down 9.7 per cent. Agricultural volume of business and assets were down 19.2 per cent and 19.3 per cent respectively. The total number of employees of agricultural co-operatives was also lower by 8.5 per cent.

PRODUCER CO-OPERATIVES

Co-operatives play a crucial role in the agricultural sector of the Canadian economy, especially in farm supply and in the processing and marketing of grains and oilseeds, dairy products, poultry, fruits, vegetables, livestock, honey and maple products.

Agricultural marketing co-operatives are, for the most part, modern enterprises that use the latest technology and are involved in processing and value added. A few large co-operatives make up the largest part of total revenues including Agropur in dairy, Saskatchewan Wheat Pool in grains and oilseeds, Lilydale in poultry and Coopérative Fédérée de Québec in meat and poultry processing. The 156 marketing co-operatives reporting represent a major economic force with a combined business volume of more than \$10.6 billion and assets of \$3.8 billion. In 2002, they marketed nearly \$8.3 billion in agricultural products in Canada and abroad (see Table 4).

Market share of agricultural marketing

co-operatives is strongest in three areas, poultry and eggs 52 per cent and dairy 42 per cent and grains and oilseeds 30 per cent (see Appendix F).

In **farm supply**, co-operatives play an indispensable role in the provision of farm inputs. They provide member co-operatives and producers with a broad range of farm inputs including fertilizers and chemicals, animal feed, seed, building materials and farm and consumer petroleum products. The 232 supply co-operatives reported total revenues of \$3.8 billion, up 4.8 per cent from 2001. In farm supply the strongest areas are farm petroleum 43 per cent, fertilizers and chemicals 23 per cent, and feed supplies 13 per cent (see Appendix F).

Nine of the top ten agricultural co-operatives in Canada are marketing organizations and one supply co-operative rounds out the Top 10 (see Appendix I).

There were 62 **fishery co-operatives** responding to the survey, two more than in 2001. They reported \$262.7 million in revenues, a 13.1 per cent increase over 2001. Assets increased 2.5 per

cent to \$95.6 million (see Tables 10 and 11).

Production co-operatives include **feeder, grazing, agricultural machinery, animal reproduction, forestry and handicraft** co-operatives. The 609 production co-operatives responding to the survey reported a combined volume of business of \$551.2 million. Production co-operatives in Québec accounted for 70 per cent of the total volume of business. Québec revenues were derived primarily from the sale of forest products. Saskatchewan has the largest number of production co-operatives, with 209 organizations reporting. Management of feeder finance operations and grazing operations were the two main activities of production co-operatives, with 160 and 151 enterprises respectively, accounting for 51 per cent of all production co-operatives (see Tables 12 and 13 and Appendix B).

CONSUMER CO-OPERATIVES

At the local level, **consumer co-operatives** vary in size and sophistication, from small buying clubs, to large supermarket organizations and wholesalers. At these “conventional stores”, sales are made in the usual manner and any “surplus” is returned at year’s end based on patronage (the purchases of each member at their co-operative). Revenues from the consumer group amounted to \$9.2 billion, with food products accounting for 46 per cent of the total. Petroleum products, dry goods and home hardware were the other main items sold (see Table 6).

The 300 member co-operatives of Federated Co-operatives Limited and 34 associate members had total revenues of \$3.3 billion, giving them the strongest presence in any region in Canada and placing them first by revenues of all non-financial co-operatives. Calgary Co-op Association Ltd. is the largest consumer retail co-operative in North America, with nearly 40 per cent of the local retail market. Their sales include food products, hardware, clothing, home furnishings, pharmaceuticals, petroleum products and building materials, as well as providing travel services. Mountain Equipment Co-op (MEC), headquartered in Vancouver, British Columbia, specializes in the sale of equipment for outdoor activities. It provides a catalogue sales service and operates eight stores outside British Columbia, in Toronto,

Ottawa, Calgary, Edmonton, Québec, Montréal and in Halifax. MEC has nearly 1.8 million members across Canada.

The 103 member co-operatives of Co-op Atlantic had revenues of \$508 million. Twenty-six former member co-ops of Co-op Atlantic have formed a new federally registered co-operative, Consumers Community Co-operative (CCC). These and other major changes introduced in 2001 will continue to consolidate and strengthen local member ownership within the consumer co-operative network in Atlantic Canada.

Although not as large or influential, Québec and Ontario consumer co-operatives are strong organizations, however, they have little penetration in large urban areas.

A diminishing number of consumer co-operatives operate as “**direct charge**” co-operatives. In 2002, 20 of these co-ops reported to the survey, most of them located in Québec and New Brunswick. They reported revenues of \$131 million with 20,610 members. The concept of the “direct charge” system is that goods are provided to members at cost and a weekly service fee is charged to cover operating costs. Some add a surcharge to build capital for the development of the co-operative. In the past year a number of these type in the Atlantic region have amalgamated into the “basics” store concept under the Consumers Community Co-operative.

Student supply co-operatives have gained a strong foothold, especially in Québec, where 86 are active. These co-operatives reported a volume of business of nearly \$130.2 million with over 457,000 members. They provide the various goods students may require, from stationery to textbooks. Several student supply co-operatives operate cafeterias and offer driver education courses (see Appendix A).

Service co-operatives make up the largest number of co-operatives in Canada and 4,135 responded to the survey, accounting for 72 per cent of all non-financial co-operatives. They reported a volume of business of \$1.7 billion, up slightly from 2001.

The largest single area of co-operative activity in the service sector is **housing** where 2,156

co-operatives reported with assets of \$5.7 billion and 112,052 members. There are other types of co-operatives involved in housing activities and 66 of these other housing co-operatives reported to the survey. Most of them are co-operative housing resource groups involved with development of emerging housing co-operatives. The concept of equity housing co-operatives which are involved with the management of common assets, exists only in British Columbia as of 2002 (see Appendix C).

There are two types of **child care co-operatives**: **daycare** and **nursery school**. Daycare co-operatives are formed by parents to provide daytime care for their children while they are at work. Nursery school co-operatives are formed with an emphasis on education and social interaction but also provide the parents with time for other pursuits. Child care co-operatives are found in greatest numbers in Ontario, Saskatchewan and Manitoba. There are 397 daycare and nursery school co-operatives reporting revenues of \$58.6 million with 31,481 members.

Health care co-operatives play an important role in a number of communities across Canada and 85 health care co-operatives reported to the survey with 58,930 members and revenues of \$121.8 million. **Home care co-ops** are found mostly in Québec where many incorporations of this type have taken place in the past few years and 46 reported for the 2002 survey. Home care co-ops provide care to mostly elderly people in their homes.

Community development co-operatives foster local leadership skills and grassroots participation in innovation and solving social and economic problems. While these co-operatives are found throughout Canada most are in Saskatchewan. There were 268 development co-operatives reporting with 17,585 members, assets of \$38.6 million and revenues of \$37.9 million, an increase of over 24 per cent.

Funeral co-operatives are located mostly in Québec, although they have made some in-roads in the Maritimes particularly in Prince Edward Island and New Brunswick. Fifty-six funeral co-operatives reported assets of \$107 million.

Water supply co-operatives are found mainly in

Alberta, Manitoba and Québec and 180 responded to the survey with 6,560 members and \$7.9 million and \$58.9 million in revenues and assets respectively.

Natural gas and rural electric co-operatives are found almost exclusively in Alberta where 139 of these co-operatives reported to the survey. However, Canada wide 145 of these co-operatives reported memberships of 157,351 and assets of \$485.9 million and revenues of \$242.9 million.

Although **recreational co-operatives** are found in most provinces, they are most prevalent in the West, particularly in Saskatchewan. The 286 recreational co-operatives reporting were engaged in various activities, including the management of community centres, skating and curling rinks, golf courses, campgrounds and swimming pools.

A number of **transportation and communication co-operatives** are found throughout Canada. Of the 66 transportation co-ops reporting most were freight co-ops and taxi co-ops. They had revenues of \$62.6 million and assets of \$40.1 million. Recently car-sharing co-operatives have been formed in large urban centres including Vancouver and Toronto, supplying their members with shared vehicles on a needs basis and saving members the high costs of owning an automobile (\$9,000 average per year), reducing congestion and in turn reducing pollution. Most of the 77 communication co-ops reporting were of the radio TV/cable and editing and publishing type. They reported 65,592 members, revenues of \$86.3 million and assets of \$115.4 million (for other service co-operatives see Appendix C).

WORKERS' CO-OPERATIVES

Workers' co-operatives are employee owned and most of these are located in the province of Québec. Canada wide, 305 reported with a total of 18,732 members and revenues of \$554 million, assets of \$328 million and 9,498 employees. These co-operatives operate in a wide variety of fields, including **forestry co-operatives** which accounted for 57 per cent of the overall volume of business of workers' co-operatives in Canada, a total of \$188.1 million (see Appendix D).

The *Coop des inséminateurs du Québec* (The Québec Artificial Insemination Co-operative)

generated the most revenues among non-forestry workers' co-operatives in Canada.

In recent years, a new type of workers' co-operative has been developed in Québec, the **worker/shareholder co-operative**. Employees can form a co-operative to buy shares in an existing business. This enables them to have a voice at the board of directors level. Ninety-nine of these co-operatives are now active in Québec. The increasing interest in workers' co-operatives reflects the shortage of jobs and the determination of educated and informed people in having more control over their jobs and, consequently, their lives and communities.

Another type of co-operative gaining in popularity in Québec is, the **multi-stakeholder** or **solidarity co-operative**. Membership is made up of different categories of partners: service users, employees and community organizations. Almost non-existent a few years ago, 176 multi-stakeholder co-operatives were incorporated in Québec by 2002. Many provide home care services to seniors and people with minor health problems.

FINANCIAL CO-OPERATIVES

CREDIT UNIONS AND CAISSES POPULAIRES

Credit unions and **caisses populaires** are in all the provinces. They reported assets of \$140.8 billion, an increase of 7.7 per cent over 2001. Québec accounts for 47.7 per cent of this figure (see appendices G and H).

INSURANCE AND OTHER FINANCIAL CO-OPERATIVES

Insurance co-operatives rank with the largest companies of their type in Canada. Eight co-operative insurance companies have nearly \$19 billion in assets and provide service to 10 million policy holders.

Two **trust co-operatives** existed in Canada in 2002 and they administered over \$157.4 billion in assets.

Figure 1: Number and Membership of Non-Financial Co-operatives, 1998-2002

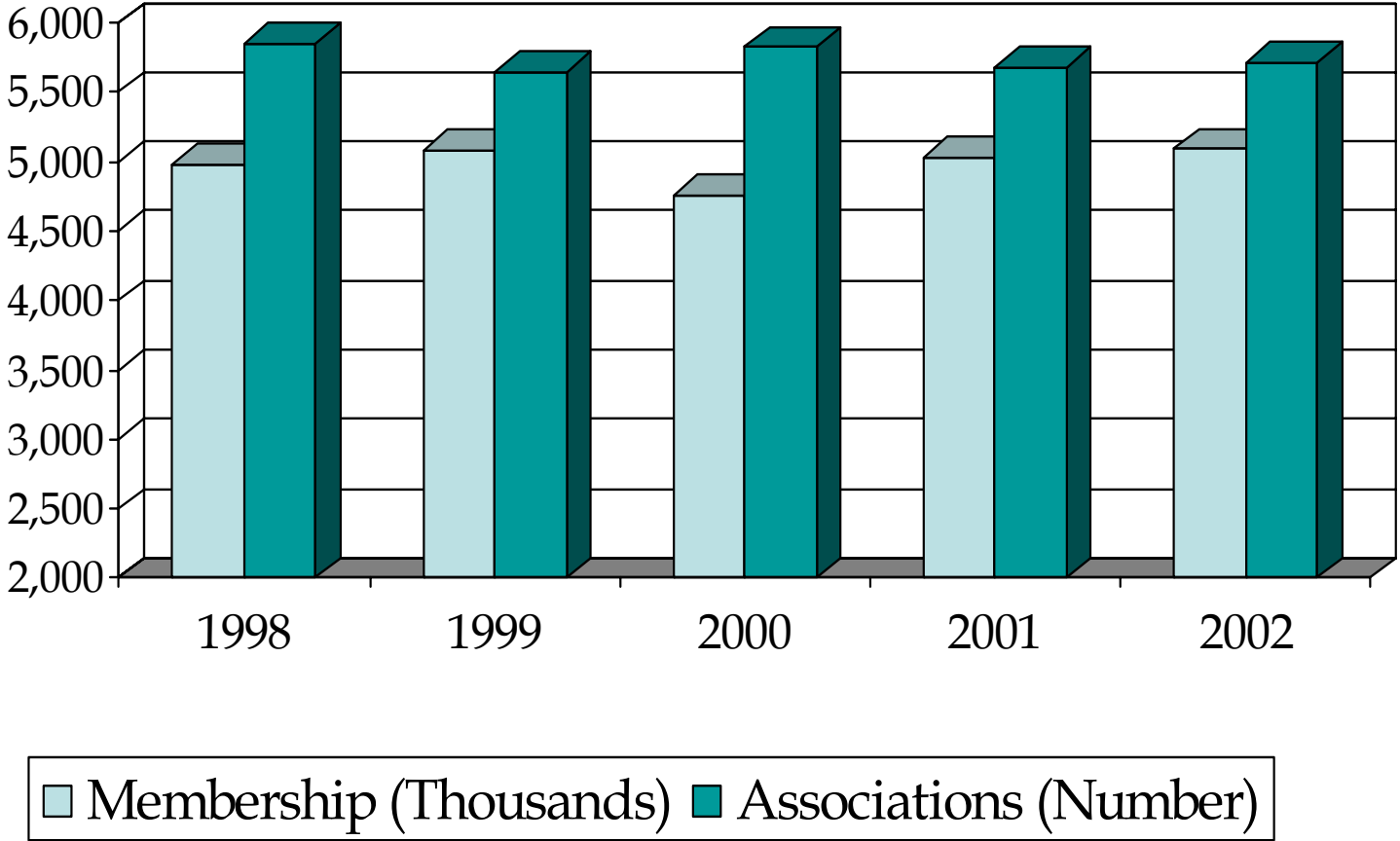


Figure 2: Volume of Business and Assets of Non-Financial Co-operatives, 1998-2002

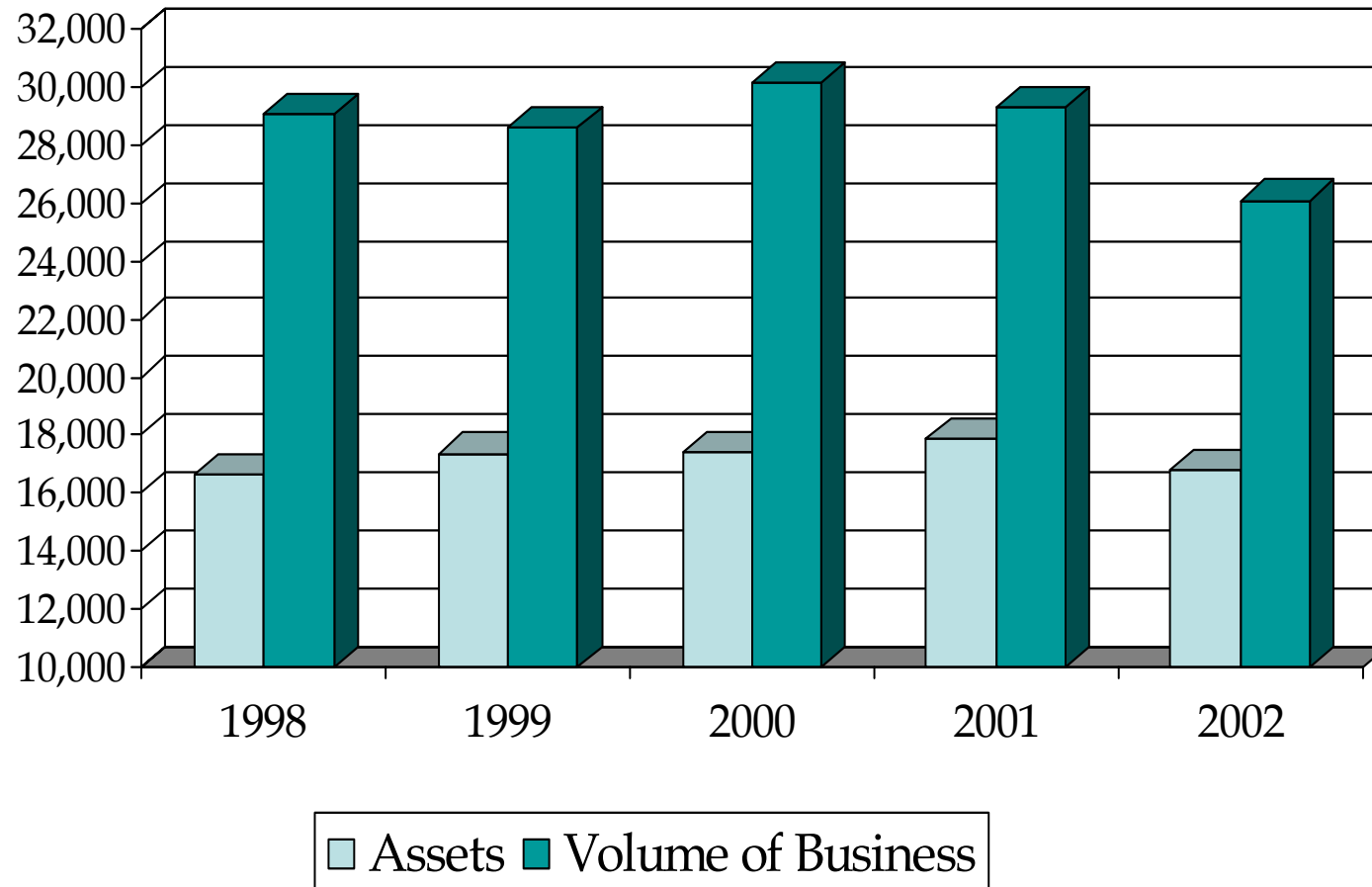
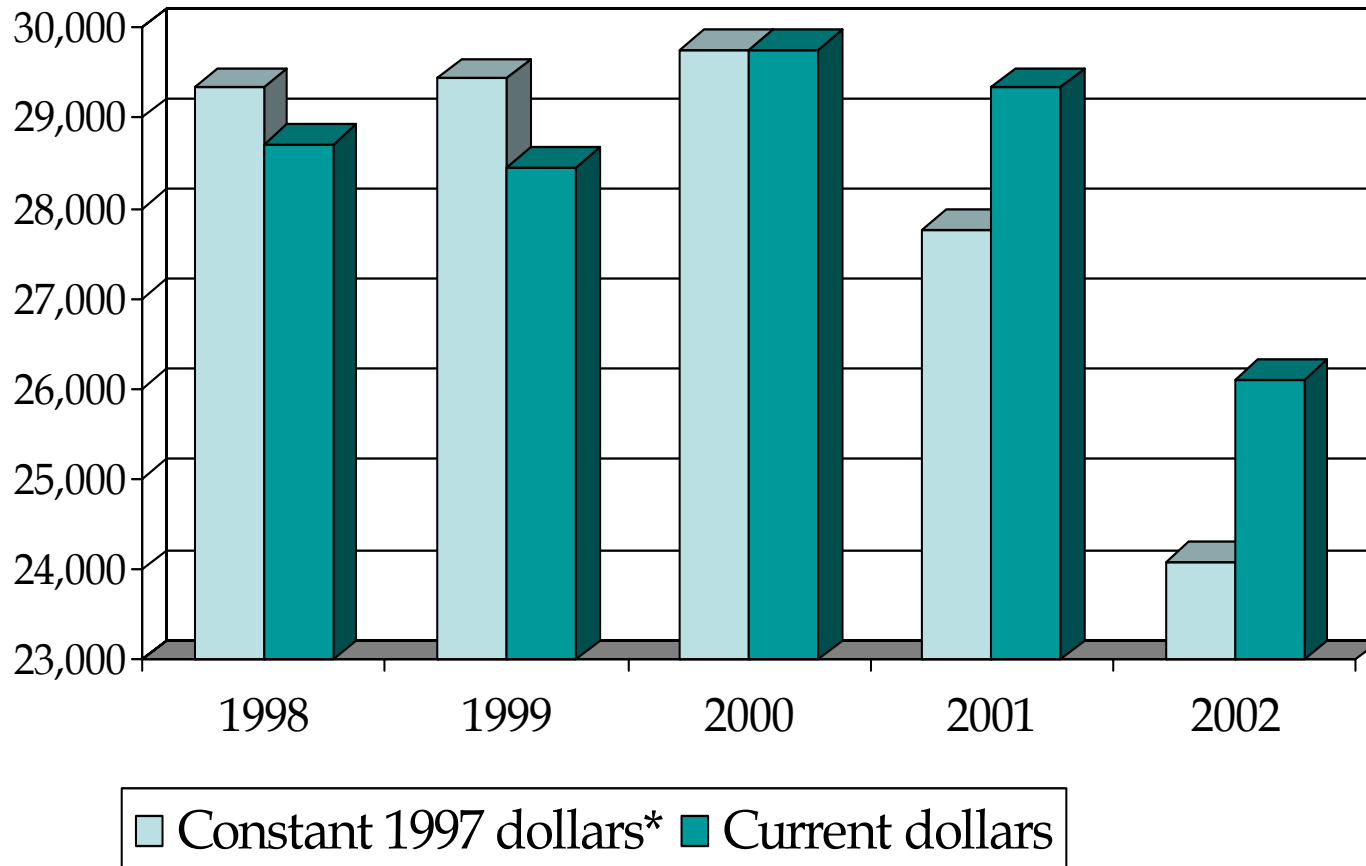


Figure 3: Volume of Business of Non-Financial Co-operatives, 1998-2002

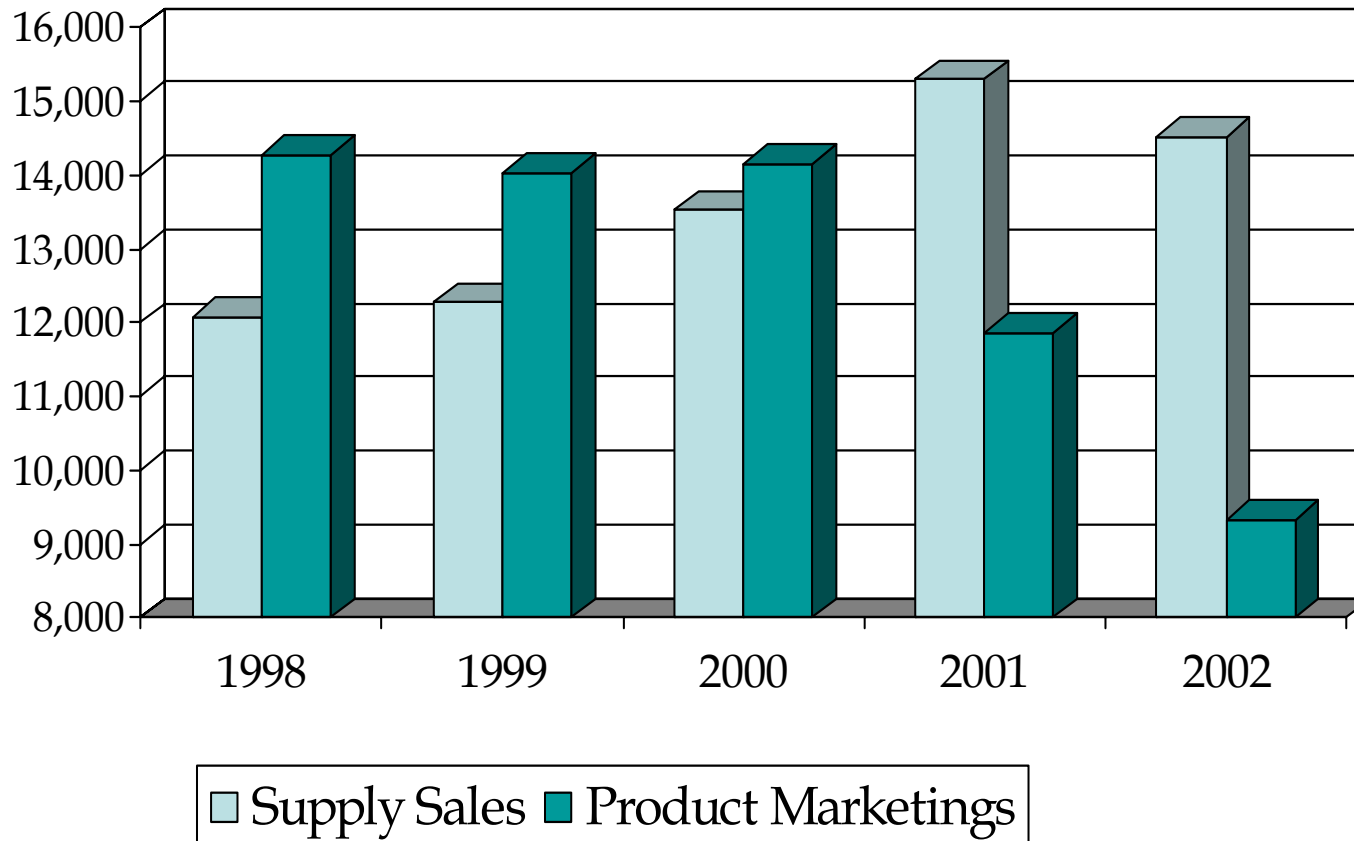


Figure 5: Products Marketed as a Percentage of Total Marketings by Non-Financial Co-operatives, 1998-2002

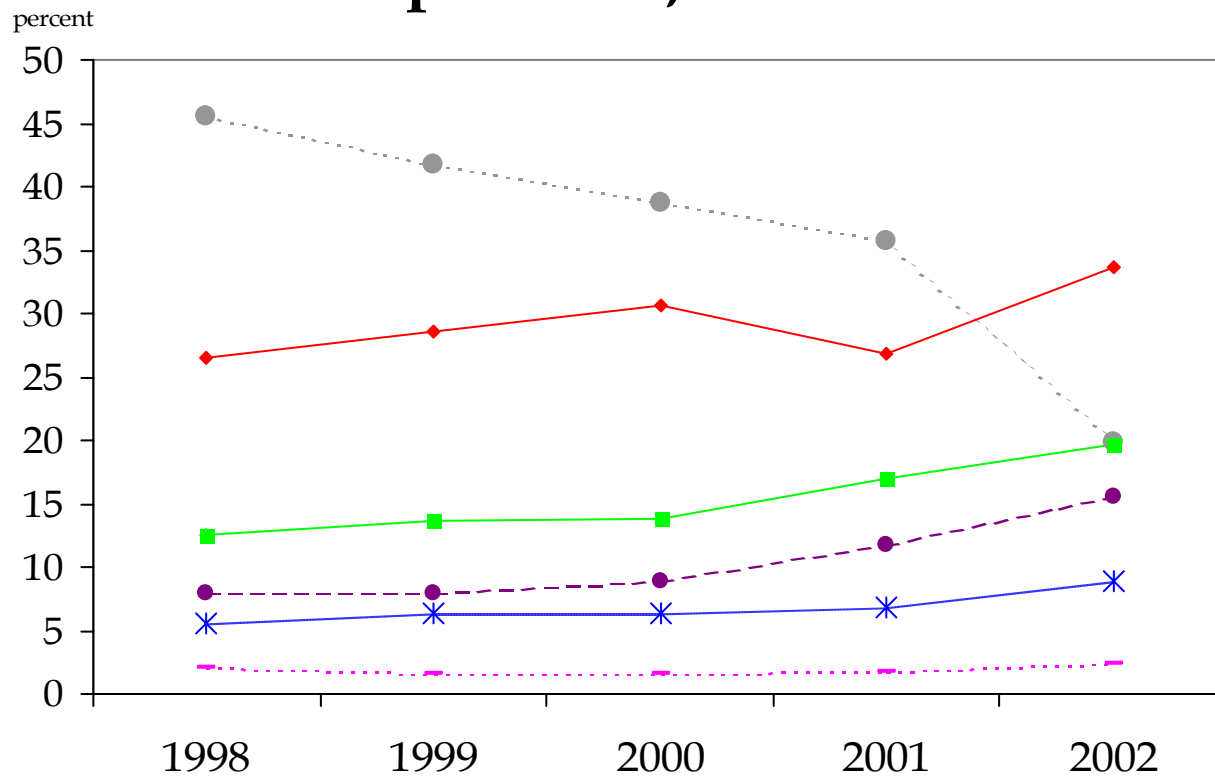
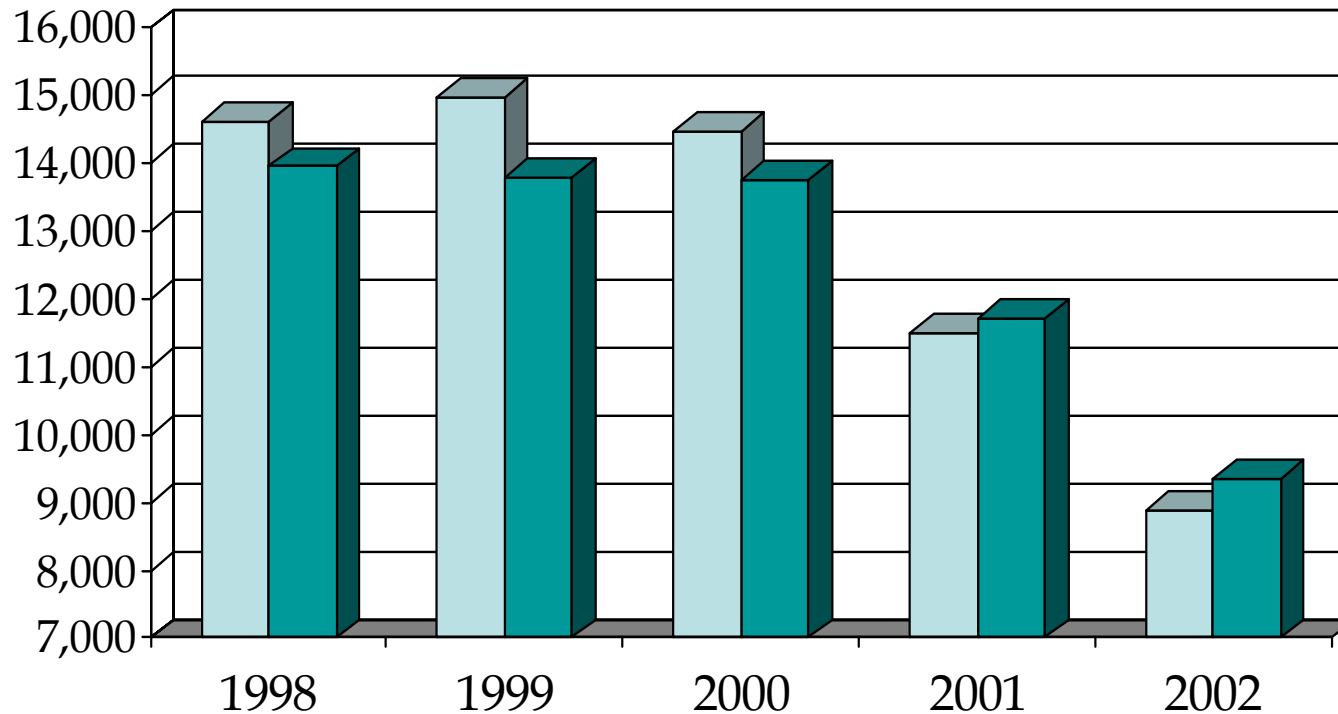


Figure 6: Product Marketings of Non-Financial Co-operatives, 1998-2002

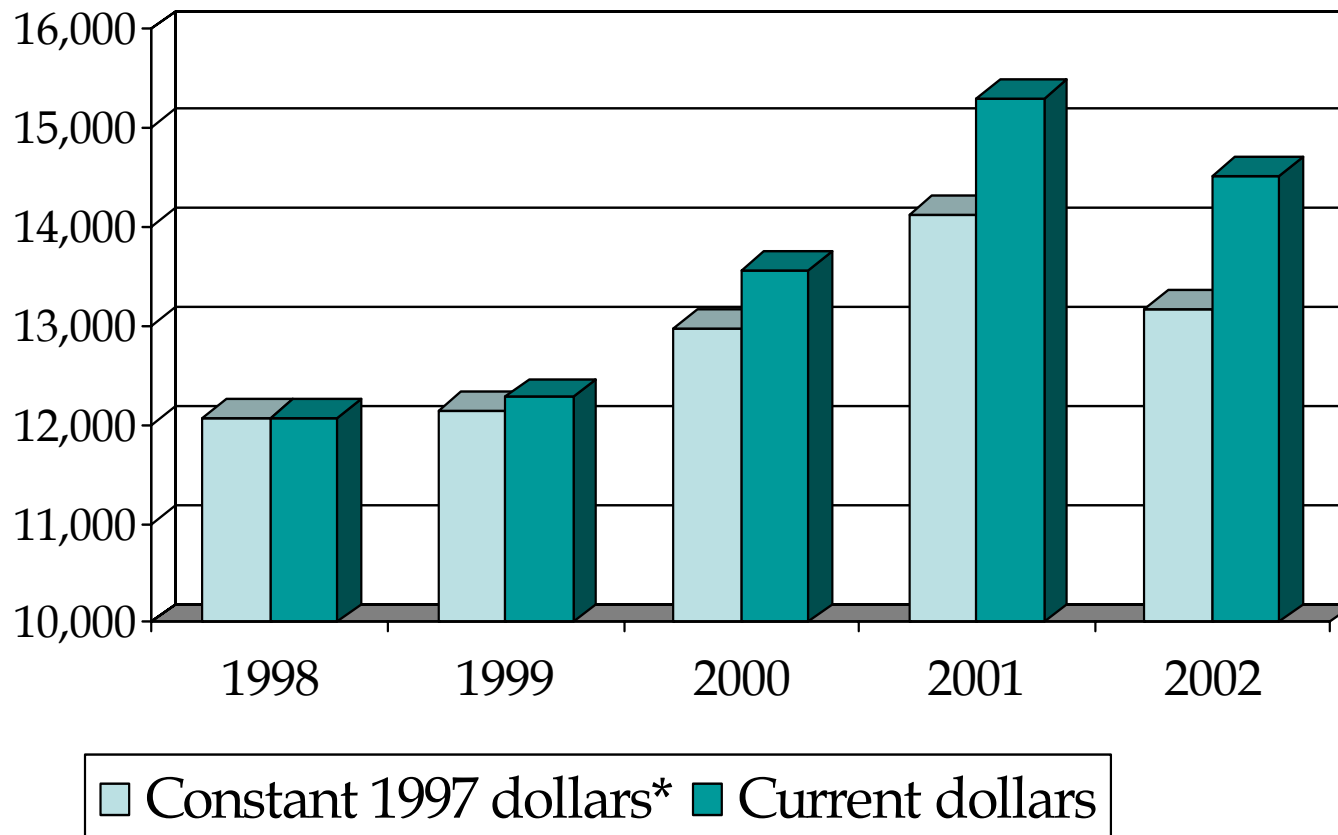

Figure 7: Consumer and Supply Sales of Non-Financial Co-operatives, 1998-2002

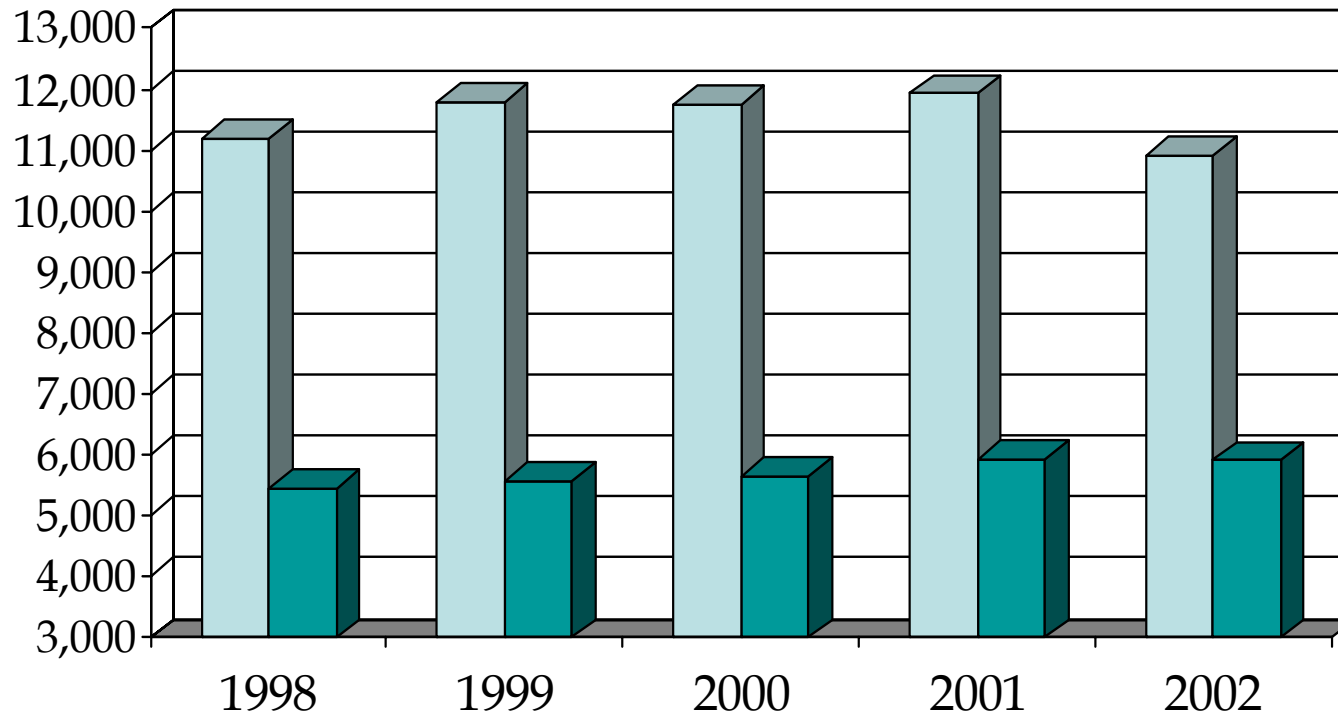

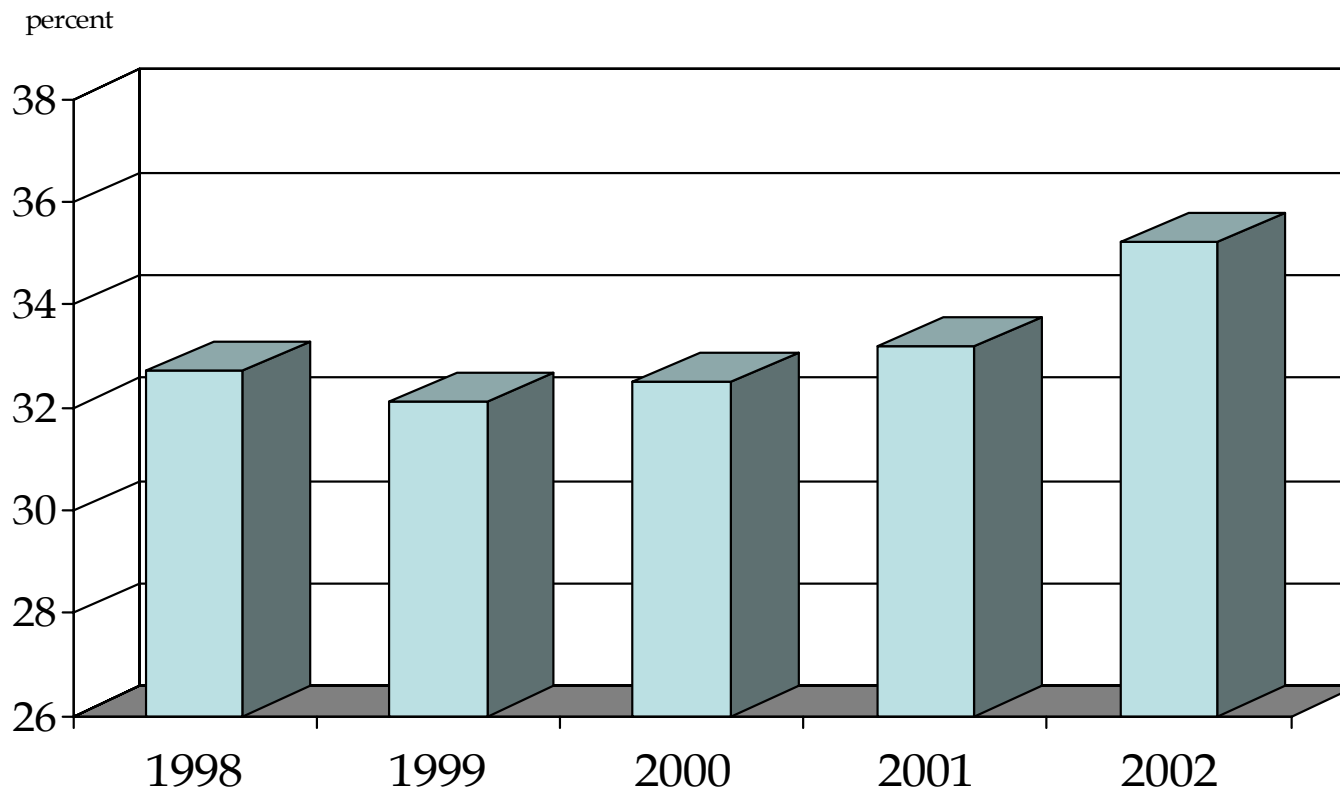
Figure 8: Liabilities and Members' Equity of Non-Financial Co-operatives, 1998-2002

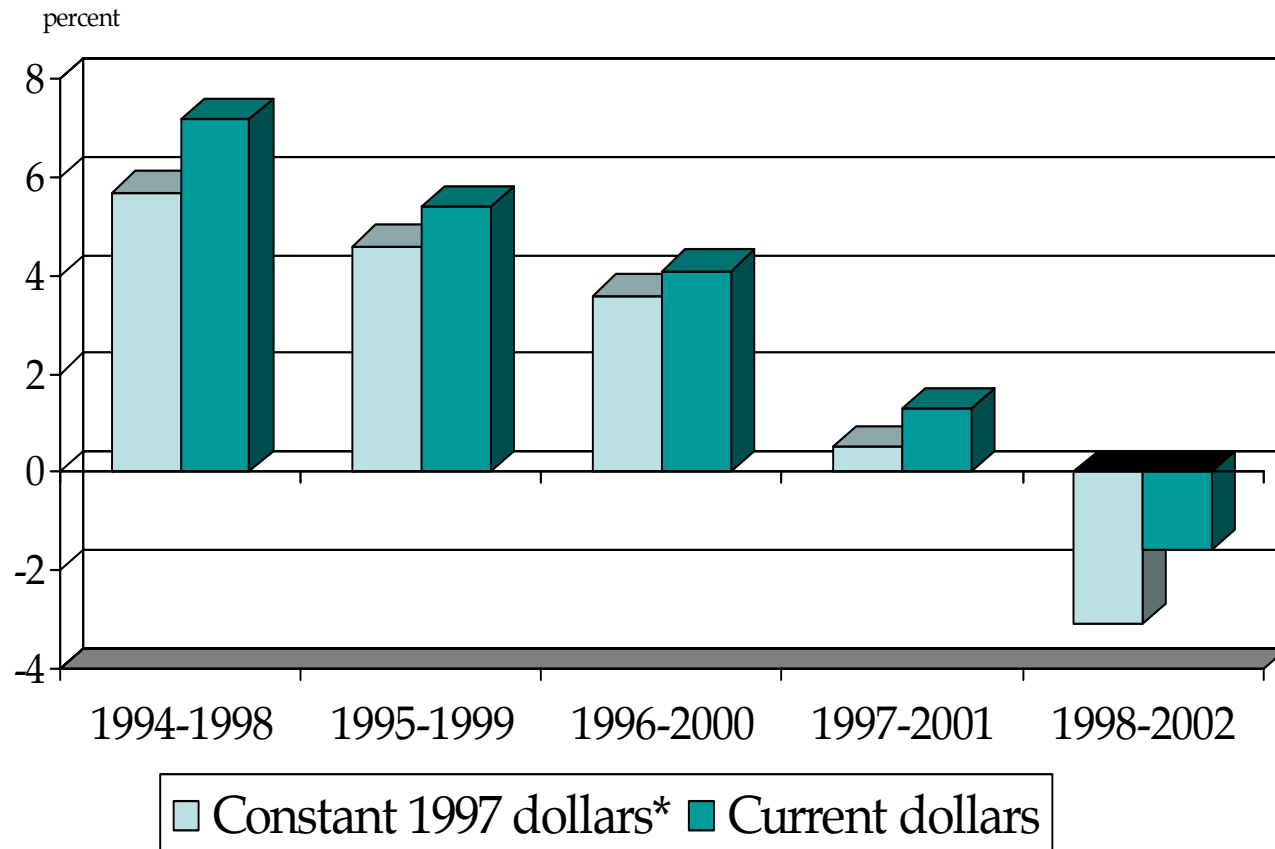
Figure 9: Members' Equity as a Percentage of Total Assets of Non-Financial Co-operatives, 1998-2002

Non-Financial Co-operatives, 1994-2002***

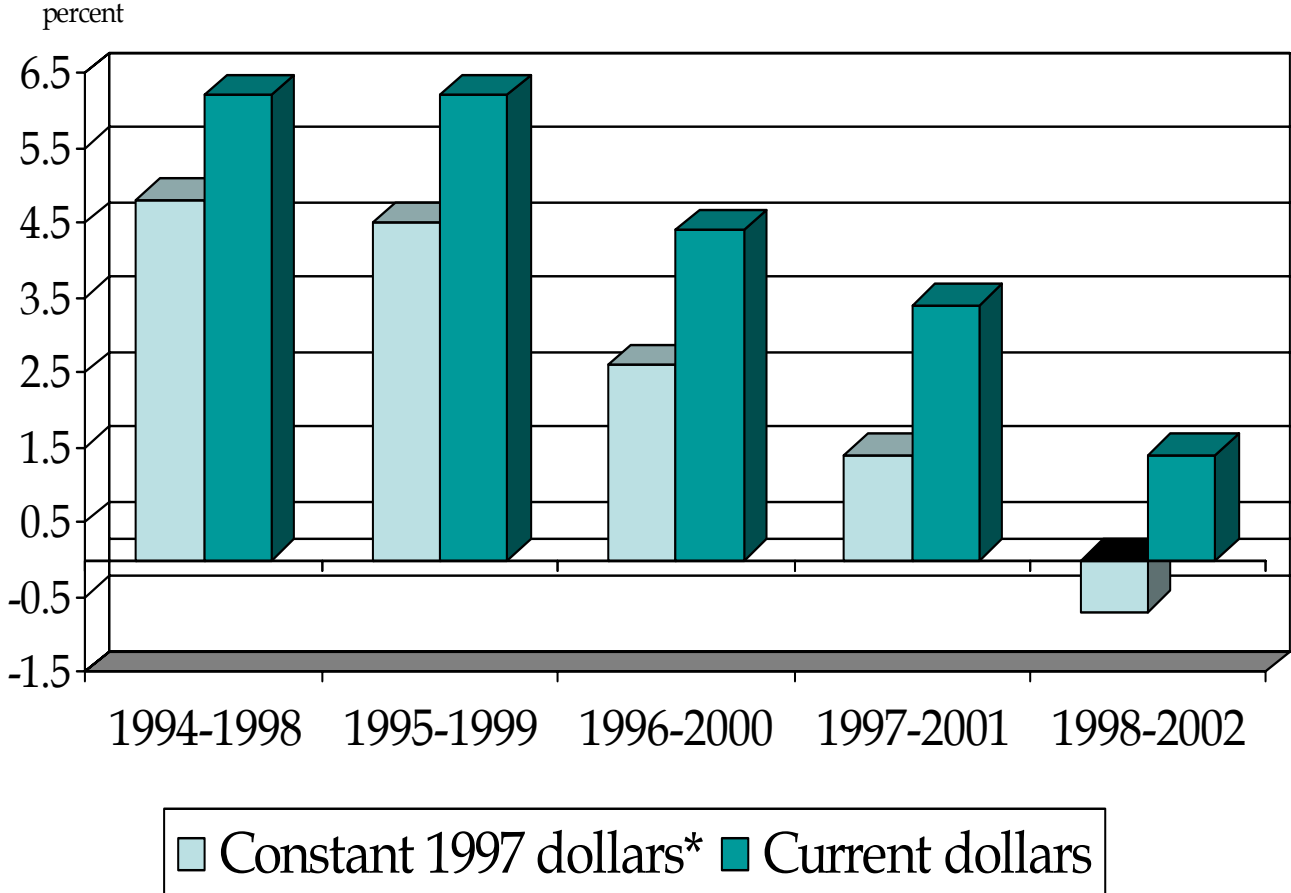


Figure 11: Five Year Moving Average, Volume of Business of Non-Financial Co-operatives, 1994-2002



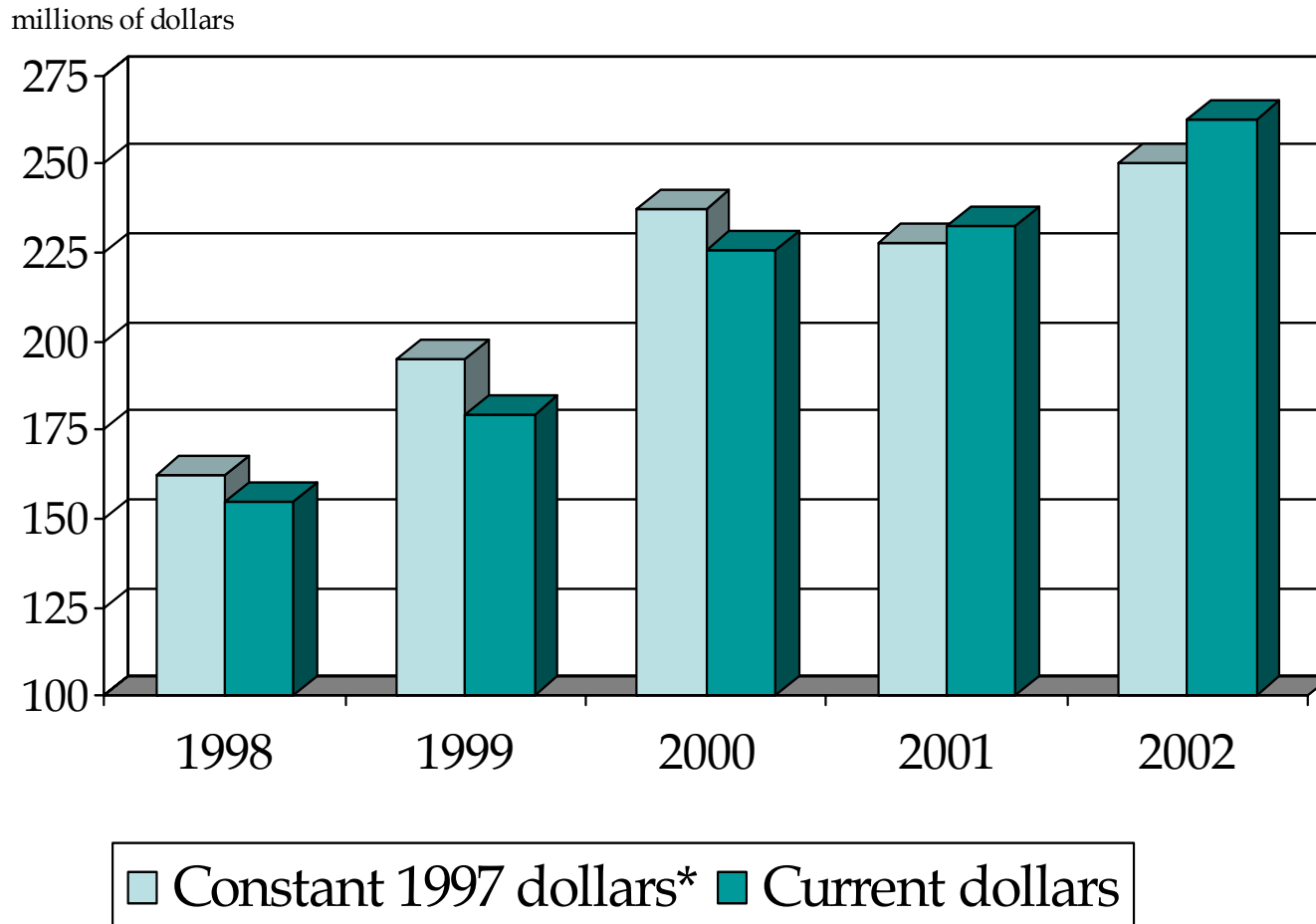

Figure 14: Number and Membership of Fishing Co-operatives, 1998-2002

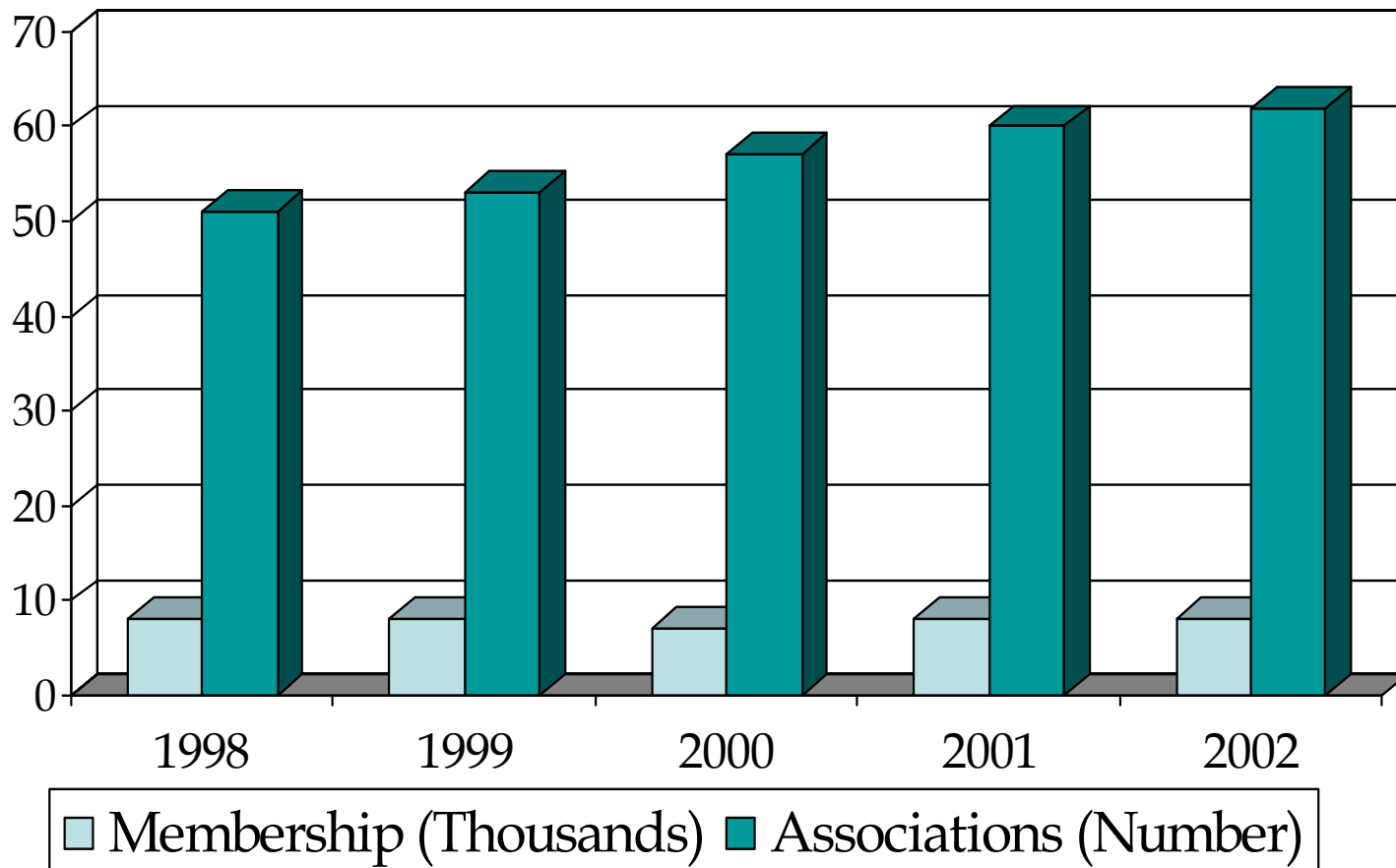
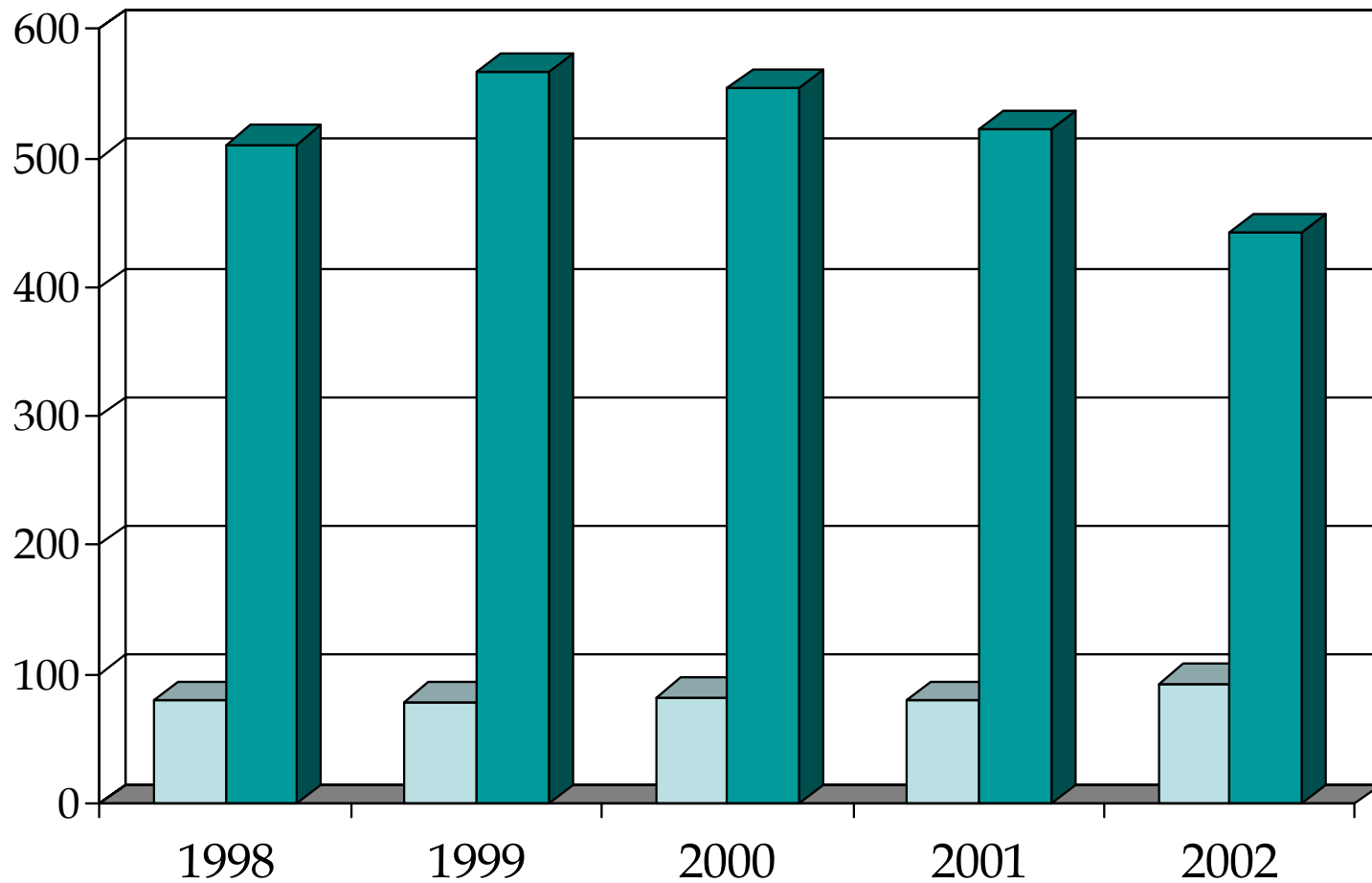


Figure 15: Service Revenues and Sales of Production Co-operatives, 1998-2002

Figure 16: Number and Membership of Production Co-operatives, 1998-2002

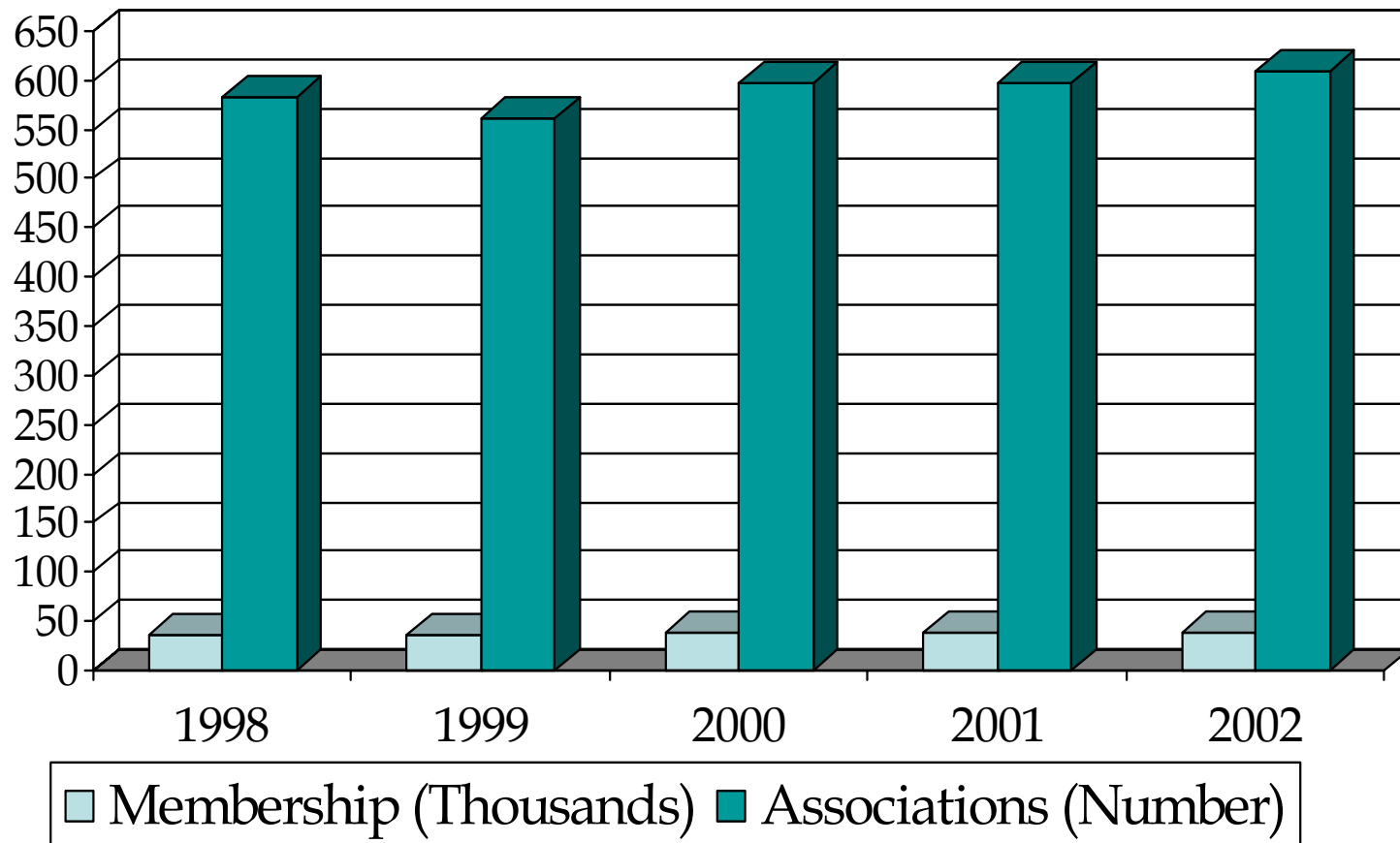
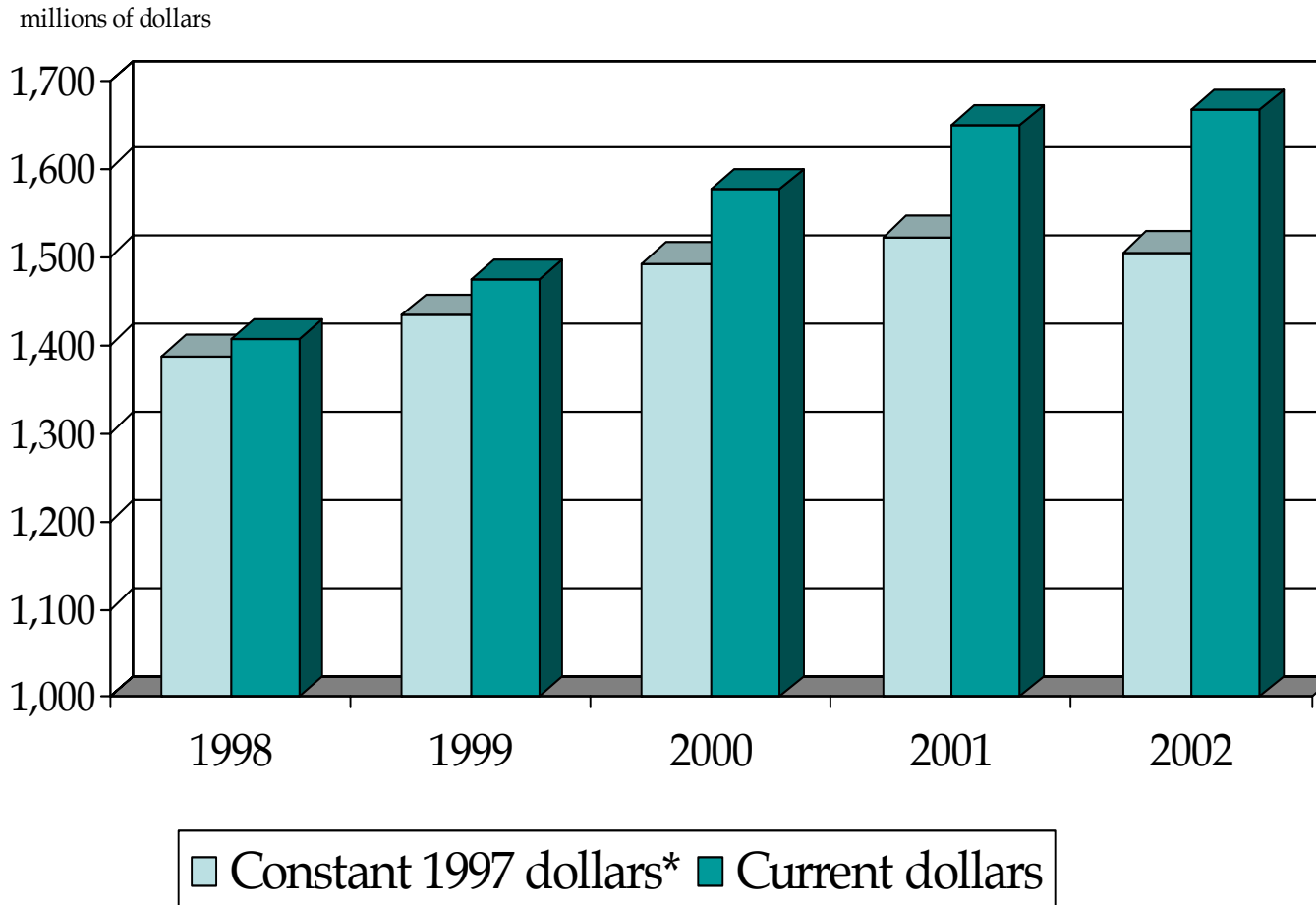


Figure 17: Volume of Business of Service Co-operatives, 1998-2002
