Need NISA funds fast?

If you find that you still need more money after receiving your 2000 NISA withdrawal trigger, why not consider an **Interim Withdrawal**?

With the Interim Withdrawal feature, you estimate your withdrawal entitlement for the 2001 stabilization year and request to receive the funds now. What do you need to do?

call NISA's TOLL-FREE LINE at 1-800-665-6472 (NISA) and request an Interim Withdrawal application.

2

ESTIMATE

what you think you would receive in withdrawal entitlements for the 2001 stabilization year (or 2002 for corporations or cooperatives with a non-calendar fiscal year end).

3

SUBMIT

your Interim Withdrawal application before the deadline.

The deadline for 2001 Interim Withdrawal applications is March 1, 2002. For corporations and cooperatives with a non-calendar fiscal year end, 2002 Interim Withdrawal applications are due by March 1, 2003. Interim Withdrawal payments are issued within 30 days of receipt of your application.



NISA funds and taxability

The month of December is the busiest time of the year for NISA's toll-free lines. This year, NISA account managers received a record number of calls from program participants, accountants and form preparers. Some of the most frequently asked questions over the toll-free lines are about the tax treatment of NISA withdrawals. See below for an example.

Q: I sent my Deposit Withdrawal Options Notice (DWON) to NISA in mid-December. I used part of my trigger to deem a deposit. With the remainder of the trigger I requested a withdrawal. If both of these are taken from Fund 2, why is the deemed withdrawal taxable in 2001 and the withdrawal cheque taxable in 2002?

A: Deemed withdrawals are taxable in the year they are processed and, in this case, it was processed in the 2001 calendar year (therefore taxable in 2001). Your withdrawal cheque, however, was issued in 2002 and was therefore taxable in 2002.
