Located in the tropical belt of South East Asia, Singapore has its historical origins as a trade colonial port serving the Straits between the Indian and the Chinese South Sea. In the last 40 years a successful free trade policy has led the city-state to an extraordinary rise in the standard of living and economic growth, with a population expansion of 4 million people.

Singapore is today one of the busiest ports in the world, one of the major oil refining and distribution centres, a main supplier of electronic components and a key financial centre in Asia.

It is a modern, progressive and well-off island city-state where change and redevelopment of the built environment is unavoidable as it evolves its national strategy to cope with the new global challenges.

Since the island became an independent Republic in 1965 innovative measures were adopted to overcome the natural limitation and the geographical constraints (680 square kilometers island, absence of natural resources). The Urban Redevelopment Authority, a government body created for the island expansion, is responsible for planning and constructing on the greater part of Singapore's land. As a result Singapore presents a dense ever-changing urban texture with a mix of tropical and high-tech landscape.

One of the principal issues of designing in the Tropics is the discovery of a design Language of line, edge, mesh and shade rather than an architecture of plane, volume, solid and void. An unlearning process is involved, given the dominance of European architecture, which forms the substance of the training of architects over the past 200 years

#### Architecture in Singapore

Today, a new generation of local architects and international architects are shaping the island for the 21<sup>st</sup> Century with deep pockets and wide powers to acquire and redevelop land on a large scale. A clearly recognizable design trend is the desire to create a new architectural Asian identity and in some cases a Western and Asian fusion that leads to a new idiom and aesthetics.

Local architectural firms often work on large and prestigious commissions in conjunction with foreign architects that continue to be widely employed as design consultants by both government and private clients. The Camden Medical Center by Richard Mayer and the 'Esplanade Theatres on the Bay' by Michael Wilford and Partners both realized in association with the local firm DP Architects are two recent examples of this kind of collaboration

Foreign architectural firms look at Singapore as an emergent strategic location for their business in Asia. The London based Foster and Partners in one of the most important foreign firms to start a local branch in Singapore.

The theme of 'import/export', recurrent in Singapore's history, seems to be a current trend in today's architecture in Singapore. Increasing numbers of Singapore registered architects are exporting their services. Singapore seems to be the stepping-stone for many designers, gaining expertise in their field. #### **Key Up-coming Architectural Projects**

As part of a ten-year plan, an array of high profile developments have begun to raise from the ground and once again change the skyline of Singapore. A new vision gives great emphasis to education, culture and art with the determination to transform Singapore into a cultural center.

Here are the most important up-coming projects:

- **Biopolis** with master plan by Zaha Hadid covers 200ha and comprises three major centers of activity for biomedical sciences, media, education industries and financial businesses. The goal is to be an iconic technopreneurial development for biomedical science research, development, manufacturing and health. Mixture of residential units, commercial hubs, tertiary and research institutes, sports facilities and green spaces, envisioned as a new creative environment that is conducive for innovation and experimentation.
- Singapore Management University city campus by KNTA Architects and Edward Cullinan Architects and SMU Administration building by DEG Architects and Cox Raynor are located in the heart of the historic civic district in Singapore, with an overall budget of S\$400m.
- **National Library** by Ken Yeung is designed to house the expanded National Library Board (NLB) collections and to efficiently support international information resources. The site is located at the edge of a planned entertainment district in the center of the city.
- La Salle SIA Campus by RSP Architects, under the lead of Liu Thai Ker, is the result of an Architectural Competition for the design of a new city campus. Targeted for completion in 2006 at a cost of S\$85m it will consist of six irregular shaped towers housing the two faculties of performing and visual arts and the six composite schools of music, dance, drama, fine arts, multi-media and design.
- **Supreme Court** by Norman Foster located in the heart of the city with the aim to knit into the city fabric will be opening soon.
- **Singapore Flyer** by Kisho Kurokawa Architects and Associates (KKAA) will be the world's highest observation platform at 170 m high. Built at an estimated cost of \$200m, it will utilize the most advanced engineering and design techniques. The accompanying structure that surrounds the flyer, a 3-storey building sitting facing the ocean, nestled in a manmade façade of green, will house retail outlets and restaurants.
- **Duxton Plains** by Arc 10 Studio Architecture and Urbanism is a 2-phase development, to be completed in 2008, featuring 1848 units of dwellings on a site of only 2.5 hectare.

#### **Interior Design in Singapore**

Commercial and institutional projects represent the leading sector for interior design firms.

Although the interior design industry consists of enterprises of small and medium size (from free lance design firms to larger architectural offices) the most lucrative commissions are offered by economically wealthy clients in the areas of shopping centers

and retail chains; hospitality and luxury condominiums developments; corporate offices and major public buildings.

Key players that have left their mark on Singapore are Kerry Hill, W architects, Minktan Architects, Wallflower Architecture and Design, Eco-id and Whiz Concepts.

The Asian Civilization Museum and the Fullerton Hotel are among the most important government projects completed in the recent years.

Recently interior design works started to be prized for excellence through the launch of public competitions and awards. The best interior works by Singapore-based design firms are awarded in the Singapore Furniture Industries Award context under the categories of home, workplace, leisure and services. Another relevant prize is awarded by Nippon Paint to celebrate the creative application of color and to acknowledge the level of skill required to complete quality work.

#### **Investing in Design**

In 2001, against the backdrop of an economic slowdown that significantly changed regional and world environment, the Government set up an Economic Review Committee (ERC) to review existing policies and formulate strategies to transform and revitalize the economy.

In the ERC review, the creative industries, namely the arts and culture, media and the design industries, were identified to be one of the three new and promising growth services. The Government has since 2001 set aside more than S\$200 million over the next five years to nurture and grow the creative industries. The aim is to add a new dimension to the Singapore economy and convert the city into a vibrant New Asian creative hub to capitalize on S\$1b of arts infrastructure that has been invested since the 1990s.

As part of the Creative Industries Development Strategy, the Government has formed the DesignSingapore Council, a national body to steer and coordinate the overall development of the design industries as an integrated cluster, to promote a pervasive design culture in Singapore, enhance creativity and raise awareness of Singapore design internationally.

Between 2004 and 2005 DesignSingapore has supported Singapore designers' participation at Venice Biennale of architecture, Tokyo Designers Block, International Contemporary Furniture Fair in New York, Paris Fashion Week and at World Expo 2005 in Aichi, Japan.

This year S\$26 million has been set aside for three initiatives aimed at promoting the development of the Creative Industries: "Media 21", "DesignSingapore" and "Creative Town Initiative".

More and more foreign companies, including foreign design companies, choose Singapore to set-up their Asia Pacific offices.

Canadian designers interested in working in Singapore compete against Australian, American, European, Malaysian and Chinese (i.e. Hong Kong) designers, more or less in that order.
