## Public Communication CAN 2003-1

Under the *North American Agreement on Labour Cooperations* (NAALC) between Canada, the United States and Mexico, each of the countries has established its own National Administrative Office (NAO) which is to provide for the submission and receipt of public communications (complaints) on labour law matters arising in the territory of another NAALC country, and is to review such matters in accordance with domestic procedures.

*Public Communication* CAN 2003-1 concerns events that occurred between 2000 and 2004 at Matamoros Garment and Tarrant México, two apparel factories in the state of Puebla, Mexico. The *Communication* raises issues related to the enforcement by the government of Mexico of its labour legislation addressing three NAALC principles: freedom of association, occupational health and safety, and minimum employment standards. This is the report and recommendation that was submitted by the Canadian NAO to the federal Minister of Labour and Housing.
