Wage Settlements

- Annual base rate wage adjustments from major collective bargaining settlements reached in **October 2005** averaged **1.3%**.
- **Private sector** wage adjustments which averaged **2.3%** in October 2005 were higher than those in the **public sector** at **0.8%**.
- On an industry basis, the largest average annual adjustment was in the **manufacturing** and the **public administration** sectors at **2.7%**, while the smallest was in the **commerce and trade** sector at **0.4 %**.

Union Membership in Canada—January 1, 2005

Each year, the Workplace Information Directorate carries out a survey on labour organizations in Canada with national and international unions either affiliated or unaffiliated to a central labour congress and having one or more members, and labour organizations consisting of a single bargaining unit and having more than 50 members, but non affiliated with any other labour organizations.

Information obtained during the most recent survey indicated that on January 1, 2005, 4,381,850 workers were union members. This represents an increase of 120,850 members compared to the 4,261,000 members accounted for on January 1, 2004.
