Certificates of Approval – Waste Management Systems

The Environmental Assessment and Approvals Branch (EAAB) of the Ministry of the Environment issues "Certificates of Approval" under the *Environmental Protection Act* (EPA) for waste management systems. Certificates of Approval are required for waste management systems that transport waste. This Fact Sheet provides information for prospective owners and operators of waste management systems.

What requires approval?

Section 27 of the *Environmental Protection Act* requires that an approval must be obtained prior to using, operating, establishing, altering, enlarging or extending a waste management system or a waste disposal site.

Operations and activities that require approval include but are not limited to:

- waste haulers
- haulers and spreaders of biosolids and septage
- mobile PCB destruction
- mobile site decontamination systems

The responsibility for obtaining approval for a waste management system lies with the owner. If the owner is a corporation, the person signing the application on behalf of the corporation must be someone who is specifically authorized by the corporation to do so. If the person signing the

application is not an official of the corporation, the application must be accompanied by a letter signed by an official of the corporation authorizing the person to act on its behalf for that purpose.

Are there exemptions to the requirement to obtain a Certificate of Approval?

Specific exemptions for selected types of waste management systems have been granted the General Waste Management regulation made under the EPA (O.Reg. 347). Applicants should familiarize themselves with the requirements of this Regulation.

How do I obtain a Certificate of Approval?

An application for a Certificate of Approval must be submitted to the EAAB for most waste management activities. This application should include a completed application form, the required application fee and any supporting information identified on the application form or in the application guidance material. A copy of the application form and supporting information should also be submitted to the ministry's District Office serving the area of the site.

Applications for Certificates of Approval relating to hauled sewage and biosolid disposal sites should be submitted directly to the ministry's District Office serving the area in which the existing or proposed disposal site is/will be located.



Application forms, application guidance material and contact information for the ministry's District Offices are available from the EAAB and in the "Publications" section of the ministry web site at www.ene.gov.on.ca.

What happens to my application once it is submitted?

Applications are screened for completeness by the EAAB. Incomplete applications may be returned at the application processing stage. Applicants should receive acknowledgment of receipt of their applications within two weeks of submitting them.

Applications are reviewed by technical staff and review engineers to assess if the application demonstrates compliance with the EPA and applicable regulations and guidelines.

Is a hearing required?

The Director may require the Environmental Review Tribunal to hold a hearing before granting an approval for a waste management system under certain circumstances, which are specified in Part V of the EPA.

Municipal applicants should also determine whether the *Environmental Assessment Act* (EAA) applies to the undertaking and, if so, ensure that any relevant EAA requirements are met before submitting an application for a C of A.

While there are specific posting requirements for waste disposal sites under the *Environmental Bill of Rights* (EBR), there are no requirements for waste management systems. Applicants should, however, familiarize themselves with the requirements of the EBR.

When can I expect to get my approval?

The EAAB typically receives over 1000 waste management C of A applications per year. Applications are processed in chronological order of their receipt.

If the proposal needs to be subjected to a public consultation/hearing process then the C of A can not be issued until after this process is complete.

The best assurance of a timely review is the preparation of a complete application package that clearly demonstrates compliance with the EPA and applicable regulations and guidelines. Review will take longer if additional required information is identified and technical comments are required from other parts of the ministry.

Will I require any other approvals?

In addition to approval under the EAA and Section 27 of EPA, the proposal may require approval under Section 9 of the EPA (air & noise) and/or Section 53 of the OWRA (sewage works). The proposal may also require approval from other Ontario ministries and other levels of government (i.e., federal or municipal). Approval under one Act does not imply approval under other Acts, under other sections of the same Act or under any other legislation.
