





Accountability Agreement Update

Hitting the Mark: The 2007/08 HAPS/HAA Negotiation Process

Ministry of Health and Long-Term Care staff have now completed their review of hospital planning submissions for 2007/08, and negotiations with hospitals are underway. To date, 26 hospitals have indicated that they are ready to sign Hospital Accountability Agreements (HAAs).

These hospitals produced submissions that were balanced, included reasonable cost, revenue and volume assumptions, and proposed no service cuts.

2007/08 HAPS/HAA Negotiation Timeline



This year, to streamline the Ministry's Hospital Annual Planning Submission (HAPS) review process, hospital submissions were triaged into three categories; A, B or C. Examples of issues that were flagged for further consideration include negative total margins and unusual movement in compensation relative to Five Ministry regional teams, which include Local Health Integration Network (LHIN) representatives, are meeting with hospitals. improve efficiencies. Ministry analyses of hospitals will be provided to hospitals prior to meetings.

Should outstanding issues require further review, corporate staff will work with the hospital and the negotiation team to develop a plan to address unresolved matters. All accountability agreements are expected to be completed by January 2007 (see timeline).

Progress Towards Finalizing the 2007/08 HAA Template

The JPPC Accountability Committee met on Friday, November 17, 2006 to finalize the 2007/08 HAA template.
