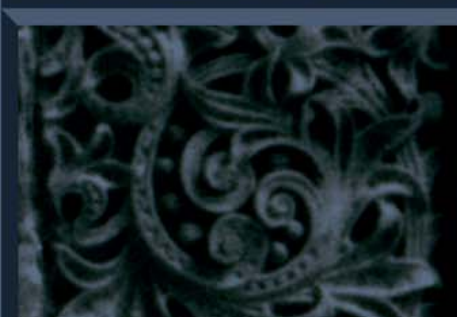

I am pleased to present the second Annual Report on the operations of the Ministry of the Attorney General's Court Services Division for the fiscal year April 1, 2003 to March 31, 2004.

The Court Services Division works to provide a modern and professional court service that supports accessible, fair, timely and effective justice services. Our five-year planning process helps us achieve this mission in a focused, fiscally responsible and transparent way. This Annual Report is an important part of our commitment under the Five-Year Plan to measure and report on the steps we have taken over the past year to provide excellent court services.

As you will read in the following pages, the Division has achieved a number of significant accomplishments in 2003/04.

A new, electronic court case tracking system for civil, family, Small Claims Court, Divisional Court and Superior Court criminal cases was implemented in 35 sites across the province. The system, which is being rolled out across the province, allows staff to track timelines and electronically schedule cases into courtrooms. The system also creates an information database that will improve the accuracy and enrich the scope of data for statistical reporting.

In collaboration with other divisions and the judiciary, the Justice Delay Reduction Initiative was implemented in 10 target sites to address criminal court delays in

high-volume courts. The Division also undertook an intensive review of administrative best practices at these sites, to ensure that court administrative processes are consistent, efficient and effective.

Several upgrades and renovations to existing court facilities were completed across the province. To accommodate continued caseload growth, new courthouses opened in Midland, Owen Sound and Chatham.

In addition to these projects, the Division implemented improvements in a number of other areas, including: new measures to support financial decision-making and accountability; a province-wide Divisional Business Continuity Framework to ensure that court services are provided during unforeseen or emergency circumstances; and pilot video assessment hearings to improve access to justice in remote areas of the province.

I trust you will find that this report is an informative overview of these and other initiatives that the Division is undertaking to ensure the high quality of Ontario's court services.

Chapter 1

Introduction to the Court Services Division

Mission

The Ministry of the Attorney General is responsible for administering justice in Ontario. Within the Ministry, the Court Services Division (CSD) is responsible for the administration of the courts. CSD's mission is to provide a modern and professional court service that supports accessible, fair, timely and effective justice services.

Core Services

CSD's core services include:

Court Office Services

CSD provides court office services in 181 communities across the province. Court staff schedule court cases at the direction of the judiciary, maintain court records and files, provide information to the public and facilitate the delivery of key justice programs including the Victim/Witness Program, the Bail Program, Domestic Violence Courts and Legal Aid.

Judicial and Courtroom Support

CSD provides administrative support to all judges of the Court of Appeal, the Superior Court of Justice and the Ontario Court of Justice and to justices of the peace. The Division also manages the jury system and provides courtroom support through court registrars, clerks, reporters, monitors and interpreters.

Mediation Programs

CSD manages the delivery of mediation services in the family and civil courts. Mandatory civil mediation is now part of the civil court process in Ottawa, Toronto and Windsor. As well, the Family Court branch of the Superior Court of Justice offers family mediation services on a voluntary basis across the province.

Enforcement Services

CSD administers the filing of writs of execution, enforces civil orders and manages the collection of fine and restitution revenues from the prosecution of criminal offences.

Highlights from the Opening of Courts

The annual Opening of Courts ceremony provides an opportunity for the legal community to reflect on the daily work done in the courts. On January 5, 2004, Chief Justice McMurtry of the Court of Appeal presided with Chief Justice Smith of the Superior Court of Justice and Chief Justice Lennox of the Ontario Court of Justice at the province's Opening of Courts ceremony at the Superior Court of Justice at 361 University Avenue in Toronto. Representatives from the judiciary, the bar, the federal and provincial governments, the police, the clergy, the media and social service agencies were in attendance. The newly appointed Attorney General, Michael Bryant, addressed the Chief Justices. He emphasized Ontario's commitment to judicial independence and his commitment to ensure a greater judicial role in the administration of justice.

Role of the Assistant Deputy Attorney General, Court Services Division

The Assistant Deputy Attorney General, Court Services Division, has overall responsibility for the administration of the courts in Ontario. The Assistant Deputy Attorney General reports to the Deputy Attorney General, who in turn reports to the Attorney General.

Regional Structure

For the purpose of providing court services, Ontario is organized into administrative regions. Each region is responsible for:

- Delivering local criminal, civil and family court services
- Maintaining records, files, exhibits and databases
- Providing judicial support services, including courtroom and administrative support
- Managing juries

- Delivering civil and family mediation programs
- Enforcing court orders
- Managing fines, fees and trust funds
- Managing regional financial and human resources
- Identifying and coordinating regional facility plans
- Managing regional stakeholder communications
- Implementing divisional initiatives

During 2003/04, CSD's North region was divided into the Northeast and Northwest regions. As a result, CSD's regions now correspond more closely with the Ontario Court of Justice administrative regions. Courts in the Northeast and Northwest can focus on, and be more responsive to, the unique service delivery challenges in their separate geographic areas.

Regional Directors

Each region is managed by a Director of Court Operations who reports to the Assistant Deputy Attorney General, Court Services Division.

Located geographically to the north and east of Toronto, the Central East region serves many of the communities of the Greater Toronto Area, including Barrie, Newmarket, Oshawa and Whitby. The population growth rate in this area is among the highest in Canada.

In 2003/04, the Central East region partnered with the Division's Business Solutions

Unit to pilot the new electronic court case tracking system for civil, family, Small Claims Court, Divisional Court and Superior Court criminal cases in Oshawa and Whitby. Oshawa and Whitby were the largest provincial pilot sites for the case tracking system, and provided valuable feedback on implementation issues.

The Justice Delay Reduction Initiative was also implemented during the fiscal year in Oshawa and Newmarket, to help reduce backlogs in these high-volume courts. The region welcomed nine new judges

in Barrie, Oshawa and Newmarket and five new justices of the peace.

The region was honoured in 2004 with a *Building Owners and Managers Association of Greater Toronto Award for Building Excellence*, in recognition of the facility improvements at the Newmarket courthouse. To receive an Award of Building Excellence, a building must meet high standards in building management, operations, environmental management, design, tenant satisfaction and building personnel training.

The region also completed construction of a new satellite courthouse in Midland in August 2003. Opened officially on September 2, 2004, the new courthouse will accommodate continued caseload growth in the area. Renovations to the Newmarket, Oshawa, Barrie and Peterborough courthouses increased the amount of functional court space in the region and ensured compliance with facility requirements under the *Youth Criminal Justice Act*.

In addition, during 2003/04, the Central East region worked on planning for the largest trial of members of a motorcycle gang in Ontario's history.

Serving over 2.5 million residents, the Central West region has the highest population of the seven CSD regions. The Central West region includes Pearson International Airport, numerous communities in the Greater Toronto Area and Ontario's largest Indian reserve, the Six Nations Reserve, as well as the New Credit Reserve.

Rapid population growth, the expansion of the Peel Regional Police force, the relocation of Caledon Ontario Provincial Police charges to the Orangeville courthouse and the presence of Pearson International Airport are contributing to high caseload growth in the Brampton and Orangeville courts. To address this growth, Orangeville and Brampton have received additional judicial, court services and Crown resources as part of the Justice Delay Reduction Initiative. The Ministry is constructing two additional courtrooms in the Orangeville courthouse.

The Central West region, in conjunction with the Business Solutions Unit, has successfully implemented the new electronic court case tracking system for civil, family, Small Claims Court, Divisional Court and Superior Court criminal cases in Simcoe, Cayuga, Brantford, Welland, St.Catharines and Brampton. Implementation of the system in Milton, Oakville, Burlington, Orangeville and Hamilton is to be completed by fall 2004.

During 2003/04, the Central West region also developed a Divisional Business Continuity Framework, to ensure court services are provided during unforeseen or emergency situations. The framework will act as a model to assist local court managers in other CSD regions with the development of local business continuity plans.

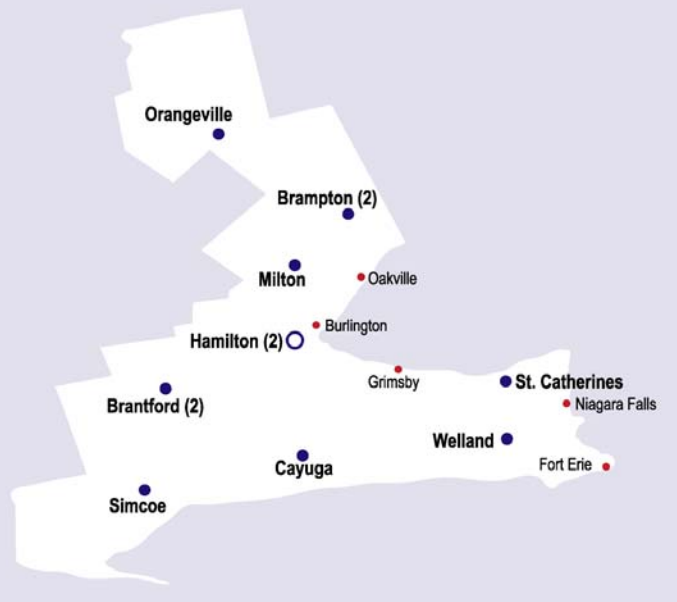

The East region provides court services to 10 counties/unioned counties in eastern Ontario. The region has a significant francophone population and provides many services in French. The East regional office is located in Canada's capital city, Ottawa.

The population in the Ottawa area continues to grow at a faster rate than the provincial

average and is expected to be over one million by 2011. This growth is reflected in the courts, as CSD issues in the East region are beginning to mirror large city issues.

Two courts in the East region were identified as Justice Delay Reduction Initiative sites for 2003/04. Ottawa and Cornwall received additional judicial, court services and Crown resources. Plans are underway for facility upgrades over the next two years to address the needs of this project.

Consolidation of the Brockville Ontario and Superior Courts of Justice into a renovated five-courtroom heritage courthouse was substantially completed in 2003/04. Occupancy is planned for summer 2004.

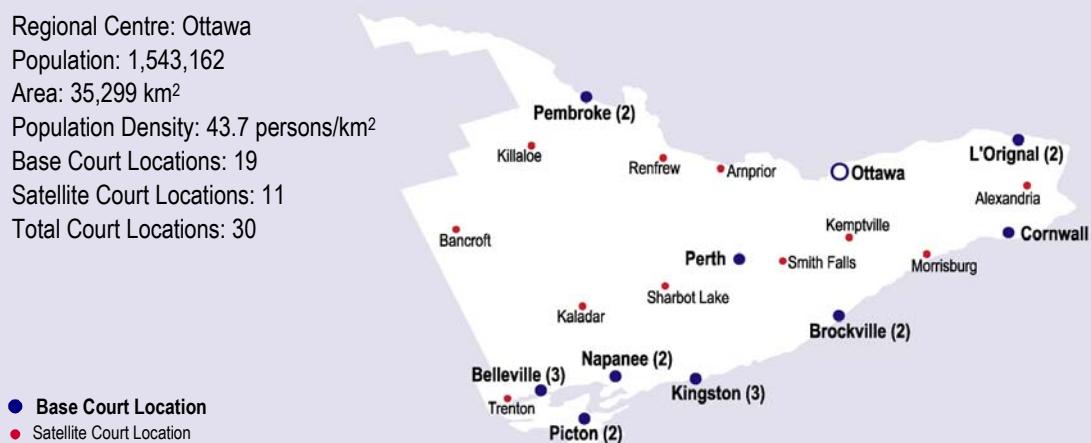
The region also implemented the new electronic case management system in Belleville. The rest of the region is scheduled for implementation by the end of 2004/05.

Information technology resources for the East region courts, Crowns and judiciary were upgraded in 2003/04. Systems officers for the courts and the Crown worked together as a team to provide more efficient completion of this project.

During 2003/04, the Director of Court Operations for the East region participated in a United Nations' mission to modernize the Algerian court system and served as the elected chair of the Eastern Interministerial Council. The Council is comprised of regional directors and senior managers who work together to achieve excellence in delivery of public services.

Northeast Regional Profile

The Northeast region includes some of the major urban centres in Ontario's north, as well as some of the smaller communities near James Bay.

The region comprises 40 percent of Ontario's land mass but is home to only 5 percent of its population. There are significant francophone and aboriginal populations in the region and court services are regularly provided in French, Ojibway and Cree.

During 2003/04, the region implemented the new electronic court case tracking system in Parry Sound, Haileybury, Sudbury, Kirkland Lake, Manitoulin and Elliot Lake. The region plans to implement the system in Cochrane, Timmins, Sault Ste. Marie and North Bay in 2004/05.

Building on technology already in place under the Video Remand Project, the region has begun piloting

video assessment hearings. The pilot will continue through 2004/05, and is expected to improve access to justice in remote areas, decrease scheduling wait times and reduce travel for hearings officers. Haileybury was also selected as a 2004 provincial test site for the re-engineering of writs of seizure and sale.

The Northeast continues to face facility challenges. Many of the region's courthouses were originally built in the 1920s and 30s and do not have sufficient space to accommodate court initiatives such as the Victim/Witness Assistance Program (VWAP), Family Law Information Centres and Legal Aid.

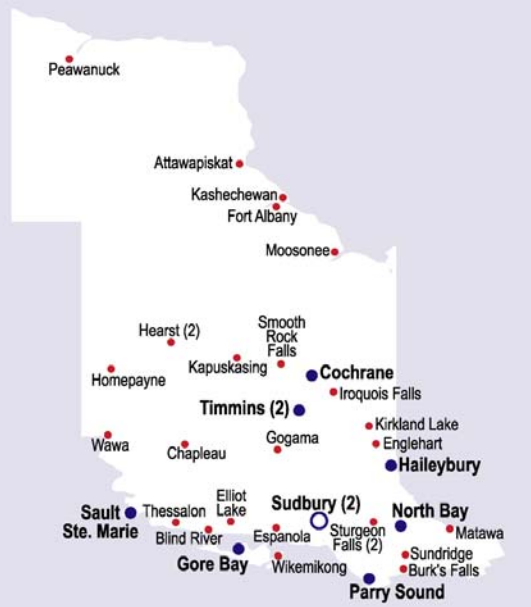
Facilities projects during 2003/04 were undertaken to create additional space in existing courthouses. At the Sudbury courthouse, a lower floor area was excavated to create new offices for Police. The space vacated by the Police is being converted to a Video Court and an Intake Office. Phase 2 of this project will result in enlarged holding cells and a sally port. At the Haileybury courthouse, Crown attorney staff were relocated within the facility to increase operational efficiency and space was created and assigned to VWAP and Legal Aid services.

The Northwest region comprises 48 percent of Ontario's land mass but is home to only 2 percent of its population.

The region delivers court services in five base court locations, three staffed satellite court locations and 32 un-staffed satellite court locations. 25 of the satellite court locations are accessible only by air. To provide community-centred

services, court staff and members of the judiciary and the bar must travel extensively.

There are significant aboriginal populations in the Northwest region, and court services are regularly provided in Ojibway and Cree.

The region's vast geography, remote locations and winter travel conditions present many program delivery

challenges. The Northwest region has been using technology to help meet these challenges and to ensure that court services are accessible and efficient.

Video conferencing infrastructure has been installed in Thunder Bay, Kenora, Dryden, Fort Frances, Sioux Lookout and Red Lake. Although this infrastructure has primarily been used for video remands, it has also allowed the region to explore new uses for video in court. The technology has enhanced access to the family court from remote communities, and will ensure that judicial resources are available to families, child protection agencies and lawyers, regardless of the remoteness of the communities in which they live. The infrastructure platform is an important vehicle to help CSD provide timely, accessible justice services in spite of geographic limitations.

In 2003/04, the Northwest region also implemented the new electronic court case tracking system for civil, family, Small Claims Court, Divisional Court and Superior Court criminal cases in locations across the region.

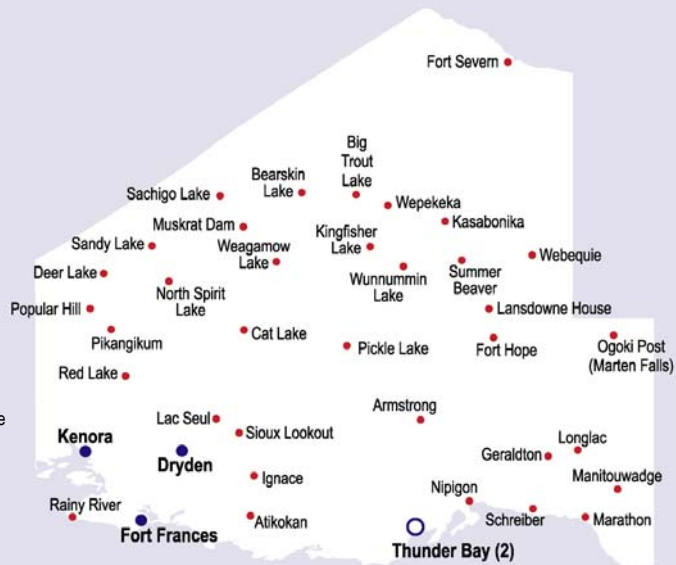

The Toronto region serves the City of Toronto. With a population of almost 2.5 million, the Toronto region has the highest population density of the CSD regions. One in four immigrants to Canada settles in Toronto and the region is ethnically diverse.

The Toronto region includes many high volume courts and key justice system participants, including: the Court of Appeal for Ontario; the Offices of the Chief Justices; the Provincial Legislature; the offices of the Provincial Law Society; and many of the province's largest law firms. The Region also manages Ontario's first electronic courtroom for commercial and other non-jury civil matters.

Three Justice Delay Reduction Initiative (JDRI) courts are located in Toronto, at 2201 Finch Avenue West, 1000 Finch Avenue West and 1911 Eglinton Avenue East. Each of these courthouses is undergoing

substantial renovations to accommodate the initiative. In addition, JDRI best practices are being introduced to non-JDRI locations within the region.

In the past year, Toronto developed and implemented the Transcript Backlog Initiative to reduce delay due to transcript backlogs. Court of Appeal directives were issued instructing court reporters to prepare transcripts within 90 days of the ordering date. The initiative has been successful in reducing delay in the region.

The region also implemented changes to forensic procedures for accused persons with mental health problems. Instead of sending accused persons to hospitals for mental health assessments, psychiatrists are now brought to the court to perform assessments. The new arrangement is more cost efficient and avoids unnecessary remand time in custody. In addition, Toronto established an agreement with the Centre for Addiction and Mental Health to ensure that appropriate medical professionals are available to support the court. The agreement consolidates forensic assessment and expert testimony services and ensures that psychiatrists attending at the courthouse are expertly trained and supervised.

West Regional Profile

The West region crosses three Superior Court judicial regions and is comprised of both large urban centers and rural farming areas. The region includes Sarnia and Windsor, both major border crossings between Canada and the United States. The volume of traffic from trucks and cross-border commuters generates a high number of traffic-related charges in this region.

The West region also houses Ontario's Central Jury Office, which is responsible for managing the selection of jury panels for courts across the province.

Video technology is used extensively in the majority of court locations in the West region. Because London is the sole location of the Weekend and Statutory Holiday Court for the West, matters from across the

region are dealt with from this single location via video technology.

In 2003/04, two new courthouses were opened in the region in Owen Sound and Chatham. Renovations were completed to the Cambridge and Stratford courthouses, resulting in additional courtrooms and judicial chambers. Further renovations and a technology upgrade to the London courthouse created a state-of-the-art courtroom which can accommodate up to 24 accused persons and their counsel.

In January 2003, Windsor implemented civil case management under Rule 77 of the *Rules of Civil Procedure*. Under case management, the court supervises the progress of cases to promote timely resolution. Civil case management has been in place in Windsor under a different rule since 1990. However, by implementing Rule 77, Windsor now follows the same rule for case management as Toronto and Ottawa. Windsor also migrated to a new technology system in 2003 to support the implementation of Rule 77 case management.

Corporate Support

The CSD corporate offices are located at 720 Bay Street in Toronto. The corporate offices include the offices of the Assistant Deputy Attorney General, the Corporate Planning Branch, the Criminal Policy and Programs Branch, the Civil/Family Policy and Programs Branch and the Business Solutions Unit.

The Corporate Planning Branch is responsible for:

- Divisional planning
- Managing financial and human resources
- Collecting and reporting court statistics
- Establishing Divisional performance measures and monitoring compliance with operational policies and business standards
- Co-ordinating public communications
- Developing and distributing Divisional directives, operational manuals and staff training guides
- Managing Divisional facilities
- Acting as a liaison with municipalities for *Provincial Offences Act* matters
- Establishing policy project teams to respond to justice system challenges

The Criminal Policy & Programs Branch is responsible for:

- Developing, implementing and managing legislative, regulatory and administrative initiatives with respect to the criminal justice system
- Providing policy and program support to criminal court staff
- Providing legal support and advice to senior management on criminal court issues
- Providing support to initiatives from the Ministry's Criminal Law Division
- Providing support to backlog initiatives in the criminal courts
- Supporting the appointment process for judges, justices of the peace, commissioners and notaries public
- Managing the Justice of the Peace Review Project

The Civil/Family Policy & Programs Branch is responsible for:

- Developing, implementing and managing legislative, regulatory and administrative initiatives with respect to the civil and family justice system
- Providing policy and program support to civil and family court staff
- Providing legal support and advice to senior management on civil and family court issues
- Developing, implementing, and managing civil justice reform strategies to reduce cost and delay in the civil justice system
- Managing family mediation and information services
- Participating on Federal/Provincial/Territorial Family Law Committees and the Family Rules Committee
- Negotiating and monitoring federal family justice funding

The Business Solutions Unit is responsible for:

- Developing, implementing and managing the CSD Strategic Information Technology Plan
- Developing, implementing, managing and supporting courts information technology systems
- Managing the acquisition of CSD information technology hardware and software
- Liaising with CSD branches and Justice Technology Services on new system requirements and enhancements to new systems
- Managing the implementation of corporate information technology initiatives in CSD
- Managing issues and relationships with partners and stakeholders, with respect to court technology

Corporate Directors

Chapter 2

Introduction to Ontario's Courts

Ontario's *Courts of Justice Act* creates the framework for the province's court structure. The Act establishes the jurisdiction of each of the province's three courts: the Court of Appeal for Ontario, the Superior Court of Justice and the Ontario Court of Justice.

The Court of Appeal for Ontario

The Court of Appeal for Ontario is the highest court of record in the province. The Court of Appeal hears:

- Criminal appeals of indictable offences
- Civil appeals of final decisions of the Superior Court of Justice
- Appeals involving young persons
- Some appeals of decisions of the Divisional Court
- Inmate appeals (heard in Kingston, Ontario)

The Court of Appeal sits in Toronto at Osgoode Hall. The court is composed of a federally appointed Chief Justice of Ontario, an Associate Chief Justice of Ontario and 22 other judges. The Court of Appeal sits with either one or three judges depending on the appeal. Decisions of the Court of Appeal may be further appealed to the Supreme Court of Canada. (Note that the Supreme Court of Canada is administered by the federal government according to ss. 91(27), 92(14), 96-101 of the *Constitution Act*).

The Superior Court of Justice

The Superior Court of Justice hears:

- Criminal prosecutions of indictable offences
- Some criminal prosecutions involving young persons
- Summary conviction appeals from the Ontario Court of Justice
- Bail reviews
- Civil suits (Civil suits under \$10,000 are dealt with in Small Claims Court, a branch of the Superior Court.)
- Family law disputes involving divorce or property claims, child and spousal support, and custody and access claims (Where the Family Court branch of the Superior Court of Justice exists, the Superior Court hears all family matters.)

The Superior Court of Justice sits in 49 permanent court locations in Ontario. The court is led by a federally appointed Chief Justice of the Superior Court of Justice, an Associate Chief Justice, and Regional Senior Justices who oversee scheduling and judicial issues in their regions. Most of the judicial locations in Ontario also have a Local Administrative Justice who oversees the judicial administrative issues at that specific location.

Divisional Court

The Divisional Court is a branch of the Superior Court of Justice. The court hears:

- Appeals and reviews of decisions by government agencies, tribunals and boards
- Some civil appeals under \$25,000

The Divisional Court sits in various locations throughout the province in panels of three judges. The court includes the Chief Justice of the Superior Court of Justice, the Associate Chief Justice of the Superior Court of Justice and other judges appointed from the Superior Court of Justice.

Family Court

In some jurisdictions in Ontario, a Family Court branch of the Superior Court of Justice has been established to provide a single court for all family matters, including divorce, division of property, child protection, adoption, child and spousal support and child custody and access matters. Special services provided by the Family Court include Family Law Information Centres, Supervised Access Centres, Mediation Services and Parent Information Sessions.

The Family Court has been established in 17 municipalities across the province. Where the Family Court does not exist, jurisdiction over family law disputes is divided between the Superior Court of Justice and the Ontario Court of Justice.

Small Claims Court

The Small Claims Court is a branch of the Superior Court of Justice. The court hears civil actions for claims up to \$10,000. While there are some permanently appointed Small Claims Court judges, the court is usually presided over by senior lawyers who are appointed to act as deputy judges.

The Ontario Court of Justice

All criminal cases are commenced in the Ontario Court of Justice, and over 95 percent of such cases are completed in this court. Ontario Court judges and justices of the peace sit in over 175 locations across the province. Judges of the court hear:

- Criminal prosecutions of indictable and summary conviction offences
- Most criminal prosecutions involving young persons
- *Provincial Offences Act* appeals from decisions of justices of the peace
- Child protection applications, family law disputes involving custody, access and support, and adoption applications, in areas where the Family Court branch of the Superior Court of Justice does not exist

Justices of the Peace hear:

- Bail hearings
- Prosecutions of provincial offences

The court is led by a Chief Justice of the Ontario Court of Justice, an Associate Chief Justice, an Associate Chief Justice/Coordinator of Justices of the Peace, Regional Senior Justices and Regional Senior Justices of the Peace. Most of the judicial locations in Ontario also have a Local Administrative Justice who oversees the judicial aspects of the court at that specific location.

Chapter 3 2003/04 Court Activity

Five-Year Trends

Statistical data about court activity is extracted from the Integrated Courts Offences Network (ICON), which is CSD's operational system for Ontario Court of Justice criminal proceedings, and from the Courts Input Statistical System (CISS), which is the case tracking system for civil, small claims and family matters and Superior Court of Justice criminal proceedings. The scope of data available from CISS is much narrower than that available from ICON.

CSD has developed a new case tracking system for civil, small claims and family cases, as well as for Superior Court criminal and Divisional Court proceedings. This system will be in place across the province by early 2005. The new system is designed to meet CSD's management information and operational needs and will provide extensive data about case processing. In developing the system, CSD has captured all of the information that is currently available from the SUSTAIN case management system in Toronto, Ottawa and Windsor, including time-standard tracking and case-aging data. The new system also includes some additional, important data elements, including detailed event information.

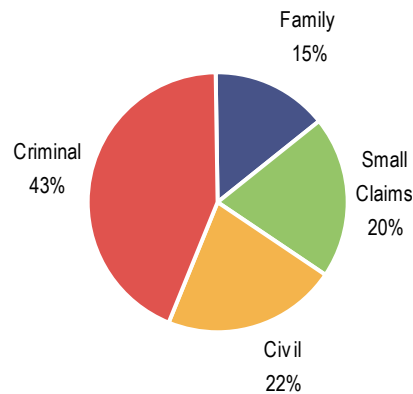
CSD is also enhancing the accuracy and scope of data available from ICON.

The following discussion outlines some of the trends that CSD is currently tracking for all practice areas. More detailed statistical information and definitions are included in the Appendix.

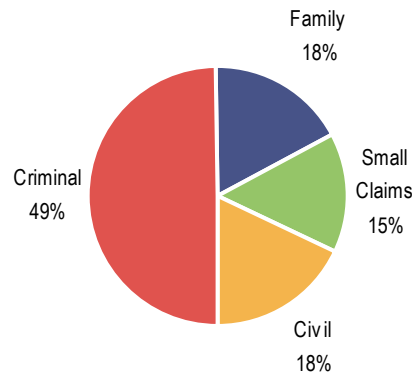
New Proceedings Received

Over the past 10 years, small claims and civil matters have declined as a proportion of total court activity while family and criminal matters have increased*.

* There are on average two charges per information filed in the criminal court of the Ontario Court of Justice. An information is roughly equivalent to a case. To compare practice area case volumes, Ontario Court of Justice criminal charges received were divided by two.

The Criminal Courts - The Ontario Court of Justice

Charges Received, Disposed and Pending

The Ontario Court of Justice receives over 500,000 criminal charges a year. There are on average two charges per information filed; an information is roughly equivalent to a 'case.' In 2003/04, there were therefore approximately 267,000 new criminal cases.

In 2003/04, adult *Criminal Code of Canada* charges comprised 75 percent of total charges received, while adult federally prosecuted charges comprised 8 percent and youth charges 16 percent.

Over the past five fiscal years, the number of charges received has increased by 11.5 percent. However, in the last two years, there has been a 2.4 percent drop in charges received, mostly due to a decline in youth charges and adult federally prosecuted charges (13.9 percent and 10 percent decrease, respectively).

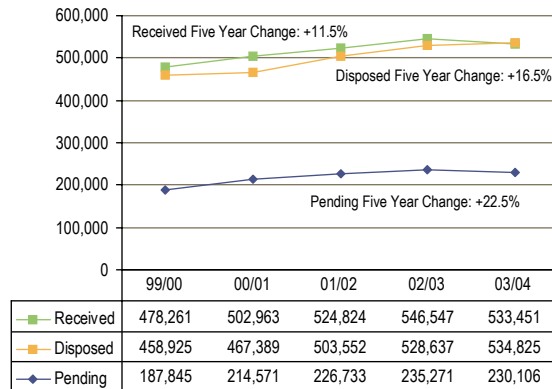
The Court disposed of 16.5 percent more charges last year than it did in 1999/2000, with adult *Criminal Code of Canada* and federally prosecuted charges accounting for most of the increase in charges disposed (21.1 percent and 11.5 percent increase, respectively).

The number of charges pending in 2003/04 was 22.5 percent higher than it was in 1999/2000. Over the past five years, the number of charges pending for adult *Criminal Code of Canada* charges has increased 27.4 percent, but has remained relatively stable over the last two years.

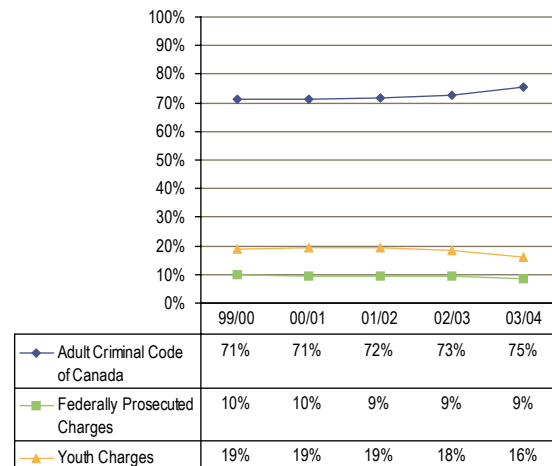
Number of Events

An event is a court appearance. Over the past five years, events heard in the Ontario Court of Justice have increased 38.6 percent. *Note: Criminal events heard in the Ontario Court of Justice are collected for each charge that was before the court. For example, if a person has been charged with two offences, the courts database shows two events for each court appearance.*

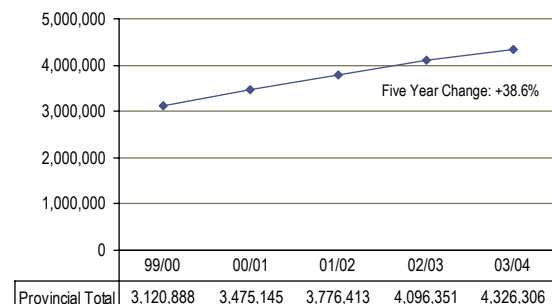
Charges Received, Disposed and Pending

Courtroom Operating Hours

Over the past five years, courtroom operating hours in the Ontario Court of Justice have increased steadily across the province by 17.4 percent. *Note: Courtroom operating hours reflect hours during which courtrooms are in use; they do not measure working hours for court staff or judicial officers.*

**The Criminal Courts -
The Superior Court of Justice**

Cases Received, Disposed and Pending

The Superior Court of Justice received over 5,000 cases (indictments and appeals) in 2003/04. There has been little change in total cases received over the past five years. However, adult *Criminal Code of Canada* cases have decreased 2.3 percent while federally prosecuted matters have increased 9.4 percent.

The number of cases disposed in the Superior Court of Justice has decreased by 9.4 percent over the five-year period. In 2003/04, however, charges disposed increased 5.7 percent, primarily due to a 32 percent increase in the number of federally prosecuted charges disposed.

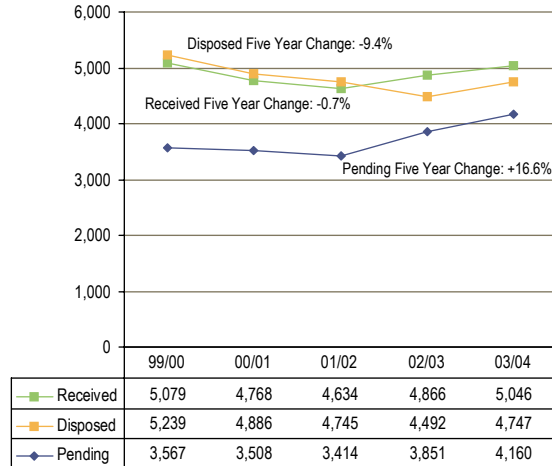
Number of Events

The number of events heard in the Superior Court of Justice has remained stable, despite a spike in 2001/02.

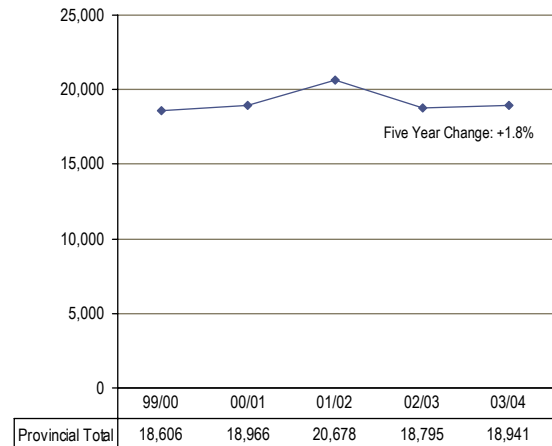
Courtroom Operating Hours

The Civil Courts

New Proceedings

In 2003/04, over 93,000 new civil cases were received in the Superior Court of Justice. Approximately 1,300 of these cases were heard in the Divisional Court.

Over the past five years, the number of new proceedings appears to have increased 16 percent. The significant increase in new cases in 2002/03, however, was due to the first-time inclusion of bankruptcy and commercial data from the Toronto region.

Number of Events Heard

The number of events heard has increased 10.2 percent during the last five years. This upward trend began after 2001/02, and has been due, in part, to the inclusion of bankruptcy and commercial events data from the Toronto region in 2001/02 and to new civil case conferencing events in Toronto, Ottawa, and Windsor during the same year.

Courtroom Operating Hours

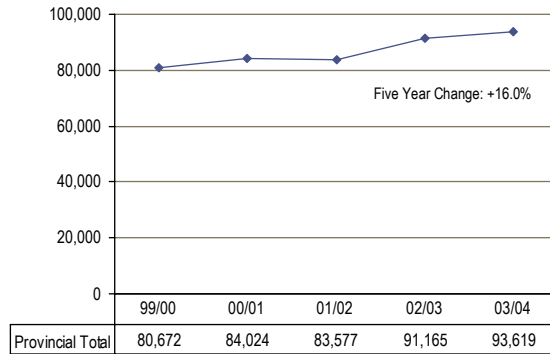

Mediation Settlement

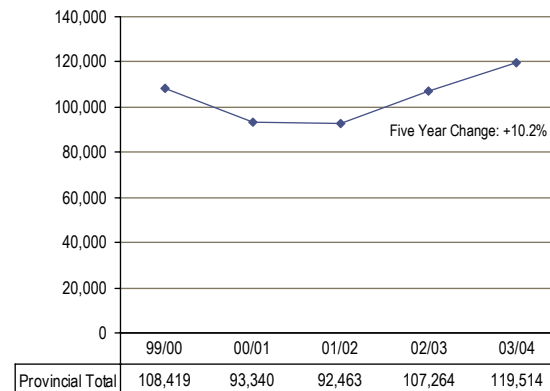
Mandatory mediation is a feature of civil case management in Toronto, Ottawa and Windsor. Full settlement rates for mandatory mediation have remained stable at approximately 40 percent. Partial settlement rates have decreased over the last five years, but have remained relatively stable over the last two years.

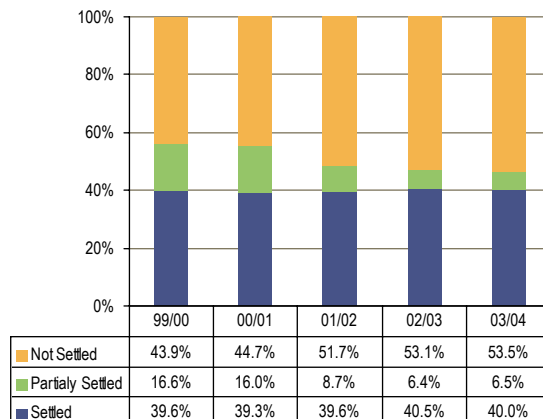
**New Proceedings in the Superior Court of Justice, Civil

The Family Courts

As discussed earlier, family matters are heard in both the Ontario Court of Justice and the Superior Court of Justice. In 17 locations, a Family Court of the Superior Court of Justice (hereinafter Family Court) has been established to hear all family matters. Family Courts have been established in all locations in the Central East region, in most locations in the East region and in a small number of locations in the Central West and West regions.

The most recent expansion of the Family Court in 1999, together with the introduction of the new *Family Law Rules* that same year, has had a significant impact on court data. These changes affected the volume of incoming cases at various locations as well as family court procedures and coding practices.

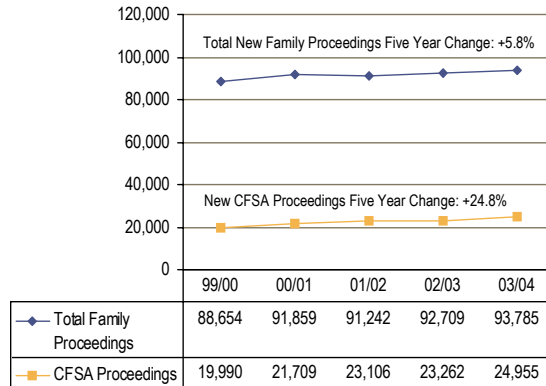
New Proceedings

In 2003/04, Ontario courts received 93,785 new family cases. Of these, 24,955 (26.5 percent) were child protection proceedings under the *Child and Family Services Act* (hereinafter CFSA). Overall, the total number of new proceedings increased 5.8 percent over the past five years. During that period, the number of new CFSA proceedings increased 24.8 percent.

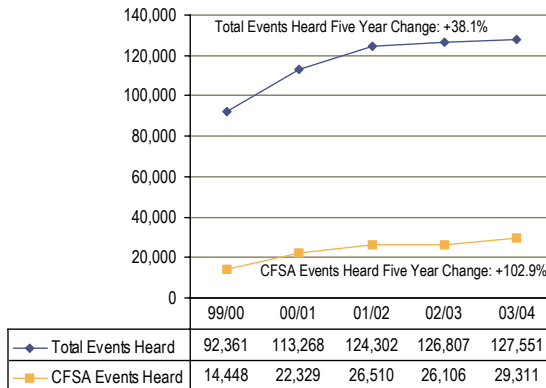
The largest increase in activity occurred in the Superior Court of Justice, due in part to the shift of cases from the Ontario Court of Justice as a result of Family Court expansion in 1999.

The Superior Court of Justice has experienced a 15.4 percent increase in new family proceedings, due in part to Family Court expansion in 1999. There has been a 53 percent increase in the East region and an almost 30 percent increase in the Toronto region. Both the Central East and North East regions had over 10 percent increases. Only the West region experienced a decrease in new proceedings (down almost 17 percent).

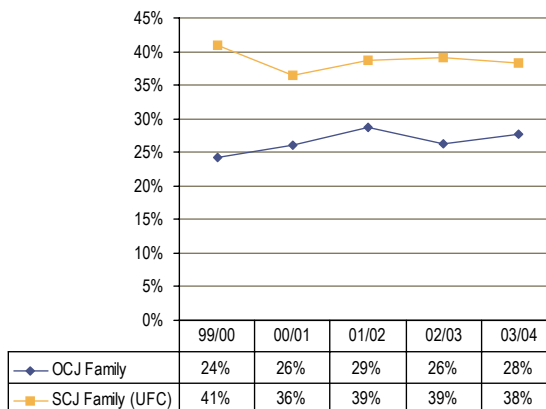
New Proceedings in the Ontario Court of Justice and the Superior Court of Justice, Family 1999/00 to 2003/04

The number of new cases commenced in the Family Court of the Superior Court of Justice has increased 47.8 percent over the past five years, while the non-Family Court experienced an 8 percent decline in the number of new cases. Since 2001/02, CFSA caseload in the Family Court has increased approximately 15 percent.

Over the past five years, the total number of new family proceedings in the Ontario Court of Justice has decreased 7.2 percent. This was due in part to the expansion of the Family Court of the Superior Court of Justice to the Central East and East regions in November 1999. Since 2001/02, however, a small increase in the number of new proceedings has occurred, due to increases in both CFSA and other family cases.

Number of Events

Over the past five years, the total number of events heard in family proceedings has increased 38 percent, while CFSA events have increased 102.9 percent.

CFSA Proceedings That Took Over Four Months to be Disposed

The percent of *Child and Family Services Act* cases that took over four months to be disposed has not changed dramatically over the five year period. The greatest percentage of cases that took over four months to be disposed occurred in regions where there is a Family Court of the Superior Court of Justice and in the Toronto region.

Mediation

Family mediation rates for full settlements remained fairly stable at approximately 64%.

Courtroom Operating Hours

Over the past five years, courtroom operating hours have increased 12 percent. *Note: Courtroom operating hours reflect hours during which courtrooms are in use; they do not measure working hours for court staff or judicial officers.*

2000/01 to 2003/04**

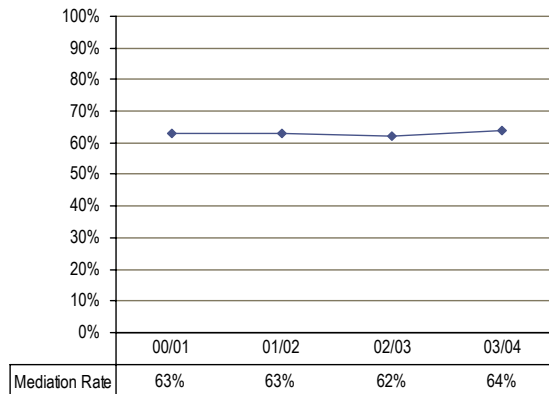

New Proceedings

45 percent of all civil cases commenced in 2003/04 were Small Claims Court claims.

In 2003/04, almost 78,000 new cases were filed in Small Claims Court. Over the last five years, the number of new cases has decreased 5.5 percent; however over the past three years there has been little change.

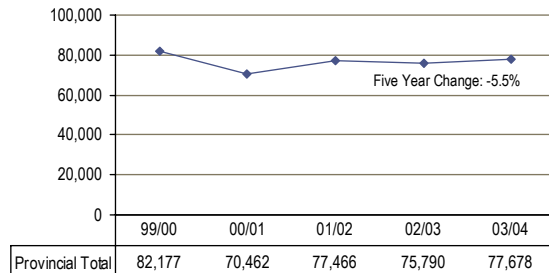
Number of Events

The number of events heard in the Small Claims Court has increased 20.3 percent over the past five years.

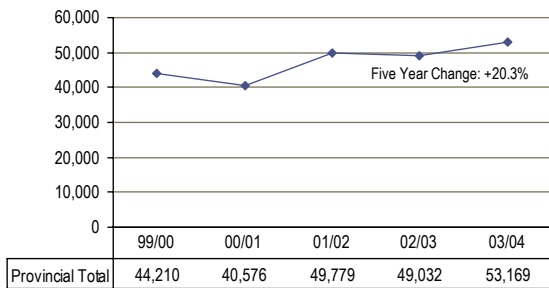

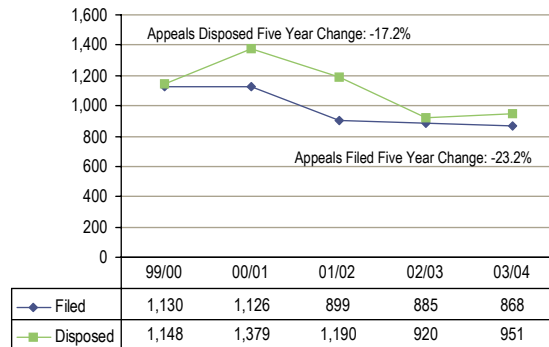
Criminal Appeals

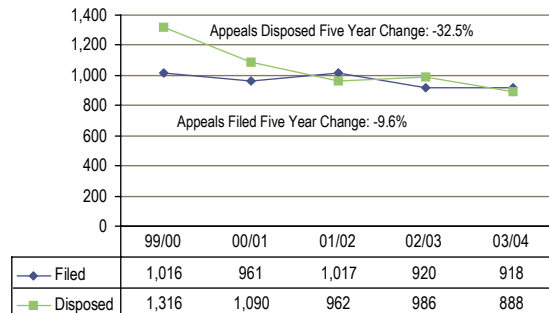
Civil Appeals

Chapter 4

2003/04 Operational Overview

The Criminal Courts

The Justice Delay Reduction Initiative

The Justice Delay Reduction Initiative (JDRI) is a joint initiative between CSD, the Criminal Law Division and the Victim Services Secretariat, working with the judiciary, Legal Aid Ontario, and Policing and Correctional Services. The initiative addresses criminal justice delay in the ten most critically backlogged sites in Ontario. During 2003/04, 14 new judges were appointed, and over 140 new court staff were hired, along with additional prosecutors and victim support workers. Funding was also increased for Legal Aid and duty counsel at these sites. This long-term infusion of additional resources means that the Backlog Reduction Initiative Teams (discussed below) can be diverted to other sites where backlog is also a problem.

The Division also undertook an intensive review of administrative best practices at the ten JDRI sites, to ensure that court administrative processes are consistent, efficient and effective. Over the coming year, these changes will be monitored to assess their impact on the Division's operations and on the backlog of criminal cases.

Backlog Reduction Initiative

The Backlog Reduction Initiative is a joint project between CSD, the Criminal Law Division and the judiciary of the Ontario Court of Justice. This initiative directs dedicated resources towards reducing the backlog of criminal cases in particular courts. Each court involved in the initiative receives additional Crown attorneys and judges, with accompanying court support staff, for up to six months. In 2003/04, resources were directed towards Newmarket, Ottawa and Brampton. Target sites for 2004/05 may include North York, Brampton, Barrie, Milton and Ottawa.

Youth Criminal Justice Act

The *Youth Criminal Justice Act* (Bill C-7), proclaimed on April 1, 2003, created significant changes in the youth justice system. The Act emphasizes the rehabilitation of young offenders within the community, expands the criteria to be considered at bail hearings, introduces new types of sentences and transforms the procedure for seeking an adult sentence.

Justice Summit

The Deputy Attorney General and the Chief Justices of the Superior and Ontario Courts of Justice co-hosted the first Justice Summit in early 2002 to address growing backlogs in criminal and child protection cases. The meeting included representatives from the judiciary, the bar, the Ministry of the Attorney General, the Office of the Children's Lawyer, Legal Aid Ontario, Children's Aid Societies and the Ministry of Community, Family and Children's Services (now known as the Ministry of Children and Youth Services). As a result of this meeting, committees were established to investigate bail and remand issues and to address possible criminal case scheduling improvements.

The Summit reconvened in February 2003. The Committee on Bail and Remand Issues reported on its initiatives and was directed to develop implementation plans. The work of the Criminal Case Scheduling Committee is underway. The Summit will reconvene in September 2004 to consider the recommendations of the committees.

The Civil Courts

Civil Justice Reform Strategy

Case management and mandatory mediation are two components of the Ministry's civil justice reform strategy to reduce unnecessary delay and cost in the civil justice system.

Civil Case Management: Under case management, the court supervises the progress of cases to promote timely resolution. Timelines for the occurrence of key litigation events are set out in Rule 77 of the *Rules of Civil Procedure*.

Case management under Rule 77 has been in place in Ottawa and Toronto since 1997. In January 2003, Windsor implemented civil case management under Rule 77. Although civil case management has been in place in Windsor under a different rule since 1990, by implementing Rule 77, Windsor now follows the same rule for case management as Toronto and Ottawa.

Mandatory Mediation: Established under Rule 24.1 of the *Rules of Civil Procedure*, Ontario's Mandatory Mediation Program is designed to help litigants settle their cases early in the litigation process, thereby saving them time and expense. Under Rule 24.1, participants in most civil, case-managed, non-family cases are referred to a mediation session within 90 days after the first statement of defence is filed.

Mandatory mediation became permanent in Toronto and Ottawa in July 2001, after a two-year independent evaluation confirmed the positive impact of mediation on the speed, cost and outcome of civil litigation. The program came into effect in Windsor in December 2002. As of January 2004, mandatory mediation has resulted in a full and partial settlement rate of 49 percent, exceeding the Ministry's target of 40 percent.

Changes to the Civil Rules

The Civil Rules Committee is a statutory committee composed of representatives from the judiciary, the bar and the Ministry of the Attorney General. The Committee has the jurisdiction to make rules regarding

procedures in all civil proceedings in the Court of Appeal and the Superior Court of Justice. In 2003/04, the Committee introduced provisions prescribing the venue of civil actions.

Small Claims Court

As of April 2, 2001, the monetary jurisdiction of the Small Claims Court was increased from \$6,000 to \$10,000. This is comparable with the monetary jurisdiction of small claims courts in British Columbia, P.E.I., Manitoba, and Quebec, which range from \$7,000 to \$10,000. The Ministry continues to monitor the impact of the jurisdictional increase.

In 2003/04, Ministry representatives also participated on the Small Claims Court Rules Subcommittee of the Civil Rules Committee. The Subcommittee completed its review of the *Small Claims Court Rules*, including a consideration of province-wide mandatory settlement conferences and automatic dismissal timelines. The Subcommittee released a consultation paper and draft rules in October 2003. It is anticipated that the Subcommittee will submit its final proposal to the Civil Rules Committee for approval in 2004 and that the new rules will come into effect in 2005.

Discovery Reform

The Government of Ontario and the Superior Court of Justice appointed a task force in 2001 to review the effectiveness of Ontario's discovery process, identify problems and make recommendations for reform. The task force consulted with representatives of the judiciary and the bar across the province, gathered quantitative and qualitative data and reviewed approaches to the discovery process in jurisdictions outside Ontario. The task force submitted its report in November 2003. The report recommends incorporating enhanced cost and time saving mechanisms into the *Rules of Civil Procedure* and developing and disseminating a best practices manual containing practical guidelines on the conduct of discovery. The Ministry is now working with members of the judiciary and bar to implement these recommendations.

The Family Courts

Family Court Services

Family Mediation Services: Family mediation services are an integral part of the 17 Family Courts. These services provide voluntary mediation of issues arising on family breakdown including custody, access, support and property division. 79 percent of the 2,560 mediated cases in 2003/04 reached settlement, with 64 percent full agreement and 15 percent partial agreement.

Parent Information Sessions: Voluntary parent information sessions are available at Family Court locations. These sessions educate parents about the effects of separation and divorce on children.

Family Law Information Centres: Family Law Information Centres exist in most court sites. They provide free information, publications, videos and other resource materials on issues related to separation, divorce and other family matters.

Client Satisfaction With Services

Client satisfaction surveys for 2003/04 indicate a 99.7 percent satisfaction rate with family mediation services, a 100 percent satisfaction rate with parent information sessions and a 96.6 percent satisfaction rate with Family Law Information Centres.

Justice Summit: Child Protection Backlog Initiative

The Justice Summit was convened to address growing backlogs in child protection cases in Ontario. In 2002 and 2003, Justice Summits have been co-hosted by the Deputy Attorney General and the Chief Justices of the Superior and Ontario Courts of Justice, to address delay in criminal and child protection cases. The Summits included representatives from the judiciary, the bar, the Ministry of the Attorney General, the Office of the Children's Lawyer, Legal Aid Ontario, Children's Aid Societies and the Ministry of Community, Family and Children's Services (now known as the Ministry of Children and Youth Services).

The Child Protection Backlog Steering Committee was formed during the 2002 Justice Summit to identify issues and develop recommendations to address delays in child protection cases. The Steering Committee includes three working groups: best practices, northern issues and data and information technology.

At the 2003 Justice Summit, the Steering Committee reported on their initiatives and were directed to develop implementation plans. To implement some of the best practice recommendations, two new working groups were created for child protection mediation and education. The Steering Committee will report back to the 2004 Justice Summit, scheduled for September 21, 2004.

Changes to the Family Rules

The Family Rules Committee is a statutory committee composed of representatives of the judiciary, the bar and the Ministry of the Attorney General, with jurisdiction to make rules regarding procedure in Ontario's family courts. In 2003/04, the Committee approved the application of the *Family Law Rules* to family law cases in the Superior Court of Justice. As a result, all trial-level family courts in Ontario will follow the same rules as of July 1, 2004.

Family Law Information Centres

By July 1, 2004, CSD plans to have expanded Family Law Information Centres to additional sites in Ontario, to coincide with the expansion of the *Family Law Rules* to the Superior Court of Justice. The majority of the new sites are located in the northern regions.

Potential Expansion of the Family Court Branch

In 2002, the federal government announced 62 new judicial appointments to Family Courts across Canada. CSD is working with the judiciary and the federal government to consider further expansion of the Family Court branch of the Superior Court of Justice to new locations in Ontario.

Chapter 5

2003/04 Corporate Initiatives

Modernizing Service Delivery

Civil/Family Court Case Tracking System

CSD has developed a new electronic court case tracking system to more effectively manage civil, family, Small Claims Court, Divisional Court and Superior Court criminal cases. The system tracks timelines, allows staff to electronically schedule cases into courtrooms and creates an electronic database that increases the accuracy and availability of court data for statistical reports.

As of March 31, 2004, CSD has implemented the new court case tracking system in 35 court sites. Province-wide training and phased implementation is targeted for completion by December 31, 2004.

Criminal Court Case Management Legacy System Modernization

Building on existing technology, CSD is planning to improve the criminal court case management system: the Integrated Court Offences Network (ICON). The Ministry is reviewing pre-court, in-court and post-court processes, resource requirements and technology needs. These reviews are to be completed in 2004, and will result in recommended priority improvements for ICON.

Display Boards Project

Visitors to busy court facilities often require assistance to locate the proceeding they wish to attend. The Display Boards Project fosters user self-service by displaying court information and directions on large display boards in courthouse lobbies.

As of March 31, 2004, display boards have been installed in 17 courthouses across the province, in the cities of Barrie, Brampton, Chatham, Cornwall, Hamilton, Kitchener, London, Milton, Newmarket, North Bay, Oshawa, Ottawa, Owen Sound, Sarnia, Sault Ste. Marie, Toronto and Windsor. Future phases of the project to display additional court information are in the planning stages.

Model Electronic Courtroom

In 2002/03, CSD established a model electronic courtroom at the 393 University Avenue Superior Court of Justice in Toronto. The courtroom is a test environment for the use of advanced in-court technology in commercial and other non-jury civil matters. The technology supports:

- Digital evidence and argument presentation
- Remote video and teleconferencing appearances by counsel, witnesses and interpreters
- Simultaneous cross-border hearings

Pilot testing and evaluation of the facility continued through 2003/04.

Telecom Modernization

The Ministry of the Attorney General Telecom Modernization Project was initiated to upgrade antiquated telephone infrastructure throughout the province, in order to improve Ministry adherence to Ontario's Quality Service Strategy.

During 2003/04, telecom enhancements continued at the Sault Ste. Marie, Red Lake, and Gore Bay courthouses. The Ministry undertook extended warranty plan options where applicable.

Video Remand

A high proportion of preliminary criminal court appearances are remands; the accused is “remanded” (sent back) to custody to await trial. The Video Remand Project allows an accused person to appear in court by video conferencing from a police station or correctional institution. Video remand reduces the number of prisoners who must be transported to and from court.

As of March 31, 2004, the Video Remand Project has implemented 125 installations in courthouses, correctional facilities, First Nations buildings and Ontario Provincial Police detachments. Video facilities will be installed in one additional courthouse location in 2004/05. The project is continuing to work with Municipal Police Services, the Ontario Provincial Police and First Nations Police Services to coordinate POTS (Plain Old Telephone Service) videophone installations, with the goal of providing video services in Ontario’s remote locations. CSD also continues to explore the use of video technology in non-criminal proceedings.

Improving Staff Support and Internal Communications

The Court Services Division Intranet

The Court Services Division Intranet site is the primary means of communication between CSD corporate head office and the regions. The site consists of over 1,800 web pages, including divisional directives, up-to-date manuals, electronic forms and other CSD communications. The site receives over 400 visits per day, resulting in over 175,000 hits per month.

The Intranet content management system was upgraded this year to facilitate posting and to make the site fully accessible under the *Ontarians With Disabilities Act* guidelines.

Procedural Manuals

The objective of the Manuals Project is to improve resources for field staff and ensure common service standards in court procedures across the province. The project is undertaking to rewrite or create over 30 court procedural manuals.

Distributed to staff on the CSD Intranet site, the new manuals:

- Present information in a clear and readable format
- Provide electronic links to forms and legislation required for legal authority
- Incorporate all CSD directives
- Remain current, by allowing for updates on a real-time basis as policies and procedures change
- Illustrate step-by-step instructions in diagrams

The manuals are being developed through collaboration between professional writers, designers, business line experts, focus groups and review committees.

Electronic Forms

The Corporate Planning Branch is in the process of making available all court forms in electronic format. The forms allow court staff to:

- Use the most current version of forms
- Fill out the forms electronically
- Save the contents of the forms for future reference
- Produce the forms in-house, on an as-needed basis, with considerable cost savings

The forms are linked to the procedural manuals on the CSD Intranet site, to allow for easy access by court staff. To date, over 500 forms have been recreated and posted online. Electronic forms are consistently among the most frequently accessed pages on the CSD Intranet.

Working with Our Justice Partners

Provincial Offences Act Support to Municipalities

The *Provincial Offences Act* (POA) governs non-*Criminal Code* offences, such as parking, traffic and liquor licence violations and offences under the *Ontario Health and Safety Act* and the *Environmental Protection Act*. Municipalities are responsible for administering POA offences and prosecuting selected POA offences. The province is responsible for prosecuting serious POA offences and for the quality of the justice system as a whole.

As part of its oversight and monitoring role, CSD conducts regularly scheduled audits of POA courts. CSD also reviews semi-annual financial and performance reports from all municipalities that administer POA courts. Additional monitoring mechanisms are being developed, including monthly reports of POA workload and financial data. The Division is also updating the POA operations manuals and is improving communications with municipalities.

Improving Public Legal Education

Established in 2002 by Chief Justice McMurtry, Chief Justice LeSage and Chief Justice Lennox, the Ontario Justice Education Network (OJEN) is a collaborative venture which fosters public understanding of the justice system.

Through the Courtrooms and Classrooms Program, tens of thousands of students across Ontario have had an opportunity to engage in interactive sessions with various justice system participants.

In 2003, OJEN completed its first year, expanding its Summer Law Institute for high school teachers to five locations, including Windsor, Ottawa, London, Sudbury and Toronto. The two-day program provided teachers with an opportunity to gain legal knowledge and to

meet members of the justice community. OJEN also developed resource materials titled *Values of the Justice System*, which were distributed to all schools in the English and French language school boards in Ontario. In winter 2004, the network published its first edition of *Update*, a newsletter that details many of the public legal education initiatives occurring throughout Ontario.

Ontario Justice International

Ontario Justice International (OJI) is the Ministry of the Attorney General's international consulting service. By drawing upon the Ontario government's experience operating one of the largest justice systems in North America, OJI helps client governments design and operate fair, impartial, accessible and efficient justice systems.

As part of OJI, CSD prepared customized training materials in modules that covered Ontario's experience with recent civil and family justice reform initiatives, including case management and mandatory mediation. Materials were drafted to respond to the particular areas of interest of OJI's international clients.

Management Information

CSD statistics, collected by court staff across the province, comprise the largest source of statistical data used by the Ministry of the Attorney General. CSD continues to develop its management information systems to:

- Improve the accuracy and scope of court statistics
- Present court statistics online
- Generate standard statistical reports
- Provide the basis for informed and strategic decision-making across the Ministry
- Provide data to assist courts in managing their caseloads

Managing Court Facilities

Investing in Court Facilities

Since 1996, Ontario has committed \$269M to the Courts Construction Program, which focuses on the consolidation of Superior and Ontario Courts of Justice. New courthouses have been constructed in Brampton, Cornwall, Hamilton, Owen Sound, Toronto (Civil/Family), Welland, Windsor and Chatham. Brockville is due to open in summer 2004. The planned Pembroke court consolidation project remains a Ministry priority in the 2004/05 Infrastructure Plan. The government is moving ahead with a new Durham courthouse that will consolidate court services that are currently spread throughout the region, which is expected to be completed in the winter of 2008/09.

The Ministry's other capital investments have focused on the repair of existing facilities to manage health, safety and security issues and to implement special initiatives, including improvements to holding cells and related areas to comply with the federal *Youth Criminal Justice Act*.

Facilities Renewal

Justice Delay Reduction Initiative: As part of the Ministry's Justice Delay Reduction Initiative to reduce the criminal backlog in the courts, capital funding of \$2.4M was allocated to commence planning for additional space in multiple court locations. The additional space will include new courtrooms and holding cells and facilities to accommodate the judiciary, Crowns, support staff, victim services, duty counsel and court administration staff.

Orangeville: Constructed in 1881, the Orangeville courthouse needs to be expanded and modernized, to accommodate caseload growth and changes in program delivery. Design work is underway and the Ministry has identified this facility as a priority project for infrastructure funding.

Holding Cells: In order to comply with the federal *Youth Criminal Justice Act*, the Ministry invested \$900,000 in 2003/04 to improve holding cells and related areas for in-custody young persons in courthouses across the province.

2003/04 Courts Construction Projects

Brockville: Consolidation of the Ontario and Superior Courts of Justice into a renovated five-courtroom heritage courthouse with an estimated cost of \$15.1M. This project was substantially completed in 2003/04 and occupancy is planned for summer 2004.

Chatham: Consolidation of the Ontario and Superior Courts of Justice into a renovated six-courtroom facility with an estimated cost of \$13.4M. Construction is complete and the Ministry began operations in August 2003. The official courthouse opening ceremony is planned for May 2004.

Owen Sound: Consolidation of the Ontario and Superior Courts of Justice into a newly constructed five-courtroom facility with a total construction cost of \$15.8M. The new consolidated courthouse began operations on February 3, 2003, and the official opening ceremony occurred on March 12, 2004.

Pembroke: Planning for the consolidation of the Ontario and Superior Courts of Justice into the existing historic courthouse at 297 Pembroke Street East is currently underway.



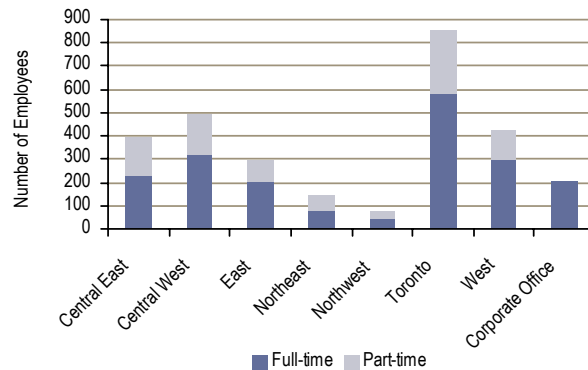

Chapter 7

Planning for the Future

Court Services Division Five-Year Plan

In 2002, CSD initiated a rolling five-year planning process for the Division to improve the effectiveness, efficiency and accessibility of court services. The resulting Five-Year Plan outlines the following business goals for the Division:

- Timely and Efficient Case Processing
- Accessible Services
- Consistent High-Quality Services
- Accountable and Effective Decision Making
- Efficient Resource Management

The Plan establishes 43 service standards, lists the initiatives that will be undertaken to meet those service standards and sets out time lines for delivery.

The Planning Process

CSD is part of a non-hierarchical network of independent but interdependent participants in the justice system. The process to develop and update the Five-Year Plan has therefore engaged representatives of the judiciary, our justice system partners and Division staff. This consultation with the judiciary and CSD stakeholders is a key strategy for meeting our business goals.

The advice that we received about this year's draft Plan has been very useful in helping us to set priorities. We have, for example, been urged to take steps to train and stabilize our workforce and to review standards for court interpreter services. The need for improved technology and to ensure adequate judicial and staff resources has been highlighted. We have been reminded of the importance of working closely with the judiciary and our partners, not only to identify necessary initiatives, but also in implementing them and, appropriately, of respecting the independence of the judiciary as we do so. This feedback is very important to us and will inform our work over the next year.

We look forward to continuing consultation as we review and update the Plan annually.

Introduction to the Appendix

The Court Services Division has implemented a new daily data extraction process with improved logic for Ontario Court of Justice criminal data (the data for other courts are not affected). This will ensure that double-counted charges received and disposed, and false pending charges, are not reported. The 2003/04 annual report is the first annual report to contain the new data. Data have been restated for all years included in this report. Old and new restated provincial totals for the 2003/04 fiscal year have been compared in order to gauge the magnitude of the change. Restating values has not changed historical trends. The restated data show the same trends over time as previously reported.

- The number of charges received for 2003/04 is 7 percent less than previously reported.
- The number of charges disposed is 3 percent less than previously reported.
- The number of events heard have dropped by 1.7 percent.
- The number of charges pending is 6.5 percent lower than previously reported.

The Division has a number of other initiatives under way to improve the quality, scope and accessibility of court statistical data and we look forward to being able to provide enhanced information as these initiatives are implemented.

Appendix Glossary

CISS	The Courts Input Statistics System (CISS) is a desktop computer system that reports monthly on activities in the Superior Court of Justice (including Small Claims Court and the Family Court) and family cases in the Ontario Court of Justice.
Civil	Civil data includes proceedings for all <i>Motor Vehicle Act</i> , <i>Construction Lien Act</i> and estates proceedings and other civil proceedings in the Superior Court of Justice. It excludes small claims and family matters.
Criminal	Criminal data includes all offences under the <i>Criminal Code of Canada</i> , <i>Controlled Drugs and Substances Act</i> and other federal offences by adults and young persons. Ontario Court of Justice criminal data is collected by charge, whereas Superior Court of Justice criminal data is collected by indictment. On average, over the last five years, there were approximately 3.6 charges on each Superior Court of Justice indictment.
Family	Family data includes all <i>Family Law Act</i> , <i>Children's Law Reform Act</i> , <i>Divorce Act</i> , <i>Child and Family Services Act</i> , <i>Reciprocal Enforcement of Support Orders Act</i> and other family cases.
ICON	Integrated Courts Offences Network (ICON) is an operational system that tracks charges filed at the Ontario Court of Justice.
Small Claims	Small claims data includes all cases which fall within the jurisdiction of the Small Claims Court (i.e., civil claims of \$10,000 or less, excluding claims under the <i>Construction Lien Act</i> and any other matter within the exclusive jurisdiction of the Superior Court of Justice).
