Note: The 2007-2008 calendar provides for 196 possible school days between September 1, 2007 and June 30, 2008. The school year shall include a minimum of 194 school days of which two days must be designated as professional activity days to focus on provincial education priorities and up to four extra days may be designated by the board as professional activity days. The remaining school days shall be instructional days. The boards may designate up to ten instructional days as examination days.
