AGREEMENTS SETTLED IN JULY

- ► In July, 49 collective agreements were ratified, each covering 200 or more employees. These agreements covered a total of 40,344 employees, 89% of whom were in the public sector (35,772) with the majority in public administration (21,292) followed by health and social services (11,990).
- The overall average annual increase in base wage rates in July was 2.7%, down from 2.8% reported in the previous month. In the public sector, 39 agreements were settled for an average annual increase of 2.7%, compared to 3.2% in June. In the private sector, 10 agreements were settled for an average annual wage increase of 2.7%, up from 2% in the previous month.
- Major settlements in July included two three-year agreements between the Ontario Government and the OPP, providing 5,400 uniform and 2,300 civilian employees with an average annual wage increase of 3.1%. York Regional Police Service Board and York Regional Police Association, representing 1,229 uniform and 422 civilian employees, settled two threeyear agreements for average annual wage increases of 3.1%. In the health care sector, the Participating Hospitals and CUPE reached a centrally negotiated settlement, providing an average annual wage increase of 2.8%, for 10,720 employees covered by 25 agreeements.

Selected settlement summaries*

Participating Hospitals and Canadian Union of Public Employees, various Locals (25 agreements covering 10,720 employees)

part of a centrally bargained Memorandum of Settlement for 56 hospitals covering 79 three-year renewal agreements for 14,070 R.P.N.s, service, office, and technical employees effective September 29, 2006, expiring September 28, 2009

- general wage increases of 2.75% in the first year, 3% in the second year, and 2.6% in the final year
- increases in standby pay, overtime, shift and weekend premiums and vacation leave for eligible employees
- improvements to health care benefits, job security provisions and various leaves

Ontario Government and Ontario Provincial Police Association (5,400 uniform and 2,300 civilian employees)

two, three-year renewal agreements effective January 1, 2006, expiring December 31, 2008

- general wage increases of 3.34% on January 1, 2006, 3% on January 1, 2007, and 3% on January 1, 2008; special wage adjustments for eligible classifications
- Improvements to health care benefits such as paramedical and psychological services, and Accidental Death and Dismemberment Coverage
- new language allowing civilian employees option to receive one week's pay in lieu of five days vacation leave every year
- increased shift premium rates for uniform employees

Woodbine Entertainment Group and Canadian Racetrack Workers Union (700 employees)

a three-year renewal agreement effective January 1, 2006, expiring December 31, 2008, settled after a work stoppage

- wage increases include a lump sum signing bonus of \$250 and an increase of \$0.50 in each year for seniority employees; \$150 and an increase of \$0.40 in each year for non-seniority employees
- improvements to health care benefits and insurance plans

Treasury Board of Canada *and* **Professional Institute of the Public Service of Canada** (6,491 Ontario-based computer systems employees)

a three-year renewal agreement effective December 21, 2004, expiring December 22, 2007

- general wage increases of 2.25% in the first year, 2.4% in the second year, \$900 on December 21, 2006, and 2.5% on December 22, 2006
- delete marriage leave provision and provide five additional days of annual leave on a one-time basis
- · improvements to the cash-out of compensatory leave
- modification to hours of work to include two fifteen-minute breaks daily
- · improvements to contracting out language

University of Western Ontario and Public Service Alliance of Canada (1,400 graduate teaching assistants)

a four-year renewal agreement effective September 1, 2006, expiring August 31, 2010

- one-time payments of \$400 for eligible employees in the first year, \$550 in the second year, \$705 in the third year, and \$865 in the fourth year
- new article on paid maternity leave for eligible employees whose delivery or adoption date falls within four months of the contract expiry date
- increased funding for the GTA Financial Fund and health care plan
