## MCGUINTY GOVERNMENT ESTABLISHES METHADONE TASK FORCE

As recommended by a Coroner's inquest, the McGuinty government is establishing an external task force to provide advice on how to improve methadone maintenance treatment in Ontario.

## **Terms of Reference**

The Methadone Maintenance Treatment Practices Task Force will examine:

- 1. Access to methadone and regulations surrounding treatment programs. The task force will examine issues associated with meeting the needs of people requiring methadone treatment.
- 2. Best practices and training of health care professionals. Guidelines and training are already in place for physician and pharmacist practice in this area. The task force will provide advice on the need to update these guidelines and training as well as the guidelines and training needs of other professionals involved in methadone maintenance treatment.
- 3. Fair payment models. The task force will provide advice on appropriate payment models for physicians prescribing methadone and pharmacists/physicians for dispensing/administering methadone.
- 4. Quality assurance and assessment of treatment programs. The task force will look at quality assurance models, content and enforceability.
- 5. Community engagement in establishing or relocating clinics. The task force will provide advice on how to establish effective community engagement processes when establishing or relocating clinics.

The task force's target is to report to the government by the end of the year.
