#### Johanne Labonté

From 1995 to 2000, she held various increasingly responsible positions with Centre de santé communautaire du Témiskaming culminating in the position of administrative officer and managing the overall operation of the Centre. As an active member of the community, Labonté serves as chair of the Northern Development Council Northeast Board, been past president of the Board of Governors of the Porcupine Big Brothers & Sisters Association, served as director of the Board of Governors of College Boreal, Sudbury, and committee member/secretary of the Organizational Management Standards Committee of Big Brothers and Big Sisters Canada, Toronto.

Since 1970, he has held several administrative positions in the aboriginal community including band administrator and chief of Moose Cree First Nation, chairman of Mushkegowuk Council, and consultant for Nishnawbe Aski Nation, Mushkegowuk Council and Moose Cree First Nation. From 1975 to 1978, Wesley was a sixth grade teacher with the Moose Factory Board of Education, and from 1981 to 1984 he was a teacher with the James Bay Lowlands Secondary School Board. He has also held positions in education administration as policy advisor for Mushkegowuk Education and vice-principal of Delores D. Echum Composite School. His community volunteer work includes serving as master of ceremonies for a number of community functions, board member and chair of Weeneebayko Health Ahutskaywin, and member of the Weeneebayko Health Integration Steering Committee.
