How to put together your collection

The collection, *Administering a Pension Plan Well*, is made up of a series of instalments that have been published one at a time since Spring 2004. You can find the French and English versions of the instalments on our Web site. The French version is also available in print format.

Each time a new instalment is published, you can add it and update the table of contents.

This collection offers guidelines aimed at helping pension committees to perform their role in a competent and prudent manner. You will find ways for improving the administration of pension plans, protecting the members of pension committees and increasing members' and beneficiaries' trust.

The instalments included in the collection will provide practical information on various aspects of administering a pension plan. You will find a variety of subjects, including:

- basic principles for sound administration
- the role and responsibilities of the pension committee
- how a pension committee operates
- the key players in plan administration
- financial management of a plan and its various registers
- financial information that must be submitted to the Régie des rentes du Québec
- documents that support the administration of a pension plan
- information for members and beneficiaries

This collection completes the *Guide for Pension Committee Members*. It will also be used as a reference document in the context of the Régie's training program in order to assist new members of pension committees in acquiring basic knowledge.

We recommend that you regularly consult this tool and encourage all new members to become familiar with it when they are designated to serve on the pension committee.
