

# Constant decline of receipts in the hog sector

### 2005 cash receipts

The cash receipts of Québec farmers slipped slightly in 2005, to \$6.2 billion (-1.7% compared with 2004).

Receipts in the livestock sector remained stable, but failed to offset the decline in crop receipts (–1.8%) or the drop in program payments (–10.2%). Over the same time period, receipts for the livestock sector rose slightly (+1.4%), while receipts for the crop sector fell by 3.6%.



#### Livestock

The **dairy product** sector had a very good year, given the rise in cash receipts of \$101.5 million (+5.8%) over the preceding year. In five years, receipts in this sector have expanded by almost 20%.

Receipts for the **cattle and calf** sector were 25% higher than in 2004.

The number of cattle marketed grew by 10.7% in 2005, while the number of calves marketed increased by a lesser margin, i.e. 3.9%

Prices were also higher in 2005: the price for slaughter cattle gained 14.5%, while the price for slaughter calves rose 12%. Since July 18, 2005, some 14 500 live animals were exported from Québec. Receipts for their sale accounted for 3.5% of total receipts for cattle and calves, compared with 17.8% in 2002, the last complete year in which international trade was unrestricted. That year, more than 110 000 animals were exported outside Québec's borders.

The year 2005 was a poor one for the **hog sector**. Receipts underwent a major decline of 13.5%, or more than \$161 million compared with the previous year. That dip was due to a decrease of 3.6% in the number of hogs sold, but especially to a reduction in prices of some 10%.

### **Programs**

In 2005, the share of the provincial stabilization program played a lesser role than the previous year. It accounted for 52% of total program payments in 2005, compared with 75% in 2004. This year, the income disaster program accelerated significantly: more than \$250 million was paid out, compared with \$10 million in the preceding years. In fact, most of the compensations paid in 2005 results from payments made through the Canadian agriculture income stabilization program for the year of production 2003 and part of 2004. Both programs are complementary in the province of Quebec and cover losses due to low prices. Crop insurance payments remained stable.

#### Crops

In regard to crop production, cash receipts totalled \$1 448.2 million. Over three years, a low rate of growth of 2.4% was recorded.

The grain sector modified the result for crop production as a whole. As regards corn and because of a pronounced drop in the producer price (-23.2%), receipts fell off in 2005 to \$259.9 million from \$331.6 million the previous year. The phenomenon was the same for grains other than corn, although the decline was less pronounced. A 12.2% drop in receipts was observed last year; cash receipts totalled \$39.4 million en 2005.

On a positive note, maple products posted receipts of \$151.7 million in 2005, a growth rate of 19.4% over 2004.

Oil and protein seed crops also experienced an upswing in receipts to \$134.5 million, despite price reductions of 16.6% for soybeans and 20.6% for canola.

After faltering in 2003, potatoes continued to gain ground and recorded receipts of \$101.6 million in 2005, attributable mainly to a recovery in price of 7.8% over the previous 12 months.

### 2005 Expenditures

Preliminary estimations of total annual expenditures in Quebec revealed a decrease of 3.4%, amounting almost 193 millions of dollars. In 2005, total expenditures should reach 5.4 billions of dollars, a level similar to the one observed in 2003.

Cash basis of accounting.
Includes NISA payments, crop insurance payments, income disaster program payments, provincial stabilization payments, dairy subsidies and other payments.
Includes room and board.

**Definitions** 

Farm cash receipts: Measures the gross revenue of farm businesses. They include sales of crops and livestock products (except

sales between farms in the same province) and program payments.

Farm operating expenses: Represent business costs incurred by farm businesses for goods and services used in the production of

agricultural commodities.

Net cash income: Total farm cash receipts including payments - total operating expenses after rebates. This income measures

farm business cash flow generated from the production of agricultural goods. Net cash income represents the amount of money available for debt repayment, investment or withdrawal by the owner. It does not take

depreciation into account.

Realized net income : Net cash income + income-in-kind - depreciation

Total net income: Realized net income + value of inventory change. It measures the financial flows and stock changes of farm

businesses. Total net income values agriculture economic production during the year that the agricultural goods were produced. It represents the return to owner's equity, unpaid labour, management and risk.

N.B.: All data are the subject of intercensal revisions.
